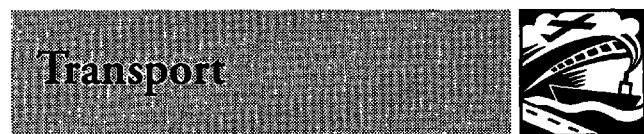

#### **THE M8 MOTORWAY (JUNCTIONS 25A AND 26) (40 MPH SPEED LIMIT) ORDER 1999**

The Scottish Ministers give notice that they propose to make the above Order which will impose a 40mph speed limit on the following lengths of the M8 Motorway:-

1. That length of the M8 Motorway Junction 25A westbound off slip road from its junction with Old Govan Road southeastwards, for a distance of 1100 metres or thereby.
2. That length of the M8 Motorway Junction 25A eastbound on slip road from its junction with Old Govan Road southeastwards, for a distance of 820 metres or thereby.
3. That length of the M8 Motorway westbound off slip road at Junction 26 from its junction with the A736 Hillington Road eastwards, for a distance of 165 metres or thereby.
4. That length of the M8 Motorway eastbound off slip road at Junction 26 from its junction with the A736 Hillington Road westwards, for a distance of 260 metres or thereby.
