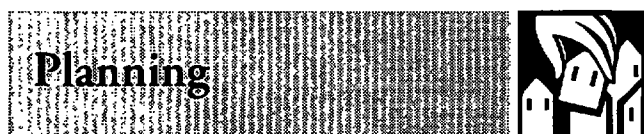

The Sheriff, on Pursuer's Motion, of consent, grants a Disqualification Order under Section 6(1) of the Company Directors Disqualification Act 1986 against James Allison Chalmers to order that he shall not, without the leave of the Court be a director of a company, or be a liquidator or administrator of a company, or be a receiver or manager of a company's property, or in any way, whether directly or indirectly, be concerned or take part in the promotion, formation or management of a company for a period of two years from this date; (2) directs that the making of this order be registered by the Secretary of State for Trade & Industry; (3) appoints intimation of this order to be made once in the *Edinburgh Gazette*; and (4) finds the Defender liable to the Pursuer in expenses as taxed (excluding the calling in Court on 13th December 2000) and allows an Account thereof to be given in and remits same when lodged to the Auditor of Court to tax and to report.
