PROCLAMATIONS

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR TEN POUND COINS COMMEMORATING THE FOUR HUNDREDTH ANNIVERSARY OF THE DEATH OF WILLIAM SHAKESPEARE ELIZABETH R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight for coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that, to commemorate the four hundredth anniversary of the death of William Shakespeare, there should be made at Our Mint coins of the denomination of ten pounds in gold and in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

GOLD COIN

1. (1) A new coin of gold of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 50 millimetres, a millesimal fineness of not less than 999, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.783 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The least current weight of the said gold coin shall be 154.5 grammes.

(4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of coins.

(5) The design of the said gold coin shall be as follows:

‘For the obverse impression Our effigy with the inscription “· ELIZABETH II · D · G · REG · F · D · 10 POUNDS” and for the reverse a depiction of William Shakespeare accompanied with the inscription “OTHELLO ACTI SC.3” surrounded by the inscription “· PUT MONEY IN THY PURSE · 2016”. The coin will have a graining upon the edge.’

SILVER COIN

2. (1) A new coin of silver of the denomination of ten pounds shall be made, being a coin of a standard weight of 156.295 grammes, a standard diameter of 65 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.783 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogramme of coins.

(4) The design of the said silver coin shall be as follows:

‘For the obverse impression Our effigy with the inscription “· ELIZABETH II · D · G · REG · F · D · 10 POUNDS” and for the reverse a depiction of William Shakespeare accompanied with the inscription “OTHELLO ACTI SC.3” surrounded by the inscription “· PUT MONEY IN THY PURSE · 2016”. The coin will have a graining upon the edge.’

(5) The said silver coin shall be legal tender for payment of any amount in any part of Our United Kingdom.

3. This Proclamation shall come into force on the eleventh day of February Two thousand and sixteen.

Given at Our Court at Buckingham Palace, this tenth day of February in the year of our Lord Two thousand and sixteen and in the sixty-fifth year of Our Reign.

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR A NEW ONE POUND COIN ELIZABETH R.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupro-nickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint coins of the denomination of one pound in nickel-brass, having joined concentric inner and outer sections, with a nickel plated inner section and a nickel-brass outer section:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd), (f) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

NICKEL-BRASS COIN

1. (1) A new coin of nickel-brass of the denomination of one pound shall be made, being a coin of a standard weight (including the nickel plate) of 8.75 grammes, a standard diameter of 23.03 millimetres, being twelve sided in shape and having joined concentric inner and outer sections, with a standard composition (excluding the nickel plate) of seventy-six per centum copper, four per centum nickel and twenty per centum zinc.

(2) In the making of the said nickel-brass coin a remedy (that is, a variation from the standard weight, composition or dimensions specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.3 grammes for the inner and outer sections;

(b) in relation to those parts of the coin other than the nickel plating, a variation from the said standard composition of two per centum copper, three-quarters of one per centum nickel and two per centum zinc; and

(c) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The said nickel-brass coin shall be current and shall be legal tender for the payment of any amount in any part of Our United Kingdom.

DESIGN OF THE COIN

2. The design of the said coin shall be as follows:

‘For the obverse impression Our effigy with inscription “· ELIZABETH II · D · G · REG · F · D £1”, and the date of the year. For the reverse a depiction of a rose, leek, thistle and shamrock encircled by and emerging from a crown with the inscription “ONE POUND” below. The said coin will have alternate grained and plain edges.’

3. This Proclamation shall come into force on the eleventh day of February Two thousand and sixteen.

ONE HUNDRED POUND COIN

1. (1) A new coin of gold of the denomination of one hundred pounds shall be made, being a coin of a standard weight of 31.210 grammes, a standard diameter of 32.690 millimetres, a millesimal fineness of not less than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter, specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.105 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The least current weight of the said gold coin shall be 31.010 grammes.

(5) The design of the said gold coin shall be as follows:

TWENTY-FIVE POUND COIN

2. (1) A new coin of gold of the denomination of twenty-five pounds shall be made, being a coin of a standard weight of 7.800 grammes, a standard diameter of 22 millimetres, a millesimal fineness of not more than 999.9, and being circular in shape.

(2) In the making of the said gold coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.025 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

(4) The least current weight of the said gold coin shall be 7.750 grammes.

(5) The design of the said gold coin shall be as follows:

‘For the obverse impression Our effigy with the inscription “ELIZABETH II · D · G · REG · F · D · 25 POUNDS”, and for the reverse a lion accompanied by a shield depicting Our Royal Arms with the inscription “FINE GOLD · 999.9 · 2016 LION OF ENGLAND · 1/4OZ” . The coin will have a grained edge.’

FIVE POUND COIN

3. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 62.420 grammes, a standard diameter of 38.61 millimetres, a standard composition of not less than 999.9 parts per thousand fine silver, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:

(a) a variation from the said standard weight of an amount per coin of 0.195 grammes; and

(b) a variation from the said standard diameter of 0.125 millimetres per coin.

(3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of coins.

(4) The design of the said silver coin shall be as follows:

Fallago Rig wind farm became fully operational in July 2013.

The variation application seeks to make the following variation:

It is proposed to vary condition 2 of the consent dated 9 November 2010 which requires the wind farm to be decommissioned 25 years from the date of commissioning.

The variation sought is to amend this condition to allow the operation of the Fallago Rig 1 to continue for 25 years from the date of commissioning of Fallago Rig 2 (an extension to the generating station by 12 turbines), or other such time deemed appropriate by Scottish Ministers. The proposed extension of time to the operational life of the wind farm is required from the Scottish Ministers under section 36C of Electricity Act 1989.

The installed capacity of the proposed extension to the generating station would be 41.4 MW comprising 12 turbines with a ground to blade tip height of up to 126.5 metres and their associated infrastructure.

Consent for 48 turbines (144MW) on the above site was granted by Scottish Ministers on 9 November 2010. EDF Energy Renewables propose to install an additional 12 turbines up to 126.5 meters tip height in addition to the operational 48 turbines. The proposed turbines are an extension to the existing Fallago Rig generating station and consent is therefore required from the Scottish Ministers under the Electricity Act 1989.

EDF Energy Renewables Limited has also applied for a direction under s57(2) of the Town and Country Planning (Scotland) Act 1997 that planning permission for the development be deemed to be granted.
