PROCLAMATIONS

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF TWO POUND SILVER COINS ELIZABETH R.

Whereas under section 3(1)(a), (b), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making such coins, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denomination of two pounds in silver:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

TWO POUND SILVER COINS

- 1. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 31.21 grammes, a standard diameter of 38.61 millimetres, a standard composition of not less than 999 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.15 grammes; and
- (b) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.
- (5) The designs of the said silver coins shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse either:
- (a) a depiction of Tower Bridge with the inscription "TOWER BRIDGE \cdot (and the date of the year) \cdot " ; or
- (b) a depiction of the Elizabeth Tower with the inscription "BIG BEN \cdot (and the date of the year) \cdot "; or
- (c) a depiction of Trafalgar Square with the inscription "TRAFALGAR SQUARE \cdot (and the date of the year) \cdot "; or
- (d) a depiction of Buckingham Palace with the inscription "BUCKINGHAM PALACE \cdot (and the date of the year) \cdot ".

The coins shall have a grained edge.'

2. This Proclamation shall come into force on the sixteenth day of November \mbox{Two} thousand and seventeen.

Given at Our Court at Buckingham Palace, this fifteenth day of November in the year of Our Lord Two thousand and seventeen and in the sixty-sixth year of Our Reign.

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGNS FOR A NEW SERIES OF FIVE POUND GOLD COINS; A NEW SERIES OF FIVE POUND STANDARD SILVER COINS; A NEW SERIES OF FIVE POUND SILVER PIEDFORT COINS; AND A NEW SERIES OF FIVE POUND CUPRO-NICKEL COINS ELIZABETH R.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denomination of five pounds in gold, five pounds in standard silver, five pounds in silver piedfort and five pounds in cupro-nickel:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIVE POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of five pounds shall be made, being a coin of a standard diameter of 38.61 millimetres, and being circular in shape.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard diameter specified above) shall be allowed of an amount not exceeding 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The design of the said gold coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot FID \cdot DEF \cdot 5 POUNDS", and for the reverse a depiction of St George slaying a dragon accompanied by the date "2018". The coin shall have a grained edge.'

FIVE POUND STANDARD SILVER COIN

- 2. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.435 grammes;
- (b) a variation from the said standard composition of five parts per thousand fine silver; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot FID \cdot DEF \cdot 5 POUNDS", and for the reverse either:
- (a) a depiction of St George slaying a dragon accompanied by the date "2018". The coin shall have a grained edge; or
- (b) a depiction of the façade of Burlington House " \cdot A PLACE TO MAKE, EXHIBIT AND DEBATE ART \cdot ROYAL ACADEMY OF ARTS \cdot 1768 2018". The coin shall have a grained edge.'
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIVE POUND SILVER PIEDFORT COIN

- 3. (1) A new coin of silver of the denomination of five pounds shall be made, being a coin of a standard weight of 56.56 grammes, a standard diameter of 38.61 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:

- (a) a variation from the said standard weight of an amount per coin of 0.22 grammes;
- (b) a variation from the said standard composition of five parts per thousand fine silver; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The design of the said silver coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot FID \cdot DEF \cdot 5 POUNDS", and for the reverse a depiction of St George slaying a dragon accompanied by the date "2018". The coin shall have a grained edge.'
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIVE POUND CUPRO-NICKEL COIN

- 4. (1) A new coin of cupro-nickel of the denomination of five pounds shall be made, being a coin of a standard weight of 28.28 grammes, a standard diameter of 38.61 millimetres, a standard composition of seventy-five per centum copper and twenty-five per centum nickel, and being circular in shape.
- (2) In the making of the said cupro-nickel coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to sav:
- (a) a variation from the said standard weight of an amount per coin of 0.75 grammes;
- (b) a variation from the said standard composition of two per centum copper and two per centum nickel; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The said cupro-nickel coin may contain impurities of three-quarters of one per centum.
- (5) The design of the said cupro-nickel coin shall be as follows:
- 'For the obverse impression Our effigy with the inscription "· ELIZABETH II \cdot D \cdot G \cdot REG \cdot FID \cdot DEF \cdot 5 POUNDS", and for the reverse either:
- (a) a depiction of St George slaying a dragon accompanied by the date "2018". The coins shall have a grained edge; or
- (b) a depiction of the façade of Burlington House "· A PLACE TO MAKE, EXHIBIT AND DEBATE ART · ROYAL ACADEMY OF ARTS · 1768 2018". The coins shall have a grained edge.'
- (6) The said cupro-nickel coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.
- 5. This Proclamation shall come into force on the sixteenth day of November Two thousand and seventeen.
- Given at Our Court at Buckingham Palace, this fifteenth day of November in the year of Our Lord Two thousand and seventeen and in the sixty-sixth year of Our Reign.

BY THE QUEEN A PROCLAMATION DETERMINING THE SPECIFICATIONS AND DESIGN FOR A NEW FIFTY PENCE COIN IN GOLD, STANDARD SILVER, SILVER PIEDFORT AND CUPRONICKEL COMMEMORATING THE ONE HUNDREDTH ANNIVERSARY OF THE REPRESENTATION OF THE PEOPLE ACT ELIZABETH R.

Whereas under section 3(1)(a), (b), (c), (cc), (cd) and (d) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and fineness of certain gold coins, the remedy to be allowed in the making of such coins and their least current weight, and to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, and to provide for the manner of measurement of the variation from the standard weight of coins:

And Whereas under section 3(1)(ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that, to commemorate the one hundredth anniversary of the Representation of the People Act, there should be made at Our Mint a new coin of the denomination of fifty pence in gold, in standard silver, in silver piedfort and in cupro-nickel:

We, therefore, in pursuance of the said section 3(1)(a), (b), (c), (cc), (cd), (d) and (ff), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

FIFTY PENCE GOLD COIN

- 1. (1) A new coin of gold of the denomination of fifty pence shall be made, being a coin of a standard weight of 15.5 grammes, a standard diameter of 27.3 millimetres a millesimal fineness of 916.66, and being in the shape of an equilateral curve heptagon.
- (2) In the making of the said gold coin a remedy (that is, a variation from the standard weight, diameter or fineness specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.070 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said millesimal fineness of two per mille.
- (3) The least current weight of the said gold coin shall be 15.4 grammes.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.

FIFTY PENCE STANDARD SILVER COIN

- 2. (1) A new coin of silver of the denomination of fifty pence shall be made, being a coin of a standard weight of 8 grammes, a standard diameter of 27.3 millimetres, a standard composition of 925 parts per thousand fine silver, and being in the shape of an equilateral curve heptagon.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.17 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said standard composition of five parts per thousand fine silver.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIFTY PENCE SILVER PIEDFORT COIN

- 3. (1) A new coin of silver of the denomination of fifty pence shall be made, being a coin of a standard weight of 16 grammes, a standard diameter of 27.3 millimetres, a standard composition of 925 parts per thousand fine silver, and being in the shape of an equilateral curve heptagon.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.25 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said standard composition of five parts per thousand fine silver.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

FIFTY PENCE CUPRO-NICKEL COIN

- 4. (1) A new coin of cupro-nickel of the denomination of fifty pence shall be made, being a coin of a standard weight of 8 grammes, a standard diameter of 27.3 millimetres, a standard composition of seventy-five per centum copper and twenty-five per centum nickel, and being in the shape of an equilateral curve heptagon.
- (2) In the making of the said cupro-nickel coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:

- (a) a variation from the said standard weight of an amount per coin of 0.35 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said standard composition of two per centum copper and two per centum nickel.
- (3) The said cupro-nickel coin may contain impurities of three-quarters of one per centum.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (5) The said cupro-nickel coin shall be legal tender for the payment of any amount not exceeding ten pounds in any part of Our United Kingdom.

DESIGN OF THE COINS

5. The design of the said coins shall be as follows:

'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 50 PENCE \cdot 2018" and for the reverse a depiction of a line of people accompanied by the inscription "1918 REPRESENTATION OF THE PEOPLE ACT". The said coins shall have a plain edge.'

6. This Proclamation shall come into force on the sixteenth day of November Two thousand and seventeen.

Given at Our Court at Buckingham Palace, this fifteenth day of November in the year of Our Lord Two thousand and seventeen and in the sixty-sixth year of Our Reign.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupronickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a coin of the denomination of one penny in silver and in the denomination of one penny in mild steel coated with copper:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd), (f), (ff) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

ONE PENNY SILVER COIN

- 1. (1) A new coin of silver of the denomination of one penny shall be made, being a coin of a standard weight of 3.564 grammes, a standard diameter of 20.32 millimetres, a standard composition of 925 parts per thousand fine silver, and being circular in shape.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.08 grammes;
- (b) a variation from the said standard composition of five parts per thousand fine silver; and
- (c) a variation from the said standard diameter of 0.125 millimetres per
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

ONE PENNY MILD STEEL COATED WITH COPPER COIN

- 2. (1) A new coin of mild steel coated with copper of the denomination of one penny shall be made, being a coin of a standard weight of 3.564 grammes, a standard diameter of 20.32 millimetres, a standard composition of ninety-one per centum mild steel and nine per centum copper, and being circular in shape.
- (2) In the making of the said mild steel coated with copper coin a remedy (that is, a variation from the standard weight, diameter or composition specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.165 grammes;
- (b) a variation from the said standard diameter of 0.125 millimetres per coin; and
- (c) a variation from the said standard composition of an amount per coin (measured as the average of a sample of not less than 100 coins but not more than one kilogram of the coin) of four per centum of the coin as mild steel and four per centum of the coin as copper.
- (3) Impurities may be present in the copper coating to the said mild steel coin in an amount not exceeding 0.5 of one per centum of the said copper coating (and, in respect of any coin, any such impurities shall be treated as copper for the purposes of sub-paragraph (2)(c) above).
- (4) The variation from the standard weight will be measured as the average of a sample of not less than 100 coins but not more than one kilogram of the coin.
- (5) The said mild steel coated with copper coin shall be current and shall be legal tender for the payment of any amount not exceeding twenty pence in any part of Our United Kingdom.

DESIGN OF THE COINS

3. The design of the said one penny coins shall be as follows:

'For the obverse impression Our effigy with the inscription "· ELIZABETH II · DEI · GRA · REG · FID · DEF ·" and the date of the year and for the reverse a portcullis with chains royally crowned, being the badge of King Henry VII and His successors, the figure "1" and the words "ONE PENNY". The coin shall have a plain edge.'

4. This Proclamation shall come into force on the sixteenth day of November Two thousand and seventeen.

Given at Our Court at Buckingham Palace, this fifteenth day of November in the year of Our Lord Two thousand and seventeen and in the sixty-sixth year of Our Reign.

Whereas under section 3(1)(a), (b), (cc), (cd), (d) and (dd) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, the design and dimensions of coins to be made at Our Mint, to determine the weight and composition of coins other than gold coins or coins of silver of Our Maundy money, and the remedy to be allowed in the making of such coins, to provide for the manner of measurement of the variation from the standard weight of coins, and to determine the percentage of impurities which such coins may contain:

And Whereas under section 3(1)(f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to direct that coins made at Our Mint other than gold, silver, cupronickel and bronze coins shall be current and that any coin shall be legal tender for the payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to prescribe the composition of the standard trial plates to be used for determining the justness of coins of any metal other than gold, silver or cupro-nickel:

And Whereas it appears to Us desirable to order that there should be made at Our Mint a new series of coins of the denomination of two pounds in gold, a new series of coins of the denomination of two pounds in standard silver, a new series of coins of the denomination of two pounds in silver piedfort and a new series of coins of the

denomination of two pounds in cupro-nickel and nickel-brass, having joined concentric inner and outer sections, being in gold with a different coloured gold outer section, in silver with a gold-plated outer section and in cupro-nickel and nickel-brass with a cupro-nickel inner section and a nickel-brass outer section:

We, therefore, in pursuance of the said section 3(1)(a), (b), (cc), (cd), (d), (dd), (f) and (ff), the said section 6(2), and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:

TWO POUND GOLD COIN

- 1. (1) A new coin of gold of the denomination of two pounds shall be made, being a coin of a standard diameter of 28.4 millimetres, being circular in shape and having joined concentric inner and outer sections
- (2) Without prejudice to section 1(2) of the Coinage Act 1971, the inner and outer sections may consist of different alloys.
- (3) The approximate diameter of the inner section shall be 20 millimetres.
- (4) The variation from the standard weight will be measured by weighing each coin separately.

TWO POUND STANDARD SILVER COIN

- 2. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight (including the gold plate) of 12 grammes, a standard diameter of 28.4 millimetres, a standard composition (excluding the gold plate) of 925 parts per thousand fine silver, being circular in shape, and having joined concentric inner and outer sections, the outer section being plated with fine gold.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to sav:
- (a) a variation from the said standard weight of an amount per coin of 0.25 grammes for the inner and outer sections;
- (b) in relation to those parts of the coin other than the gold plating, a variation from the said standard composition of five parts per thousand fine silver; and
- (c) a variation from the said standard diameter of 0.125 millimetres per
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The approximate diameter of the inner section shall be 20 millimetres.
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

TWO POUND SILVER PIEDFORT COIN

- 3. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight (including the gold plate) of 24 grammes, a standard diameter of 28.4 millimetres, a standard composition (excluding the gold plate) of 925 parts per thousand fine silver, being circular in shape, and having joined concentric inner and outer sections, the outer section being plated with fine gold.
- (2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.35 grammes for the inner and outer sections;
- (b) in relation to those parts of the coin other than the gold plating, a variation from the said standard composition of five parts per thousand fine silver; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (4) The approximate diameter of the inner section shall be 20 millimetres.
- (5) The said silver coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

TWO POUND CUPRO-NICKEL AND NICKEL-BRASS COIN

- 4. (1) A new coin of cupro-nickel and nickel-brass of the denomination of two pounds shall be made, being a coin of a standard weight of 12 grammes, a standard diameter of 28.4 millimetres, being circular in shape and having joined concentric inner and outer sections. The approximate diameter of the inner section shall be 20 millimetres, with a standard composition as to the inner section of seventy-five per centum copper and twenty-five per centum nickel, and as to the outer section of seventy-six per centum copper, four per centum nickel and twenty per centum zinc.
- (2) In the making of the said cupro-nickel and nickel-brass coin a remedy (that is, a variation from the standard weight, composition or diameter specified above) shall be allowed of an amount not exceeding the following, that is to say:
- (a) a variation from the said standard weight of an amount per coin of 0.5 grammes for the inner and outer sections;
- (b) a variation from the said standard composition as to the inner section of two per centum copper and two per centum nickel, and as to the outer section of two per centum copper, three-quarters of one per centum nickel and two per centum zinc; and
- (c) a variation from the said standard diameter of 0.125 millimetres per coin.
- (3) The inner and outer sections of the said coin may contain impurities of three-quarters of one per centum.
- (4) The variation from the standard weight will be measured as the average of a sample of not more than one kilogram of the coin.
- (5) The composition of the standard trial plates to be used for determining the justness of the nickel-brass outer section of the said coin shall be pure copper, pure nickel and pure zinc.
- (6) The said cupro-nickel and nickel-brass coin shall be legal tender for the payment of any amount in any part of Our United Kingdom.

DESIGN OF THE COINS

- 5. The design of the said two pound gold coins, two pound silver coins, two pound silver piedfort coins and two pound cupro-nickel and nickel-brass coins shall be either:
- (a) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse the badge of the Royal Air Force with the inscription "THE 100TH ANNIVERSARY OF THE ROYAL AIR FORCE 1918 2018". The said coin shall have a grained edge and in incuse letters the inscription "PER ARDUA AD ASTRA", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or
- (b) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse a depiction of a Vulcan bomber with the inscription "RAF 1918-2018 VULCAN". The said coin shall have a grained edge and in incuse letters the inscription "PER ARDUA AD ASTRA", save for the gold coin where the incuse letters shall be accompanied by a plain edge.';
- (c) 'For the obverse impression Our effigy with the inscription "ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse a depiction of a Spitfire with the inscription "RAF 1918-2018 SPITFIRE". The said coin shall have a grained edge and in incuse letters the inscription "PER ARDUA AD ASTRA", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or
- (d) 'For the obverse impression Our effigy with the inscription "-ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 2 POUNDS", and for the reverse a depiction of a Sea King helicopter with the inscription "RAF 1918-2018 SEA KING". The said coin shall have a grained edge and in incuse letters the inscription "PER ARDUA AD ASTRA", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or
- (e) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse a depiction of a Lightning II jet fighter with the inscription "RAF 1918-2018 LIGHTNING II". The said coin shall have a grained edge and in incuse letters the inscription "PER ARDUA AD ASTRA", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or
- (f) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse the inscription "FRANKENSTEIN" accompanied with "BICENTENARY OF MARY SHELLEY'S" and "1818 · THE MODERN PROMETHEUS · 2018". The said coin shall have a grained edge and in incuse letters the inscription "A SPARK OF BEING", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or

(g) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot DEI \cdot GRA \cdot REG \cdot FID \cdot DEF \cdot 2018", and for the reverse the inscription "THE TRUTH UNTOLD THE PITY OF WAR" accompanied with "THE FIRST WORLD WAR \cdot ARMISTICE \cdot 1918" and the denomination "TWO POUNDS". The said coin shall have a grained edge and in incuse letters the inscription "WILFRED OWEN KILLED IN ACTION 4 NOV 1918", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or

(h) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse the hull of the ship Endeavour over a map of Plymouth Sound, Captain Cook's signature and "250", accompanied with the inscription "CAPTAIN JAMES COOK 1768 – 2018". The said coin shall have a grained edge and in incuse letters the inscription "OCEANI INVESTIGATOR ACERRIMVS", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or

(i) 'For the obverse impression Our effigy with the inscription "- ELIZABETH II \cdot D \cdot G \cdot REG \cdot F \cdot D \cdot 2 POUNDS", and for the reverse the sails of the ship Endeavour below a sun with the Venus symbol and "250", accompanied with the inscription "CAPTAIN JAMES COOK 1769 – 2019". The said coin shall have a grained edge and in incuse letters the inscription "OCEANI INVESTIGATOR ACERRIMVS", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'; or

(j) 'For the obverse impression Our effigy with the inscription "-ELIZABETH II · D · G · REG · F · D · 2 POUNDS", and for the reverse a depiction of the bow of the ship Endeavour and a canoe over a map showing Captain James Cook's voyage round the south coast of Australia and New Zealand and "250", accompanied by the inscription "CAPTAIN JAMES COOK 1770 – 2020". The said coin shall have a grained edge and in incuse letters the inscription "OCEANI INVESTIGATOR ACERRIMVS", save for the gold coin where the incuse letters shall be accompanied by a plain edge.'.

The Public Appointments Order in Council 2016 ("the 2016 Order") makes provision for an independent Commissioner to monitor the procedures adopted by appointing authorities when making appointments to public bodies.

It is desirable to revoke the 2016 Order and make further provision in relation to these matters.

Her Majesty is pleased, by and with the advice of Her Privy Council, to order as follows— $\,$

Citation, commencement and revocation

1.—(1) This Order may be cited as the Public Appointments Order in Council 2017 and comes into force on the day after the day on which it is made.

(2) The 2016 Order is revoked.

Interpretation

2.—(1) The Interpretation Act 1978(a) applies to this Order as it applies to an Act of Parliament and, in particular, as if the 2016 Order was an enactment for the purposes of section 16(1) of that Act. (2) In this Order—

"appointing authority" means, in relation to a public appointment—
(a) a Minister of the Crown or, as the case may be, the Welsh Ministers, the First Minister for Wales or the Counsel General;

(b) the NHS Trust Development Authority where an appointment is made by it on behalf of a Minister of the Crown or, as the case may be, the Welsh Ministers, the First Minister for Wales or the Counsel General;

(c) in relation to the Office of Communications (OFCOM), a Minister of the Crown or, as the case may be, the Welsh Ministers, the Scottish Ministers or the Minister for the Economy in Northern Ireland.

"Commissioner" means the person appointed for the time being by Her Majesty in Council to be Her Majesty's Commissioner for Public Appointments(b);

"Governance Code" means the Governance Code for Public Appointments published under article 3 by the Minister for the Cabinet Office;

"public appointment" means any appointment (including any reappointment or extension of an appointment) made by, or on the recommendation of, an appointing authority to a public body or public office.

"public body or public office" means any body or office that is listed in the Schedule.

(3) Where a provisional appointment is to be made before a public body or public office exists in law or before a body or office has been specified a public body or public office for the purposes of this Order, the Minister for the Cabinet Office may notify the Commissioner that the appointment is to be treated as if it were a public appointment to a public body or public office for the purposes of this Order.

Governance Code

- 3.—(1) The Minister for the Cabinet Office must prepare, publish and keep under review a Governance Code which sets out—
- (a) the principles of public appointments, and
- (b) guidance on the practices to be followed in relation to making public appointments.
- (2) Before publishing the Governance Code, including the principles of public appointments, and any amendments to them, the Minister for the Cabinet Office must consult the Commissioner and the First Minister for Wales.

Functions of the Commissioner

- 4.—(1) The Commissioner must exercise his or her functions under this Order with the object of ensuring that appointing authorities act in accordance with the Governance Code, including the principles of public appointments.
- (2) The Commissioner must, in the manner the Commissioner thinks fit, carry out an audit of the procedures and practices followed by appointing authorities in making public appointments, including the interpretation and application by them of the Governance Code including the principles of public appointments.
- (3) The Commissioner may conduct an investigation into any aspect of public appointments with the object of improving their quality.
- (4) The Commissioner may conduct an inquiry into the procedures and practices followed by an appointing authority in relation to any public appointment whether in response to a complaint or otherwise.
- (5) The Commissioner may require appointing authorities to publish specified summary information relating public appointments.
- (6) For the purposes of this article, appointing authorities must provide the Commissioner with any information the Commissioner reasonably requires.

Additional functions

5. The Commissioner may, at the request of a Minister of the Crown, carry out such additional functions as may be agreed between the Minister and the Commissioner.

Commissioner's annual report

- 6. The Commissioner must publish an annual report on public appointments which must include—
- (a) information arising from the audit carried out under article 4(2), including information about non-compliance; and
- (b) an account of any inquiry into the public appointment procedures and practices of appointing authorities.

Exercise of the Commissioner's functions, powers and duties

- 7.—(1) The Commissioner may delegate functions, powers and duties to—
- (a) an officer of the Commissioner; or
- (b) for the purposes of the functions carried out under article 4(2) or additional functions carried out under article 5, any other person.
- (2) A delegation does not prevent the Commissioner from doing anything personally.
- (3) A delegation does not prevent the Commissioner's functions, powers and duties from remaining the responsibility of the Commissioner.



- 3 The Publisher reserves the right, to be exercised at its sole and absolute discretion, to make reasonable efforts to verify the validity of the Advertiser.
