Notice is hereby given that Scottish Hydro Electric Transmission Plc, "the Company", (registered in Scotland under company registration number SC213461 at Inveralmond House 200 Dunkeld Road, Perth, PH1 3AQ), has applied to the Scottish Ministers for consent under Section 37 of the Electricity Act 1989, to upgrade approximately 168 km of existing overhead line between Tower 559R at Kintore Substation and the Applicants boundary at Blairingone (East of Stirling) at the midpoint between Tower 33 and 34 to allow the OHL voltage to increase from 275kV to 400kV. The proposed development is subject to Environmental Impact Assessment (EIA). An EIA Report has been produced to accompany the application for consent.

The Company has now submitted additional information to Scottish Ministers, which includes information relating to a forestry resilience survey providing more accurate estimations of tree loss associated with the project and proposed compensatory planting. Further to this additional information has been submitted in relation to two tower foundation upgrades at towers 239 and 372 and their potential impacts on Scheduled Monuments adjacent to these towers.



  - 4.6 subject to clause 5 below, no amendments to the text (other than those made as a consequence of 4(i) (v) above) shall be made without confirmation from the Advertiser.

For the avoidance of doubt, the Advertiser agrees and accepts that, subject to the limited rights to edit any Notice referred to above, it is the Advertiser that shall be solely responsible for the content of any Notice, including its validity and accuracy and that the Publisher shall not be responsible for, nor shall have any liability in respect of such content in any way whatsoever.
