Most Gracious Sovereign.

We, your Majesty's most dutiful and loyal subjects, the ancient body corporate of the seamen of England, lumbly beg leave to approach your Majesty, to express the deep concern, which, in common with all your Majesty's faithful subjects, we seel at the present disgraceful conduct of some of the seamen of your Majesty's fleet, who, instigated, no doubt, by the wicked infinuations of some evil disposed persons, enemies alike to your Majesty's royal person and to their country, have been betrayed into acts of insubordination and outrage, degrading to the character of British seamen, hitherto as highly distinguished for loyalty and good conduct, as for intrepritity in vanquishing their enemies: Impelled, therefore, by the duty we owe to your Majesty and to our country, we step forward, at this alarming criss, to declare our readiness to support, with our lives, such measures as your Majesty, in your wissom, may think most expedient to adopt for the restoration of good order and subordination among the seamen of your Majesty's steet.
