Extract of a letter from Captain RICHARD DAVIES, Commander of his Majesty's ship *Astrea*, to EVAN NEPEAN, Esq. dated Yarmouth Roads, June 13. 1797.

I Request you will acquaint their Lordships, that on the 1st instant, off the Scaw, we fell in with and captured the *Stulver* Dutch privateer, of 10 guns and 48 men, belonging to Amsterdam, out eighteen days, and had taken nothing.
