T the Court at Buckingham-Palace, the 30th day of July 1838,

PRESENT,

The QUEEN's Most Excellent Majesty in Council.

HEREAS in pursuance of the laws in force in the colonies of British Guiana, Trinidad, Saint Lucia, the Cape of Good Hope, and Mauritius, contracts for service in Agriculture, or in the manufacture of colonial produce to be performed within the said colonies respectively, have been and may be made with persons not being at the time of entering into such contracts within the limits of the colony within which such service is to be performed, and it is expedient that the law of the said colonies respectively should be amended in that behalf; it is, therefore, ordered by the Queen's Most Excellent Majesty, by and with the advice of Her Privy Council, that, from and after the arrival of this present Order within any of the said colonico, all contracts which may at any time thereafter be made for the performance within the same of any service or labour in agriculture, or in or about the manufacture of any colonial produce, shall within such colony be, and be taken, by all courts, judges, justices, magistrates, and others therein, to be null and void and of no effect, unless the person or persons there form any such service or work shall, at the time of entering into any such contract, have been within the limits, and upon the land of the colony within which such service or labour is to be performed by him, her, or them:

And whereas it may be necessary hereafter to make and establish regulations for and in respect

of contracts to be made within the limits of the respective colonies, for the performance of such service or labour as aforesaid, it is, therefore, hereby ordered and declared, that any such contracts as shall hereafter be made for that purpose within the said respective colonies, shall be subject to all such rules and conditions as shall hereafter be imposed

by law upon the parties entering into the same:

And, for the prevention of all doubt as to the time of the arrival within the said colonies respectively of this present Order, the respective Governors, or officers for the time being administering the government thereof respectively, shall, and they are hereby respectively required to issue Proclamations, reciting at length this present Order, and stating the days of the months and years respectively in which the same was received by them respectively, and upon and from the day so stated in such Proclamation respectively, this present Order shall have the force and effect of the law within the said respective

And the Right Honourable Lord Glenelg, one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly. C. C. Greville.

An Act to facilitate the merger of tithes in land. An Act for the better government of prisons in the West

An Act to remove doubts respecting conveyances of estates vested in heirs and devisees of mortages.

An Act for relieving the commissioners and others acting in the execution of divers local improvement Acts from certain penalties and disabilities.

An Act to continue until the first day of June one thousand eight hundred and forty, and to the end of the then next session of Parliament, the Local Turnpike Acts of Great Britain, which expire with this or the ensuing session of Parliament.

An Act for maintaining a lighthouse at Gibraltar, and respecting lighthouses not within the United Kingdom.

An Act to amend and continue for one year, and from thence to the end of the then next session of Parliament, the several Acts relating to the importation and keeping of arms and gunpowder in Ireland.

An Act to continue for one year, and from thence until the end of the then next session of Parliament, the several Acts for regulating the turnpike roads in Ireland.

An Act to amend the Acts relating to the police of the district of the Dublin metropolis.

An Act to extend the powers of an Act of the sixth and seventh year of the reign of His late Majesty, in relation to granting tacks and making excambions by heirs of entail.
