HAT it is intended in the ensuing Session of Parliament to apply for leave to bring in a Bill for creeting and maintaining a Bridge over the River Leven, at a point betwirt the Saw-mill Ford and the Chain-foot Bridge, with twixt the Saw-mill Ford and the Chain-foot Bridge, with Roads of Communication thereto; and it is also intended by such Bill to take powers for altering, amending, widening, and keeping in repair, the Road running from Borland Loan above Dysart, by East Wemyss, Mairedge, and Saw-mill Ford, or thereby, till it joins the Turnpike Road near to Seoonie Bridge; which Bridge and Roads are intended to be situated in the Parishes of Seoonio, Markinch, Wemyss, and Dysart, and County of Fife; and that, in such Bill, it is intended to take powers to shut up all Fords and Ferries in, through, or over the said River Leven, which are or may be situated between a point on the said River Leven, two thousand yards above, and eight hundred yards below the said intended Bridge; which Fords and Ferries are situated in the Parishes of Seoonie, Markinch, and Wemyss, and County aforesaid; and to alter and amend, so far as may be necessary, the provisions of an Act passed in the 10th year of the Reign of his late Majesty King George the Fourth, entituled, 'An Act for Repair- ing and keeping in Repair the Turnpike Roads in the County of Fife, for rendering Turnpike certain Statute-Labour and Parish Roads; and for making and maintaining certain New Roads in the said County.'
