

THIS day, at five o'clock, His Excellency Hugh, Baron Fortescue, commonly called Viscount Ebrington, embarked at Kingstown, on board the Merlin Steamer, for Plymouth.

Her Majesty's Letters-patent have passed the Great Seal, appointing the Right Honourable William Conyngham Lord Plunket, Lord High Chancellor of Ireland, the Most Reverend Father in God, Richard, Archbishop of Dublin, and the Right Honourable Sir Edward Blakeney, K. C. B. Lieutenant-General Commanding the Forces in Ireland, Lords Justices of Ireland.

This day the Privy Council assembled, when the Right Honourable the Lord Chancellor, the Most Reverend the Archbishop of Dublin, and the Right Honourable the Commander of the Forces, were sworn Lords Justices of Ireland.
