T. Captain-General and Governor-in-Chief of Her Majesty's Provinces of Canada, New Brunswick, and Nova Scotia, and of the Island of Prince Edward, and Governor-General of all Her Majesty's Provinces on the Continent of North America, and of the Island of Prince Edward, and to the heirs-male of his body lawfully begotten, by the name, style, and title of Baron Elgin, of Elgin, in that part of the said United Kingdom called Scotland.

The Queen has been pleased to present the Reverend Alexander Hill to the church and parish of Kilsyth, in the presbytery of Glasgow, and county of Stirling, vacant by the death of the Reverend Henry Douglas, late Minister thereof.

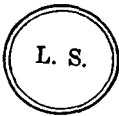

1. That three additional properly qualified medical men, or (in case such properly qualified medical men cannot be obtained) advanced medical students, be forthwith appointed, to devote their whole time to a house to house visitation of the affected districts.

2. That a house or houses, or suitable rooms be forthwith prepared, wherever it may be deemed most convenient (being as near as practicable to the affected districts), to serve as a House or Houses of Refuge, for the reception of the families of those who have been attacked by Cholera, and also of those necessitous persons living under the same roof, or in the immediate vicinity of those so attacked, and that the houses or rooms from which such persons have been so removed, shall be thoroughly cleansed and purified by the owners, or those having the care or ordering thereof, or in their default, by the Board of Guardians of the aforesaid Union.

That a Dispensary be immediately established in a convenient and suitable position, in the aforesaid Church Street District of the Parish of Bethnal Green, to be open at all hours, day and night, and with proper attendance, to supply to necessitous persons such medicines as may be required by those attacked by Cholera, or by any of its premonitory symptoms.

WHEREAS by the Act 11th and 12th Victoria, cap. 123, intituled, "An Act to renew and amend an Act of the tenth year of Her present Majesty, for the more speedy removal of certain nuisances, and the prevention of contagious and epidemic diseases," and by virtue of an Order of Her Majesty's Most Honourable Privy Council, bearing date the 27th day of March 1849, directing that the provisions of the said Act be continued in force throughout the whole of Great Britain, We, the General Board of Health, are authorized to issue such Directions and Regulations as the said Board shall think fit, for the prevention, as far as possible, or mitigation of epidemic, endemic, and contagious diseases ;

And whereas various parts and places within the Greenwich Union appear to be affected by formidable epidemic and endemic disease,

We, the General Board of Health do, in further exercise of the power vested in us as aforesaid, issue the Directions and Regulations hereinafter contained, to extend to the Greenwich Union :—

1. That four additional properly qualified Medical Officers be forthwith appointed, to make a house to house visitation throughout the Greenwich Parish, of the aforesaid Union.

2. That two additional properly qualified Medical Officers be forthwith appointed, to make a house to house visitation throughout the Woolwich Parish, of the same Union.

3. That two additional properly qualified Medical Officers be forthwith appointed, to make a house to house visitation throughout the Parish of Deptford, in the same Union.

4. That adequate and convenient hospital accommodation be provided without delay, for the two Parishes of Woolwich and Deptford, within the

Greenwich Union aforesaid, for the treatment of necessitous persons who may be attacked with Cholera, or with any of its premonitory symptoms.

That a House of Refuge be immediately provided for, and within each of the above mentioned

Parishes of Woolwich and Deptford, to which may be removed the families of such necessitous persons as have been attacked with Cholera, and also such necessitous persons living under the same roof, or in the vicinity of persons so attacked, as the Medical Officers may deem necessary to remove ; the houses, rooms, or dwellings from which persons may have been so removed to the Houses of Refuge, to be cleansed and purified by the owners or persons having the care or ordering thereof, or in their default, by the Guardians of the Poor of the Greenwich Union.

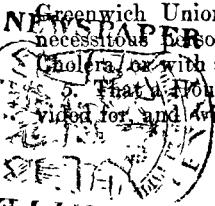

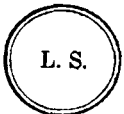
To the Church Wardens of the Parish of St CLEMENT DANES, MIDDLESEX, and to all Others whom it may concern.

WHEREAS by the Act 12th and 13th Victoria, cap. III. intituled "An Act to amend the Nuisances Removal and Diseases Prevention Act, 1848," it is provided, that it shall be lawful in England or Wales, for the General Board of Health, to cause enquiry to be made by a Superintending Inspector, or by such other ways and means as the General Board of Health may deem fit to direct, into the state of the Burial Grounds in any part of England or Wales excepted from the powers of the Public Health Act, 1848, or in any populous City, Town, or Place in England or Wales to which, for the time being, the said Act has not been applied; and if it appear to the General Board of Health that any such Burial Ground is in such a state as to be dangerous to the health of the persons living in the neighbourhood thereof, it shall be lawful for the said General Board of Health in England and Wales, under the Seal of the said Board, and under the hands of two or more Members thereof, to issue such Orders as the said Board may think fit, for the application of such disinfecting substances, and for the adoption of such other measures of precaution in relation to the premises, as may, in the opinion of the said Board, tend to lessen or remove the danger to Health.

And whereas Gavin Milroy, Doctor of Medicine, Superintending Inspector to the said Board, has enquired into the state of the Burial Ground in Portugal Street, in the Parish of Saint Clement Danes, in the County of Middlesex, and has reported the said Burial Ground to be in a condition dangerous to the health of the persons living in the neighbourhood thereof,

Now We, the General Board of Health, being of opinion that in order to lessen or remove the danger to health at present arising from the said Burial Ground, it is expedient that it should be temporarily closed, do hereby order and require the Churchwardens, and other persons having the care and control of the same, to close the said Burial Ground until further order, and to make such provision for interment elsewhere, as to them may appear necessary, under the Tenth Section of the Nuisances Amendment Act aforesaid, or otherwise.
