The following ADDRESS was presented to His Royal Highness PRINCE ALBERT, who was pleased to receive the same very graciously :---

To His Royal Highness Prince Albert.

May it please your Royal Highness,

We, the Ministers and Elders of the Presbytery of Kincardine-O'Neil, in connection with the Free Church of Scotland, in Presbytery assembled,

2. That three lay visitors be immediately appointed to aid in a regular and systematic house to house visitation, especially of the infected districts.


