And Notice is also Hereby Given, that in the said Bill, or Bills, powers will be inserted enabling the said Company to divert part of the Road from Lower Dee Street to the Craiglug, joining the Wellington Bridge Road, at or near to Victoria Street, in the Parish of Old Machar, in the County of Aberdeen, such diversion commencing at a point at or near Affleck Street, in the Parish of Old Machar, in the County of Aberdeen, and terminating at or near the eastern end of Victoria Street, in the same Parish, as shewn on the said Plans to be deposited as hereinafter mentioned.

AND NOTICE IS ALSO HEREBY GIVEN, that it is intended by the said Bill or Bills, to enable the Aberdeen Railway Company to abandon and relinquish the construction of a Terminus or Station, at or near Market Street, in the said Parish of Saint Nicholas; and also to abandon or relinquish so much of their said Railway as lies, or is authorised to be made, between the South side of Guild Street, in the said Parish of Saint Nicholas, and the authorised commencement or Terminus of the said Railway, at or near Market Street aforesaid.
