

And it is intended by the said Bill to restrict the amount of Capital authorised to be raised by the said Acts, and to reduce the number of the Shares of the said Company, and the amount of each such Share.

And it is intended by the said Bill to enable the Edinburgh and Glasgow Railway Company to purchase or acquire and to hold shares and stock in the Caledonian and Dumbartonshire Junction Railway Company, or otherwise to contribute towards the said Undertaking, and to raise a farther sum of money for the said purposes; and to exercise all the powers, rights, and privileges belonging to proprietors of shares or stock in the said last-mentioned Company.

And it is intended by the said Bill to vary or extinguish all existing rights and privileges which would in any manner interfere with any of the objects aforesaid, and to confer other rights and privileges.

And for the above and other purposes it is intended by the said Bill to amend, and partially or wholly to repeal, the said Acts or one of them; and also to amend the following Acts, or some of them, or some of the provisions therein, viz. "The Caledonian Railway (Glasgow, Garnkirk, and Coatbridge Railway purchase) Act, 1846," "The Caledonian Railway (Garnkirk Station) Act, 1847." the Act passed in the 1st. and 2d years of the reign of Her present Majesty, entituled, "An Act for making a Railway from Edinburgh to Glasgow, to be called the Edinburgh and Glasgow Railway, with a Branch to Falkirk," and the several other Acts relating to the Edinburgh and Glasgow Railway Company, passed respectively in the 3d and 4th, the 5th, the 7th and 8th, the 8th and 9th, the 9th, the 9th and 10th, the 10th and 11th, the 11th and 12th, and the 12th and 13th years of the reign of Her said Majesty.

**GLASGOW, GARNKIRK, AND COATBRIDGE,  
AND CALEDONIAN RAILWAYS (AMEND-  
MENT OF ACTS) BILL.**

NOTICE is hereby given, that application is intended to be made to Parliament in the ensuing Session, for leave to bring in a Bill to render the Lien provided to the Glasgow, Garnkirk, and Coatbridge Railway Company, by the Act after mentioned, more effectual and more readily available, and to alter, amend, and enlarge the powers and provisions of the said Act, and so far as necessary to repeal the same, viz. the Act passed in the Ninth and Tenth years of the Reign of her present Majesty, and intituled "An Act to effectuate the Sale by the Glasgow, Garnkirk, and Coatbridge Railway Company of the said Railway to the Caledonian Railway Company; and other purposes connected therewith," or some of the powers and provisions of the said Act; and also, so far as necessary for these purposes, to alter, amend, and enlarge the powers and provisions of the following Acts, relating to the Glasgow, Garnkirk, and Coatbridge Railway Company, formerly the Garnkirk and Glasgow Railway Company, or some of them, viz., 7 Geo. **INVERNESS ACADEMY  
AND  
MACKINTOSH FARR FUND.**

NOTICE is Hereby Given, that it is intended to apply to Parliament, in the ensuing Session, for leave to bring in a Bill to Unite under One Trust and Management, in whole or in part, the Funds and Property commonly called the "MACKINTOSH FARR FUND," held by the Provost, Magistrates, and Dean of Guild of Inverness, under the Will and relative Codicils made and executed by the deceased WILLIAM MACKINTOSH, Commander of the ship "Hindustan," in the service of the East India Company, on the 5th April 1797, April 1798, 10th June 1800, 30th June 1801, 16th November 1801, and 6th May 1803, and the Funds and Property belonging to the Directors and Managers of the INVERNESS ACADEMY, established by Royal Charter, dated the 6th day of March 1793, and written to the seal and registered the 9th April 1793, to appoint a Joint Board of Directors of the said Joint Trust, and to authorise them to carry out the purposes of both Trusts; to Incorporate the Directors so to be appointed, and their successors in office, into One Body Corporate and Politic, with perpetual succession and a common seal, and with power to sue and be sued, to acquire, hold, and transfer Property, Heritable and Moveable, and with the other usual rights, powers, and privileges of a Corporate Body; and also to confer upon the said Directors such powers as may be necessary for the more efficient management and operation of the said Trust and Academy, to authorise them, from time to time, to appoint and dismiss Professors, Teachers, and other officers, and to fix and regulate their duties, salaries, and emoluments; to give retiring allowances to teachers; to establish Bursaries; to make Bye Laws, and to appoint Committees of their own numbers with such powers as may be necessary.

And it is Further Intended by the said Bill to Transfer to and Vest as said is in the Directors so to be appointed and incorporated the Property, Heritable and Moveable, belonging to the said Mackintosh Farr Fund, or the Trustees thereof, and to the said Academy, or the Directors thereof, respectively, with power to Sell and Realise the same, or part thereof, to Purchase other Property, and to re-invest in other Securities, Heritable or Moveable, to Erect New and Additional Buildings, and to Feu or Lease portions of the said Property; and otherwise to Manage the same in the manner most beneficial for the said Trust and Academy.

And also to Alter, Explain, and Enlarge the Powers and Provisions of the said Will and Codicils, and of the said Royal Charter, and to confer all Powers, Authorities, and Privileges which may be necessary for effectually carrying into effect the several purposes of the said Bill.
