## GORBALS GRAVITATION WATER COM-PANY—AMENDMENT OF ACT, AND EX-TENSION AND NEW WORKS.

OTICE is hereby given, that application is intended to be made to Parliament, in the next Session, for leave to bring in a Bill or Bills for an Act or Acts to alter, amend, enlarge, or explain, and in part to repeal the " Gorbals Gravitation Water Company Act, 1846," and to take power to alter the name of the said Company to that of the "Glasgow Gravitation Water Company :" AND NOTICE IS HEREBY FURTHER GIVEN, that it is intended by the said Bill or Bills to take powers for further and better supplying with pure Water the following City, Towns, and places, or some of them : that is to say, the City of Glasgow and Suburbs thereof, and places adjacent thereto : the Town or Royal Burgh of Rutherglen, and places adjacent thereto ; and the Towns or Villages of Barrhead, Nitshill, and Hurlet, and places intermediate and adjacent thereto; and with powers to the said Company or other party or parties in connection therewith, to extend and enlarge the existing works of the said Company-To take and acquire, by compulsory purchase or otherwise, certain Lands, Tenements, Houses, and other Heritages, Rock and other materials, and to take, acquire, and divert, certain Rivers, Brooks, Streams, Springs, Dams, and Watercourses, and to construct, form, and maintain all such further works as may be necessary for the purposes aforesaid, and, in particular, with powers to construct and maintain the following Reservoirs, and other Works in connection therewith, or some part or parts thereof ; that is to say, First-A Reservoir on the Brook or Stream called the Brock or Brockburn, commencing on the Farm of Balgrayfield, in the Parishes of Neilston and Mearns, at or near the Parish Road from Barrhead to Newton of Mearns, and terminating at or near Balgray House, in the said Parish of Mearns. Second-A Reservoir on the Brook or Stream called the Killoch, commencing on the Farm of Killoch, at or near to the top of the Killoch Glen, and terminating on or at or near the Parish Road, on the Farm of Kapily or Cappilly, at the point where the said Road crosses Killoch Burn, both in the said Parish of Neilston. Third-Another Reservoir on the said Brook or Stream called Killoch, commencing immediately above the said last mentioned Reservoir, and terminating at or near the Old Mill on the said Stream, at or near the Farm of East Kapily or Cappilly, both in the said Parish of Neilston. *Fourth*—A Reservoir on the Stream or River called the Laveron, or Levern, commencing at or near the Lint Mill, at or near the point where the said Stream or River is crossed by the Old Turnpike Road from Glasgow to Irvine, and terminating at or near the Farm-house of Midgehole, both in the said Parish of Neilston. Fifth-Another Reservoir on the said Stream or River called the Laveron or Levern, commencing on the Farm of East Neilstonside, at or near where the said Stream or River Laveron passes under the Cross Road leading from the Turnpike Road from Neilston to Stewarton to the Old Turnpike Road from Glasgow to Irvine, and terminating on the Farm of Waterside, at or near Waterside Bleachfield, both in the said Parish of Neilston. Sixth-A Reservoir on the Brook or Stream called Rowbank, commencing at or near the Farm-steading of Brownmuir in the Parish of Beith, and terminating at or near the Farm-steading of Muirhead in the Parish of Lochwinnoch. Seventh-A Reservoir on the Brook or Stream called Kapelrig, commencing A on the plan aftermentioned, in the Parishes of Mill Burn, at or near the point marked I on the said

Eastwood and Mearns, and terminating on the said Farm of Holme. at or near the point marked B on the said Plan, in the said Parish of Mearns. Eighth\_ Another Reservoir on the said Brook or Stream called Kapelrig, commencing at or near where such Brook or Stream passes under the Parish Road lead-ing from the Old Turnpike Road from Glasgow to Stewarton, to the New Turnpike Road from Glasgow to to Kilmarnock, and terminating on the Farm of Falls, at or near where the Road to the Farm-steading of Falls diverges from the Parish Road leading from the said Old Turnpike Road past Pilmuir Mill, both in the said Parish of Mearns. Ninth-Another Reservoir on the said Brook or Stream called Kapel. rig, over the site of an existing Dam called Pilmuir Dam, commencing at the site of the embankment at the north end of the said Dam, above Pilmuir Mill, and terminating on or near the Farm of North Hillhead, at or near the point marked C on the said Plan, both in the said Parish of Mearns. Tenth-A Reservoir on the Stream or River called the Earn, Yearn, or Mearns, commencing at or near the Farm-steading of Muirhouse, at or near the point marked D on the said Plan, and terminating on the Farm of Little Binnend, at or near the point marked E on the said Plan, both in the Parishes of Eaglesham and Mearns, or one or other of them. Eleventh -A Reservoir on the Brook or Stream called Blackloch or Blackloch Burn, over the existing site of the Loch called Blackloch, commencing at the site of the embankment at the East end of the said Loch on the Farm of Nethercairn, and terminating on the said Farm of Nethercairn at or near the point marked F on the said Plan, both in the said Parish Twelfth-A Reservoir on the said of Mearns. Brook or Stream called Brock or Brockburn, over the site of Darnley Dam, commencing at or on the embankment of the said Dam, and terminating in Waulkmill Glen, both in the said Parishes of Neilston and Mearns; together with all such Weirs and Embankments, and all other Works necessary to form and uphold the said several Reservoirs; and also with power to construct and maintain the following Conduits, Cuts, Drains, or Byewashes, videlicet :---(First,) A Cut or Byewash, commencing on Waterside Farm, at or near the Waterside Farm-steading, in the Parish of Mearns, and terminating at the Byewash belonging to the said Company, at or near to the Parish Road from Barrhead to Newton of Mearns, in the Parish of Neilston. (Second,) A Cut or Byewash, commencing at or near the old Mill on the Brook or Stream called Killoch, at or near the Farm of East Kapily or Cappilly, and terminating on the Farm of Killoch, at or near the top of Killoch Glen, both in the Parish of Neilston. (Third.) A Cut or Byewash, commencing at or near the Farm-steading of Midgehole, and terminating at or near the Lint Mill, at or near the point where the said Stream or river Laveron is crossed by the old Turnpike Road from Glasgow to Irvine, both in the said Parish of Neil-(Fourth,) A Cut or Byewash, commencing ston. on the Muir or Farm of Brownside, at or near the point marked G on the said Plan, in the Parish of Mearns, and terminating at or near the Farm-steading of Muir-House, at or near the said point marked D on the said Plan, in the Parish of Eaglesham. (Fifth,) A Cut or Drain commencing on the Muir or Farm of Little Binnend, at or near the point marked H on the said Plan, and terminating on the said Farm of Little Binnend, at or near the said point marked E on the said Plan, both in the Parish of Eaglesham. (Sixth,) A Cut or Conduit commencing near the point where the old Turnpike Road from Glasgow to Irvine crosses the Cowden-
