staple Bar, thence on the south side of the harbour channel to the Customs' watch-house at Appledore, thence in an imaginary line to Instow Church, and shall extend seawards for the distance of three miles from the headlands of, and including Appledore, Pool, and all bays, harbours, rivers, creeks, pills, and islands within the said limits.
