REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE, AT ST JAMES'S-PALACE.

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levee at St James's Palace are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence Chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be sent in to the Lord Chamberlain's Office, on Monday, 26th May, before twelve o'clock, in order that they may be submitted for the Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levees but in conformity with the above Regulations.
