THE following Addresses of the General Assembly of the Church of Scotland having been transmitted by William David, Earl of Mansfield, Her Majesty's Commissioner, to the Right Honourable Spencer Horatio Walpole, one of Her Majesty's Principal Secretaries of State, have been by him presented to the Queen; which Addresses Her Majesty was pleased to receive very graciously:—

To The QUEEN'S Most Excellent Majesty.

May it please your Majesty.

WE, your Majesty's dutiful and loyal subjects, the Ministers and Elders' of the Church of Scotland met in this General Assembly, beg leave to give utterance to our grateful sense of the warm satisfaction with which your Majesty has condescended to contemplate the approach of our present Meeting, and to express your assurance that our consultations will be guided by a due regard to the important interests committed to our charge, and to the maintenance and promotion of the peace and happiness of the Church of Scotland and the people at large.

Remembering also with heartfelt gratitude the many occasions on which former Assemblies have been assured of your Majesty's determination to maintain the Church of Scotland in the full possession of all its rights and privileges, we cannot fail to be encouraged by the unreserved confidence with which your Majesty has resolved to entrust the interests of this Church to our care, and to rely on the prudence and moderation which, in your Majesty's estimation, has long distinguished the deliberations of our predecessors, and we cherish the hope that your Majesty's favourable expectation may be fulfilled, that through the grace of the Almighty God we shall be guided into all the truth, so that our counsels and acts may be dictated by sound wisdom and discretion.

In the appointment of the Right Honourable the Earl of Mansfield as your Majesty's High Commissioner and Representative, we recognize an unequivocal proof of your Majesty's good will to this National Church, the Ministers and Elders of which are fully aware of the eminent talents, the ardent loyalty, and enlightened patriotism, and the numerous excellencies of character which have determined your Majesty's choice.

The Royal Warrant for two thousand pounds to be applied to the reformation of the Highlands and Islands, has been received by us with the deepest gratitude, and it is our anxious desire, with all diligence and good fidelity, to administer the fund thus placed at our disposal so as to promote effectually the sacred and momentous objects to which it has been destined.

Limits of Port and Legal Quays.

We, the undersigned, being two of the Lords Commissioners of Her Majesty's Treasury of the "United Kingdom of Great Britain and Ireland, do hereby, under the authority of an Act passed in the Session of Parliament holden in the ninth and tenth years of the reign of Her present Majesty, intituled "An Act to amend the laws relating to the Customs," appoint Maldon to be a port in that part of the United Kingdom called England, and we do hereby declare that the limits of the said port shall commence at the west entrance of Bilmeroy Creek, near Tilbury Fort, in the county of Essex, and extend from thence to low-water mark in a direction south, towards a tree, or the site

in a direction south, towards a tree, or the site thereof, commonly called and known, and laid NE toward for the Round Tree, in the parish toward for the forward for the Round Tree, in the parish the formal for the shore at low-water mark, the several creeks and inlets, to the said for the formal forma

line along the boundary of the said port of London to the Shoe Beacon, on the south-east part of the Maplin Sands, from thence in a direct line along the boundary of the said port of London towards Saint Osyth's Point, in the said county of Essex, to the distance of one mile and a quarter from the said point, from thence in a direct line west-north-westwardly to Tollesbury Point (where the port of Colchester commences), and from the said point of Tollesbury westward to the town of Maldon, together with all bays, channels, roads, bars, strands, harbours, havens, rivers, streams, creeks, and places within the said limits contained.

And we, the said Lords Commissioners of Her Majesty's Treasury, do hereby appoint the following places within the said port of Maldon, to be legal quays for the lading and unlading of goods, and do hereby declare the bounds and extent of the said quays to be as follows; that is to say :-

All that open place, quay, or wharf, situate in the parish of St Peter, Maldon, commonly called and known by the name of Sadd's Wharf, being in length along the river Chelmer sixty-seven feet, and in depth sixty-four feet, or thereabouts, bounded on the north-east by the said river Chelmer, on the north-west by Maldon Bridge or Full Bridge, on the south-east by land belonging to John Payne, and on the south-west by the crossroad leading to Payne's Limekiln.

Also all that open place, quay, or wharf, situate within the said port of Maldon, commonly called and known by the name of Payne's Lower Wharf, now in the occupation of Harridance and Butler, being in length along the river Chelmer, from Heybridge-road to a warehouse near the centre of the said wharf, fifty-three feet, and from the said warehouse to another warehouse at the southeastern extremity of the said wharf sixty-seven feet, and being in depth one hundred and twentysix feet, or thereabouts.

And also all that open place, quay, or wharf, at Maldon aforesaid, called Eve's Wharf, being in length along the said river Chelmer, from a warehouse at the south-western end thereof to Eve's Dock, sixty three feet, and from the said dock in a south-easterly direction twenty-eight feet, and being in depth two hundred and fifty feet or

thereabouts.

And we, the said Lords Commissioners of Her Majesty's Treasury, do hereby, under the powers contained in the said recited Act, annul all former limits of the said port of Maldon, and all former legal quays set out and appointed within the same.
