Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office before Twelve o'clock on the Monday previous to the Levee, in order that they may be submitted for approbation; it being Her Majesty's command that no presentation shall be made at the Levee but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announc-

ing them.
