REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEES AT ST. JAMES'S-PALACE.

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levees at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence-Chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are hereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to each Levee, in order that they may be submitted for The Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levees but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The State Apartments will not be open for the reception of Company coming to Court, until Half-past One o'Clock.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levees, are to deliver a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come,) to the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to each Levee above announced; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee, one of the two cards to be delivered to

the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to Her Majesty; and on these occasions no other statement is to be addressed to Her Majesty.

A Deputation to present an Address is not te exceed four persons.

A PROCLAMATION.

VICTORIA, R.

HEREAS by the Customs Consolidation Act, 1853, section 150, certain goods may, by Proclamation or Order of Her Majesty in Council, be prohibited either to be exported or carried coastwise; and whereas We, by and with the advice of Our Privy Council, deem it expedient and necessary to prohibit the goods hereinafter mentioned either to be exported or carried coastwise; We, by and with the advice aforesaid, do hereby order and direct, that from and after the date hereof, all arms, ammunition, and gunpowder, military and naval stores, and the following articles, being articles which we have judged capable of being converted into, or made useful in increasing the quantity of, military or naval stores, that is to say:—marine engines, screw propellers, paddle wheels, cylinders, cranks, shafts, boilers, tubes for boilers, boiler plates, fire bars, and every article, or any other component part of an engine or boiler, or any article whatsoever which is, can, or may become applicable for the manufacture of marine machinery, shall be, and the same are, hereby prohibited either to be exported from the United Kingdom, or carried coastwise.

Given at Our Court, at Buckingham-Palace, this eighteenth day of February, in the year of our Lord one thousand eight hundred and fifty-four, and in the seventeenth year of Our Reign.

His Excellency the President has been pleased to forward me the following Decree:—

Antonio Lopez de Santa Anna, &c., &c., &c.

President of the Mexican Republic, to the Inhabitants thereof: Know that, by virtue of the authority with which the Nation has been pleased to invest me, I have thought proper to issue the following Decree:—

Art. 1. The Port of the Island del Carmen, in the Territory bearing the same name, is open to Foreign Commerce.

Art. 2. The merchandize which, by virtue of this Decree, is imported by said port, cannot be introduced to any other port of the Republic, but must necessarily be consumed in the said Territory.

Art. 3. The Tariff to be observed at the said port is the general Tariff of the Republic of 1st June of the present year, and posterior amend-

Art. 4. Foreign Ships, after having legally unloaded in any port of the Republic, may go to the Isla del Cármen to load logwood, subject always to the visits of the Port Captain, and other requisite formalities observed in like cases.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received a Dispatch from Her Majesty's Consul at St Domingo, reporting that in consequence of the outbreak of cholera at St Thomas and Nevis, the Dominican Government have prohibited all intercourse with St Thomas and any other infected Island, and that no vessel from the infected Islands will be admitted until further orders.

All ships coming from places either known or presumed to be infected are strictly forbidden to communicate with the shore for such a period as the Board of Health may think requisite.

Port La Caldera, at the Bay of Ocoa, is appointed as the quarantine place for vessels without sickness on board, for the provinces of Saint Domingo and Azua; and Punta de Salina, in the same bay, for vessels with cases of disease.
