REGULATIONS TO BE OBSERVED AT THE QUEEN'S LEVEE AT St. James's-Palace.

The Noblemen and Gentlemen who purpose to attend Her Majesty's Levee at St. James's Palace, are requested to bring with them two large cards, with their names clearly written thereon, one to be left with the Queen's Page in Attendance in the Presence-Chamber, and the other to be delivered to the Lord Chamberlain, who will announce the name to Her Majesty.

Those Gentlemen who are to be presented are bereby informed it is absolutely necessary that their names, with the name of the Nobleman or Gentleman who is to present them, should be delivered at the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to the Levee, in order that they may be submitted for The Queen's approbation; it being Her Majesty's command, that no presentation shall be made at the Levee but in conformity with the above Regulations.

It is particularly requested that in every case the names be very distinctly written upon the cards to be delivered to the Lord Chamberlain, in order that there may be no difficulty in announcing them to the Queen.

The State Apartments will not be open for the reception of Company coming to Court until Half-past One o'Clock.

Notice is hereby given, that all persons having Petitions or Addresses to present to Her Majesty at the Levee, are to deliver a card (having on it their names, a statement of the object of such Petitions or Addresses, and the names of the persons from whom they come,) to the Lord Chamberlain's Office, before twelve o'clock, on the Monday previous to the Levee above announced; and that two other cards, having on them precisely what is written upon that sent to the Lord Chamberlain's Office, are to be taken to the Levee, one of the two cards to be delivered to the Page in the Ante-Room, and the other to the Lord Chamberlain, who will read its contents to

Board of Trade, Whitehall, Marine Department, February 23, 1854.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul at Algiers, transmitting an Extract from the "Moniteur Algérien," a translation of which is subjoined, notifying the establishment of a new Lighthouse on Cape Carbon, on the Coast of Algeria.

NOTICE TO MARINERS.

COAST OF ALGERIA.

A Lighthouse of the first class, with a revolving light, has been erected on Cape Carbon, at the entry and on the west side of the Gulph of Bougia; and from the 1st of March next the lighthouse will be lighted up every night from sunset to

The lighthouse is situated in latitude 36° 49' north, and in longitude 2° 49' 40" east of the

longitude of Paris.

The centre of the light apparatus stands at an elevation of 722 feet above the level of the sea, and 33 feet above the platform where the building is situated.

Its interval of revolution is once in every minute.

In ordinary weather the light is seen at a dis-

tance of 27 marine miles; and when the weather is clear will be visible at 40 miles.

The red fixed light which at present points out Cape Carbon will disappear when the lighthouse is lighted up; the red light will then be is lighted up; the red light will then be removed to the roadstead of Bougia, and placed on Abd-el-Kader Point, to replace, on the 1st of March next, the present light.

TREASURY WARRANT.

Whereas by an Act, passed in the fourth year of the reign of Her present Majesty, intituled "An Act for the regulation of the duties of postage," power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage, or Inland postage, payable by law on the transmission by the Post of Foreign or Colonial letters, or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant; and from time to time, by Warrant as aforesaid, to alter or repeal any such altered rates, and to make and establish any new or other rates in lieu thereof; and from time to time, by Warrant as aforesaid, to appoint at what time the rates which may be payable are to be paid; and it is provided that the powers thereby given should extend to any increase, or reduction, or remission of postage.

And whereas further powers are given to the Commissioners of Her Majesty's Treasury, by another Act passed in the eleventh year of the reign of Her present Majesty, intituled "An Act for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating

to the Post-office.

NEWS PARE whereas a postal convention has been made and entered into between Her Majesty's Government and the Government of the Republic of the Leuguay.

The purpose of better carrying into effect the rems of such convention, we, the under-

signed, being two of the Commissioners of Her Majesty's Treasury, do, in exercise of the powers and authorities in us for such purpose vested in and by the said recited Acts, and of all other powers and authorities enabling us in this behalf. direct :-

That on every letter not exceeding half an ounce in weight, posted in or addressed to any part of the Republic of the Uruguay, and transmitted by the Post between any part of the United Kingdom and any port in the Republic of the Uruguay, there shall be charged, taken, and paid, in lieu of any rates of British postage now payable by law on such letters, an uniform rate of British postage of one shilling.

And we further direct that on every letter not exceeding half an ounce in weight, posted in or addressed to any part of the Republic of the Uruguay, transmitted by the Post between any port in the Republic of the Uruguay and any of Her Majesty's colonies or possessions, or any Foreign Country, through the United Kingdom, there shall be charged and taken, in lieu of any rates of British postage now payable by law on such letters, the rates of British postage following; that is to say :-

For the conveyance of every such letter between any port in the Republic of the Uruguay and any part of the United Kingdom, a rate of one

shilling.

And for the conveyance of every such letter between the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and the Colony or Foreign Country to or from which the same shall be forwarded, such a further or additional rate of postage as shall, from time to time, be charged and payable for British postage on letters posted or delivered at the port in the United Kingdom of the departure or arrival of the packet or ship conveying the same, and transmitted direct between such Port and such Colony or between such Foreign Country.

And we further direct that on every letter transmitted as is mentioned in this Warrant, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of postage as follows; that is to

For every letter exceeding half an ounce in weight, but not exceeding one ounce in weight, two rates of postage.

If exceeding one ounce but not exceeding two

ounces in weight, four rates of postage.

If exceeding two ounces but not exceeding three ounces in weight, six rates of postage.

If exceeding three ounces but not exceeding four ounces in weight, eight rates of postage. And for every ounce in weight above the weight

of four ounces there shall be charged and taken two additional rates of postage, and every fraction of an ounce above the weight of four ounces shall be charged as one additional ounce, and each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding half an ounce in weight.

we further direct that printed books, printed magazines, printed reviews, printed pamphlets (whether British, Colonial, or Foreign), posted in the United Kingdom, addressed to the

Republic of the Uruguay, or posted in the Republic of the Uruguay, addressed to the United Kingdom, may be transmitted by the Post between any part of the United Kingdom and the Republic of the Uruguay, subject to the several regulations and British rates hereinafter contained; that is to say:—

On every packet consisting of a single printed book, or printed magazine, or printed review, or printed pamphlet, the several sheets, or parts of which when more than one, shall be sewed or bound together, if not exceeding half a pound in weight, there shall be charged and taken one uniform rate of postage of sixpence.

And on every such packet, if exceeding half a pound, and not exceeding one pound in weight, there shall be charged and taken one uniform rate of postage of one shilling.

And on every such packet, if exceeding one pound and not exceeding two pounds in weight, there shall be charged and taken one uniform rate of postage of two shillings.

And on every such packet, if exceeding two pounds and not exceeding three pounds in weight, there shall be charged and taken one uniform rate of postage of three shillings.

And for every additional one pound in weight of any such packet, above the weight of three pounds, there shall be charged and taken an additional rate of postage of one shilling, and every fraction of such additional pound shall be charged as an additional pound.

And we further order and direct that no such packet, if containing more than one printed book, or printed magazine, or printed review, or printed pamphlet, or containing any paper or thing besides a printed book, printed magazine, or printed review, or printed pamphlet, or containing any printed book, printed magazine, printed review, or printed pamphlet, the several sheets, or parts of which when more than one, shall not be sewed or bound together, or which packet, in length or breadth, or width or depth, shall exceed the dimensions of two feet or twenty-four inches, shall be forwarded by the Post under the provisions aforesaid.

And we further order and direct that as to any book packet hereinbefore authorised to be sent by the Post under the provisions aforesaid, which shall be posted in the United Kingdom, the postage thereof shall in every case be pre-paid at the time of the same being posted, not in money, but by being duly stamped with the proper British postage stamp or stamps affixed thereto; which stamp or stamps shall in every case be affixed or appear on the outside of every such packet, near the address, and shall be of the value or amount of the postage duty payable thereon, under or by virtue of this Warrant, unless any such packet be sent from any department or office in or connected with the public service of Her Majesty, which shall keep a postage-account with the General Post-office in London, in which case the same shall be forwarded post-paid, and the postage thereof shall be charged in such postageaccount.

And we further order and direct that every such packet shall be sent without a cover, or in a cover or envelope open at the ends or sides, and shall contain printed matter only, with the binding thereof, and there shall be no writing or marks upon the cover or envelope thereof, or upon or within any part of the contents thereof, other than

the name and address of the person to whom the packet shall be sent, and the printed name and address of the sender, unless any such packet be sent from any department or office in or connected with the public service of Her Majesty, which shall keep a postage-account with the General Post-office in London, in which case the same may, in addition to the name and address of the person to whom it shall be sent, and the printed name and address of the sender, have printed or written thereon, or upon the cover or envelope thereof, the words "On Her Majesty's Service," and also the name of the department or public office from which the packet shall be forwarded, together with the name of any public officer employed in, or belonging to any such department or office, who may be authorised to affix his name to letters and packets sent by the Post, as a certificate that they are on the public service.

And in order to prevent any obstacles to the due and regular transmission of letters by the Post, we further direct that it shall be lawful for any officer of the Post-office in the United Kingdom, to delay the transmission of any book packet, posted or forwarded by the Post under the provisions of this Warrant, either for the space of twenty-four hours from the time at which (or, at his option until the despatch of the mail next after that by which) the same ought otherwise to have

been forwarded by him.

And we further order and direct that if any. book packet sent, or tendered, or delivered, in order to be sent by the Post under the provisions of this present Warrant, shall contain any paper or thing besides a printed book, printed magazine, printed review, or printed pamphlet, and the binding thereof, or shall have any writing or marks upon the same, or upon the cover or envelope thereof, except the name and address of the person to whom it is forwarded, and the printed name and address of the sender; and also as to any such packet sent from any department or office, in or connected with the public service of Her Majesty, which shall keep a postage-account with the General Post-Office in London, except the words "On Her Majesty's Service, and the name of the department or public office from which the same shall be forwarded, with the name of any public officer employed in or be-longing to any such department or office, who may be authorised to affix his name to letters and packets sent by the Post, as a certificate that they are on the public service, or shall not be open at the ends or sides, or shall in length, or breadth, or width, or depth, exceed the dimensions of two feet or twenty-four inches, or shall contain more than one printed book, or printed magazine, or printed review, or printed pamphlet, or shall contain any printed book, printed magazine, printed review, or printed pamphlet, the several sheets, or parts of which when more than one, shall not be sewed or bound together; or if the postage of any such book packet, posted in the United Kingdom, shall not be duly and properly pre-paid by British stamps when posted (any such packet sent from any department or office in or connected with the public service of Her Majesty, which shall keep a postage-account with the General Post-office in London, and the postage thereof shall be charged in such account, only excepted), the same shall. and may be detained and opened at any place in the United Kingdom, and, at the option of the Postmaster-General, shall be either returned or given up to the sender thereof, or be given up to the person to whom it shall be addressed, or be forwarded to the place of its destination; and any such packet on being so returned, given up, or forwarded, shall be chargeable with the like amount of postage to which it would have been

liable as a letter.

And we further direct that such printed newspapers as are hereinafter mentioned, may be sent by the Post according to the regulations, and subject to the British rates hereinafter mentioned, which rates shall be in lieu of any rates of British postage that may now be payable by law on such newspapers (that is to say) :-

Newspapers printed and published in the Republic of the Uruguay, and sent direct from thence by the Post to the United King-

dom, a rate of one penny each.

British newspapers sent by the Post direct from the United Kingdom to any port in the Republic of the Uruguay, a rate of one penny each.

And we further direct that every printed supplement or additional sheet to any newspaper shall, for the purpose of charging the postage under this Warrant, be deemed a distinct newspaper, unless sent in the same cover, or together with the newspaper to which it is a supplement or addition.

And we further direct that all such printed newspapers as aforesaid, shall be forwarded with out covers, or in covers open at the sides, and there shall be no word or communication printed on the paper after its publication, or upon the cover thereof, except the name and address of the person to whom sent, and the printed name and address of the sender on the cover, nor shall any paper or thing be enclosed in or with the same, and if any such printed newspaper shall not be posted and forwarded in conformity with this Warrant, the same shall respectively be liable to the like rates of postage as would have been chargeable on such newspapers if the same had been letters so conveyed by the Post.

And we further direct that nothing herein contained shall be deemed or construed to repeal, alter, or affect any of the rates of postage fixed by a certain Warrant under the hands of three of the Commissioners of Her Majesty's Treasury, bearing date the 9th day of May, 1843, which rates shall continue payable as if this Warrant had not

been signed.

And we further direct that nothing herein contained shall be deemed or construed to annul, prejudice, or affect any of the exemptions and privileges granted by the said first recited Act, or by an Act made and passed in the first year of the reign of Her present Majesty, intituled "An Act for the management of the Post-office," and that all such exemptions and privileges shall remain in full force.

And we further direct that nothing herein contained shall be construed to extend to any letters, newspapers, or packets sent between the United Kingdom and the Republic of the Uruguay by private ships.

And we further direct that the terms and expressions used in this Warrant shall be construed to have the like meaning in all respects as they would have had if inserted in the said Act of the

fourth year of the reign of Her present Majesty.

And we further direct that this Warrant shall come into operation on the first day of March one

thousand eight hundred and fifty-four.

Provided lastly, and we hereby declare and direct that it shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, or any three of them, by warrant under

repeal any of the rates hereby altered, or the regulations hereby made, and to make and establish any new or other rates or regulations in lieu thereof, and from time to time to appoint at what time the rates that may be payable are to be paid.
