WESTMINSTER, July 10, 1854.

This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that the Lords authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to alter the duties of customs on sugar, molasses, and spirits.

An Act for granting certain duties of excise on

sugar made in the United Kingdom.

An Act for the better regulation of the traffic on railways and canals.

An Act to facilitate the apportionment of the rent when parts of lands in lease are taken for the purposes of the Church Buildings Acts.

An Act to place Public Statues within the Metropolitan Police District under the control of the Commissioners of Her Majesty's Works and Public Buildings.

An Act to enable the Courts of Law in England, Ireland, and Scotland, to issue process to compel the attendance of witnesses out of their jurisdiction, and to give effect to the service of such process in any part of the United Kingdom.

An Act for preventing frauds upon creditors by

secret bills of sale of personal chattels.

An Act to repeal certain provisions of an Act of the fifth and sixth years of Her present Majesty, concerning the holding of assizes for the county of Warwick.

An Act for establishing the validity of certain proceedings in Her Majesty's Court of Vice-Admiralty in Mauritius.

An Act to authorize the Trustees of the Rochdale and Burnley Turnpike-roads to take toll in respect of the carriage of certain stones.

An Act for enabling the North and South-Western Junction Railway Company to raise additional capital, and for other purposes.

An Act to amend the Tralee and Killarney

Railway Act 1853.

An Act for making a railway from Horncastle, in Lincolnshire, to the Kirkstead Station of the Great Northern Railway.
