The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Copenhagen, inclosing the translation of a notice (a copy of which is subjoined,) issued by the Danish Government, indicating the position of the Submarine Cable lately laid down to connect the wires of the Swedish and Danish Electric Telegraphs.

- NOTICE TO MARINERS.

Submarine Electric Telegraph in the Sound.

Notice is hereby given, that a Submarine Telegraphic Cable has been laid down from Vedbek, on the coast of Siælland, to the vicinity of Hillesborg, a manor  $2\frac{1}{2}$  miles to the north of Landscrona, on the coast of Skaane, in the following marks, viz.—

At Vedbek, two beacons, bearing W. § S., and E. § N. (by compass) when in one, gives the direction of the cable from this place to the southward of the Island of Hveen; and

At Hillesborg, two similar beacons, bearing E. by N. \(\frac{1}{3}\) N., and W. by S. \(\frac{1}{3}\) S., when in one, shews the direction of the said cable from south of Hyeen to the coast of Skaane.

Between Vedbek and Hveen the line of the cable has moreover been marked by several small floating beacons, with a flag on a pole, while a larger floating beacon at the south end of Hveen indicates the place where the direction of the cable is bent.

Mariners are requested not to anchor with those marks or bearings on, lest by so doing they damage the Electric Cable, or lose their own anchors, and to follow the directions given by pilots or other appointed functionaries on this account.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Brussels, enclosing the copy of a Belgian Law, dated 29th November 1854, of which the following is a translation:—

I. The undermentioned articles will be admitted free of duty:—Wheat, cleansed spelt, meslin, peas, lentils and French beans, rye, maize, buck wheat, small beans and vetches, barley, malt, oats, uncleansed spelt, oatmeal, and pearl barley, meal of all kinds, bran, fecula, and other amylaceous substances, rice, bread, biscuit, potatoes, bulls, oxen, cows, bullocks, young bulls, heifers, calves, sheep, lambs, and pigs. Meats of all sorts are also decreed free of import duties.

II. Wheat and wheat meal, rye and rye meal, and potatoes are prohibited to be exported.

III. The above Regulations will be in force till the 31st December 1855. Nevertheless the Government is empowered before that period to put an end to the stipulations of Article II.

IV. The privilege of free entry, decreed by Article I, will be applicable to all Belgian or Foreign Ships, the papers of which declare that the loading was completed and the departure made from a Foreign Port before the date of the re-establishment of the duties.

V. The Royal Decree of the 25th July 1854, provisionally maintaining the prohibition to export potatoes, is confirmed.

VI. The present law will come into force on the day after publication.

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister in Mexico, enclosing the subjoined translation of a Decree of the Mexican Government with respect to the manner in which the general invoices of cargoes sent to Mexico from Foreign Ports are henceforward to be drawn up.

#### (Translation).

Secretary of State's Office.

H.S.H. the General President has been pleased to issue the following Decree :-

Antonio Lopez de Santa Anna, &c., &c.

Art. 1. It is prohibited to make use of phrases which admit of a double meaning or of different interpretations, in the invoices of goods that are brought to this Country.

Art. 2. It is also prohibited that in the abovementioned invoices, a statement be given only of the number, weight, and measure of the goods contained in one package, when there are several packages contained in a larger one, but it is necessary to state the whole contents, as well as their marks and numbers, if they have any.

Art. 3. The 2d part of the 97th Article of the Tariff of the 1st of June 1853, prohibiting the introduction of several packages under one cover, or in one large bale, is annulled.

Art. 4. The penalty of confiscation will be imposed for the infraction of the provisions of the 1st and 2d Articles of this Decree, which will come into effect four months after its publication in the
