ORD PANMURE has this day received a Despatch and its Enclosures, of which the following are Copies, addressed to His Lordship by Field-Marshal the Lord Raglan, G.C.B.

MY LORD DUKE,

Before Sevastopol, March 3, 1855.

Some more ships are said to have been sunk since I wrote to your Lordship on the 27th. I am not certain of this; but, according to my observation, the new barrier across the harbour appeared yesterday evening to have been extended beyond the point at which I had seen it two days

The enemy is busily occupied in establishing a work considerably nearer the French batteries on the extreme right than that which was attacked by our Allies on the morning of the 24th.

The enemy seem to be increasing their force in the neighbourhood of Sevastopol, both to the northward and upon the Tchernaya.

The railway continues to progress satisfactorily, and we already make considerable use of it in the conveyance of stores, hutting materials, &c., as far as Kadikoi; and the electric telegraph is completed between that village and my head-quarters.

The weather has again become extremely cold, and there was a fall of snow yesterday, and some little this morning.

WITH reference to my letters of the 20th and 24th ultimo (Nos. 140 and 152), I beg leave to inclose, for the information of the Lords Commissioners of the Admiralty, a copy of a letter from Ahmed Pacha, Commander-in-Chief of the Ottoman squadron, returning thanks for the assistance afforded by Her Majesty's ships during the attack on Eupatoria by the Russians, on the 17th ultimo.

Féize Bari, Rade d'Eupatoria, le 26 Février 1855.

Monsieur l'Amiral, L'Empressement que mettent les marins Anglais que se trouvent ici, soit pour le débarquement des troupes, de leurs provisions, des chevaux, ainsi que de tout le matériel de guerre, qui nous arrive continuellement, soit pour courir au secours de nos troupes, concourir à la défense de la ville, en appuyant par mer et par terre les opérations militaires, comme ils l'ont fait le 17 du mois courant, lorsque l'ennemi nous a attaqué avec des forces considérables; en un mot, les services que la marine Anglaise, sous votre commandement supérieur, nous rend journellement, avec zèle et dévouement, sont trop grands et trop sensibles pour que j'hésite davantage à vous les faire connaître.

LORD PANMURE has this day received a Despatch and its Enclosures, of which the following are Copies, addressed to His Lordship by Field-Marshal the Lord Raglan, G.C.B.:—

My Lord Duke,

Before Sevastopol, February 27, 1855.

Ir appears that on Saturday night the enemy sunk three or four more ships of war in the harbour, as far within the booms as the first sunken ships were outside of them; and, according to the most accurate examination yesterday, there are now four barriers or impediments to the entrance of the harbour, viz.—two of sunken ships, and two booms.

The only movement on the part of the enemy, since I last wrote to your Lordship, is the march of some infantry and artillery from the neighbourhood of Bakchi-Saria towards the Tchernaya, upon which river, near Chagouna, they have at present five guns and several hundred men.

The weather has been fine for the last three days, the snow is gradually disappearing, and the

country is becoming drier.

The enemy have re-occupied the ground which was the scene of contest between the French and Russians on Saturday morning before daylight; and they are making great progress in a work they are establishing upon that point.

#### PRESENT,

The QUEEN's Most Excellent Majesty in Council.

Whereas by an Act passed in the tenth year of Her present Majesty, intituled "An Act to "amend an Act for regulating the sale of waste "land belonging to the Crown in the Australian "Colonies, and to make further provision for the "management thereof," Her Majesty was empowered to grant leases or licences for the occupation of any waste lands of the Crown in the Colony of New South Wales, (then including the present Colony of Victoria,) for any term of years not exceeding fourteen, and to make rules respecting the issue of such leases and licences, and respecting the reservation of any rents thereon, and the insertion therein of any conditions and clauses of forfeiture, and respecting any other matters and things which might be requisite for carrying into complete effect the occupation of such waste land.

And whereas it is expedient to authorize the issue of such leases and licences as may promote the working of mines (not being mines of gold or silver) on such waste land within the Colony of

Victoria.

It is hereby ordered by the Queen's Most Excellent Majesty, by and with the advice of Her

Majesty's Privy Council, as follows :-

1. It shall be competent for the Governor of Victoria to license any person or persons to search for mines (not being mines of gold or silver) on such waste lauds of the Crown, and for such period, not exceeding twelve months, as may be specified in such licence.

2. It shall be competent to the said Governor to grant to the holder of any such licence as aforesaid, a lease for mining purposes, of the whole or any part of the land specified in such licence.

- 3. Every such lease shall be for a term not exceeding fourteen years, and shall be subject to a rent of not less than ten shillings per acre per annum, to be paid in advance, and shall be assignable under such rules as shall be ipso facto forfeited if the rent shall not be paid when due; provided that it shall be competent to the Governor to remit such forfeiture on such terms as he shall think fit.
- 4. The Governor may insert in such leases such conditions and clauses of forfeiture as he may think fit, and especially such as may seem to him necessary, to secure the bonâ fide application of the land to mining purposes.
- land to mining purposes.

  5. The extent of land to be comprised in such leases or licences, and the amount of rent to be reserved thereon, shall be regulated from time to time by the Governor, with the advice of his Executive Council.

6. At the expiration of every such lease the land comprised therein shall be open to sale by public auction, under such Government regulations as shall be in force respecting such sales.

7. Every such lease shall declare whether, and under what circumstances, the lessee shall be entitled to compensation for improvements effected by him, and shall also declare the mode of estimating

and paying such compensation.

8. In this Order in Council the word Governor shall include the Lieutenant-Governor, or Officer for the time being administering the Government of Victoria.

And the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, is to give the necessary directions herein accordingly.

Now therefore, Her Majesty, by and with the advice and consent of Her Privy Council, and by the authority of the same, doth order, and it is hereby ordered, that so long as the said Act shall remain and continue in force within the said colony, all prohibitions in any of the said hereinbefore recited Acts of the Imperial Parliament, or in any other Acts thereof contained, against the importing into the said Colony, or against the selling, letting out to hire, exposing for sale or hire, or possessing therein Foreign reprints of books first composed, written, printed, or published in the United Kingdom, and entitled to copyright therein, shall be suspended, so far as regards the said colony.
