By this determination Commerce will, we trust, be freed from a scourge which has inflicted wide spread ruin amongst individuals, and interfered with the pursuits of peaceful industry, aggravating unnecessarily the calamities of War.

We fervently pray that your Majesty's life may be spared for many years, and that the future portion of your reign may be as happy and as prosperous as the past.
