BUCKINGHAM-PALACE, June 6, 1856.

THIS day the Right Honourable the Earl of Derby, D.C.L., and a Deputation from the University of Oxford, waited upon Her Majesty to present the following ADDRESS, which Her MAJESTY was graciously pleased to receive on the Throne :—

To The QUEEN'S Most Excellent Majesty,
Most Gracious Sovereign,

WE, your Majesty's most dutiful and loyal subjects, the Chancellor, Masters, and Scholars of the University of Oxford, beg leave to approach your Majesty's throne with the renewed assurance of our devoted attachment. With heartfelt thankfulness to Almighty God we desire to offer our congratulations to your Majesty on the termination of the late War, and the re-establishment of the Peace of Europe.

We have been cheered, amidst the misery and affliction which the War has entailed on many of your Majesty's subjects, by the examples of heroism, of patience, of Christian charity, and devotion, which it has called forth. We have observed with admiration and gratitude that Royal sympathy which has comforted our fellow-countrymen under their trials. We are persuaded that the result will be to knit all classes more firmly than ever in brotherly union with one another, and in loyal and affectionate attachment to your Majesty's Throne and Person.

We rejoice that your Majesty has been enabled, in concert with your august Allies, so speedily to terminate a just War by an honourable Peace, that in the late negotiation provision has been made for suppressing the practice of privateering and averting the renewal of War, and that freedom has at length been obtained for Christianity in the land of its birth.

It is our earnest prayer that, under the peaceful sway of your Majesty's Sceptre, the spiritual welfare of your Majesty's subjects may be effectually promoted, and the Gospel of Christ more widely diffused; and that while commercial enterprise and the industrial arts continue to flourish, we may also be found, in our own sphere, so labouring in the sound religious and moral training of the young, and in the cultivation of

learning and science, as to make peace on earth minister to the glory of God.

Given at our House of Convocation, under our Common Seal, this tenth day of May, in the year of our Lord 1856.

To which Address Her Majesty was pleased to return the following most gracious Answer :

" I receive with great satisfaction the congratulations you have offered me on the re-establishment of Peace in Europe.

" While deeply sympathising with the sorrows and privation which the War in which we have recently been engaged has inflicted on many of my people, I cordially share your feelings of admiration for the heroism, patient endurance, and Christian charity and devotion of which it has produced such bright examples; and I gratefully appreciate the constant support which I have received from all classes of my subjects, in a contest entered upon with a deep sense of its justice and necessity, and which has happily been brought to an honourable and satisfactory termination.

" I trust that the Peace which I have concluded, in concert with my august Allies, will be of long continuance, and that by God's blessing it will tend to the promotion of those high objects and interests which are essential to the welfare and happiness of mankind, and to the advancement of which your influence and exertions are so usefully devoted."

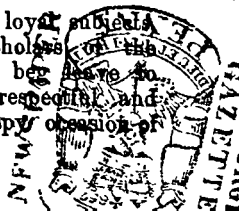
THIS day His Royal Highness Prince Albert, and a Deputation from the University of Cambridge, waited upon Her Majesty to present the following Address, which Her Majesty was graciously pleased to receive on the Throne :—

To The QUEEN'S Most Excellent Majesty.

The humble Address of the Chancellor, Masters, and Scholars of the University of Cambridge.

May it please your Majesty,

WE, your Majesty's dutiful and loyal subjects, the Chancellor, Masters, and Scholars of the University of Cambridge, humbly beg leave to approach the Throne with our respectful and cordial congratulations on the happy occasion of



the termination of the War in which your Majesty has been engaged.

We recall to mind, with deep thankfulness to Providence and strong affection to your Majesty, the tranquillity and prosperity which the Empire had enjoyed during the previous part of your Majesty's auspicious reign, and we cannot doubt that those years will be reckoned among the happiest portions of English history.

Yet it will not fail to be regarded as an addition to the glories and benefits of that reign, that it included a War, undertaken for the maintenance of right and justice, and the security of future generations; carried on with a courage and energy, on the part of your Majesty's soldiers and sailors, which no age or Nation has surpassed; softened by truly Christian ministrations to its victims; marked by the extinction of ancient enmities and rivalries; and ending in a satisfactory settlement of the questions for which it was begun:—a Peace truly glorious to the Nation, as being free from any impress of selfish purpose.

That this glory should have been added to the peaceful blessings of your Majesty's reign at the cost of only two years of war, we esteem a peculiar felicity, on which we beg leave to offer our warmest congratulations. In proportion as we look upon War as a condition which, even when necessary, is deplorable, and even when successful is calamitous, we are deeply thankful to the goodness of God which has spared us the continuance of such a state, and put a speedy end to its concomitant evils.

May the Providence, which has hitherto been so gracious, continue its favour to your Majesty in all the events, public and domestic, in which your Majesty is concerned, and preserve and bless you through a long series of peaceful and happy years.

To which Address Her Majesty was pleased to return the following most gracious Answer:

"I receive with sincere gratification your loyal and dutiful address.

"I fully share your feelings of thankfulness to Divine Providence for the many blessings with which this Country has been favoured both in Peace and War.

"While I heartily appreciate the zeal and resolution of my people in the prosecution of a just War, the distinguished courage and endurance of my soldiers and sailors who have been engaged in it, and the signal examples which it has afforded of a truly Christian charity in ministering to the sick, the suffering, and the bereaved, I accept with unfeigned satisfaction your congratulations on the attainment of the objects with which the War was undertaken, and I trust that the Peace which has been concluded with the concurrence of all the Great Powers of Europe will long continue to promote the happiness of my people, and the welfare and best interests of mankind."

THIS day the Protestant Dissenting Ministers of the Presbyterian Denomination of the cities of London and Westminster waited upon Her Majesty to present to Her Majesty the following Address, which Her Majesty was graciously pleased to receive on the Throne:—

To The QUEEN'S Most Excellent Majesty.

May it please your Majesty,

WE, your Majesty's dutiful and loyal subjects, the Protestant Dissenting Ministers of the Pres-

byterian Denomination, residing in and about the cities of London and Westminster, in the exercise of a privilege enjoyed by our predecessors from the Revolution to the present day, approach the Throne with sentiments of devoted attachment, to offer to your Majesty our sincere congratulations on the Peace which has terminated what we believe to have been a just and necessary War, and which we rejoice to think is honourable, and fervently hope may endure.

We recall with patriotic pride the unanimity of sentiment, the zeal and devotedness in your Majesty's service, and the cheerful readiness to bear increased burdens, which pervaded all classes of the community through the costly and sanguinary conflict in which we have been engaged, and from which we now retire with a profounder consciousness of national strength and national security. The short trial of War has taught us the inestimable value of Peace, and rendered us more deeply sensible of those social blessings which can only be enjoyed under a free Government, and under a wise and enlightened rule.

We have been touched with your Majesty's personal sympathy in the sufferings, and interest in the welfare, of your brave soldiers; your Majesty could give no better pledge that nothing but a solemn sense of duty could induce your Majesty to encounter the terrible evils of War.

With the return of Peace, fostered by the influence and encouraged by the example of your Majesty and your Majesty's Illustrious Consort, may the industry which enriches, the art which adorns, the knowledge which enlightens, and the religion which sanctifies a Nation, spring up with a new life in the midst of us. May impartial legislation draw all ranks and all sects into closer union with each other. Long may your Majesty be permitted to uphold by a high moral influence a just and righteous Peace among the Nations of the earth; but should War ever become again an unhappy necessity of your reign, we have full confidence that your Majesty will be found then, as now, at the head of a free and united people, calmly but energetically sustaining those eternal principles of justice and humanity on which alone can permanently rest the tranquillity of Nations and the stability of Thrones.

In conclusion, we fervently offer up our prayers to the Sovereign Disposer of all Good, that He would be pleased to shower down every blessing, public and private, on your Majesty, on your Majesty's Illustrious Consort, on your Children, and on every Member of your Royal House.

To which Address Her Majesty was pleased to return the following most gracious Answer:

"I thank you sincerely for the loyal and dutiful Address which you have presented to me on the happy occasion of the termination of a War undertaken from a deep sense of its justice and necessity, and conducted to an honourable and satisfactory termination, with the zealous, patriotic, and unanimous support of my people.

"I am deeply sensible of the gratitude we owe to Divine Providence for restoring to us the inestimable blessings of Peace, and I fervently pray that, based as I believe this Peace to be on the principles of justice and humanity, it will long continue to foster and promote those high interests with which the happiness and welfare of mankind are so essentially connected."

The following Address having been presented to The Queen, Her Majesty has been pleased to receive the same very graciously :—

To The QUEEN'S Most Excellent Majesty.

Most Gracious Majesty,

WE, your Majesty's loyal and dutiful subjects, the Lord of the Barony of Kemes, in the county of Pembroke, the Mayor, Aldermen, and Burgesses of the ancient borough of Newport, the principal town within the said barony, in Court Leet and Court Baron assembled, beg leave to approach the Throne of your Majesty with our humble but earnest congratulations on the happy restoration of Peace.

That the dreadful War in which the Nations of Europe had been engaged for the last two years should have terminated, was a subject for great thankfulness, but that the War should have been so skilfully conducted, and that it should have led to such glorious results, with such a Treaty of Peace so creditable to all engaged, so well calculated to further the cause of civil and religious liberty, and to promote the blessed principles of Christianity, to extend the commercial enterprizes of this and other countries, and to open up new channels of communication; viewed in any of these lights we have abundant cause to testify our joy.

We gratefully acknowledge the hand of Providence in the successes achieved by our Arms; and while we sympathize with your Majesty for the loss of the brave men who have gloriously fallen, we proudly rejoice to record that in no former War has the generous and enduring bravery of the British soldier and sailor been more brilliantly conspicuous.

We hope that the Peace which is now concluded may, under the favour of Divine Providence, long continue to shed its blessings over Europe, and that harmony amongst Governments and friendly intercourse amongst Nations may steadily promote the progress of civilization and secure the welfare of mankind.

This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that *the Lord's authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to*

An Act for raising the further sum of five millions by way of annuities.

An Act to continue certain compositions payable to bankers who have ceased to issue bank notes.

An Act to amend the laws relating to the duties on fire insurances.

An Act for enabling the Company of Proprietors of Lambeth Waterworks to raise further money, and for other purposes.

An Act for effecting certain alterations in the works of the tidal harbour of Victoria Dock, at Dundee, and for other purposes in relation to the harbour of Dundee.

An Act to enable the Lincoln Waterworks Company to raise a further sum of money.

An Act for the incorporating of the Milford Railway Company, and for the making of the Milford Railway, in the county of Pembroke.

An Act to enable the East of Fife Railway Company to make a deviation in the line of their railway, and for other purposes.

An Act for granting further powers to the Heywood Gas-light and Coke Company.

An Act for making a railway from the Wilts, Somerset, and Weymouth Railway, near Frome, to Shepton Mallett, in the county of Somerset.

An Act to enable the Eastern Counties' and London and Blackwall Railway Companies to raise a further sum of money for the purposes of the London, Tilbury, and Southend Extension Railway, to amend the Acts relating to such undertaking, and for other purposes.
