## ACT OF SEDERUNT

THE NEXT WINTER SESSION OF THE FIRST DIVISION OF THE COURT OF SESSION.

EDINBURGH, 17th July 1856.

THE Lords of Council and Session having considered a representation made to them by the Lord President, as to the great number of Causes presently on the Rolls of the First Division, and that will remain undisposed of at the termination of the present Summer Session, and that from the nature of certain of those Causes, and the position in which they stand, it is desirable that they should be heard previous to the ordinary period for the commencement of the next Winter Session; and having taken into consideration the provisions of the Act of Parliament passed in the 2d & 3d year of the reign of Her present Majesty, cap. 36, § 10, do hereby, in exercise of the powers thereby conferred on them, ENACT, DIRECT, and

I. That the next Winter Session of the Court. in so far as regards the First Division thereof, shall be extended beyond the ordinary period, by commencing on the 4th, instead of the 12th day of November next, for the disposal of Causes as aftermentioned.

II. That as the object of the foresaid Extension of the next Winter Session, in so far as regards the First Division of the Court, is to enable that Division to dispose of certain Causes, and as it is desirable that these Causes should be heard without interruption, it is hereby ENACTED and DECLARED, that the foresaid Extension shall have no operation except for the hearing of such Causes as shall be set down for that purpose in a Roll or Rolls specially applicable to the period of such Extension of the Session.

And the Lords APPOINT this Act to be inserted in the Books of Sederunt, and to be published in

the usual manner, and copies thereof to be transmitted to both Houses of Parliament, in terms of the before recited Act.

An Act for raising the sum of four millions by Exchequer Bills and Exchequer Bonds, for the service of the year one thousand eight hundred

An Act to exempt imprisonments under the Act 5 Geo. IV, c. 96, from the operation of the Act abolishing in Scotland imprisonment for civil debts of small amount.

An Act for the incorporation and regulation of Joint Stock Companies and other Associations.

An Act for amending the procedure before Magistrates and Justices of Peace in Scotland.

An Act for confirming a scheme of the Charity Commissioners for Saint Mary Magdalen Hospital, near Bath.

An Act for confirming a scheme of the Charity Commissioners for the Endowed School at Moulton, in the county of Lincoln.

An Act to facilitate the despatch of business before grand juries in England and Wales.

An Act to continue certain Turnpike Acts in Great Britain.

An Act to enable parishioners and others, forming a numerous class, to sell advowsons held by or in trust for them, and to apply the proceeds in providing parsonage houses, augmenting small livings, and to other beneficial purposes; and for giving other powers to such persons.

An Act to suspend the making of lists and the ballots for the militia of the United Kingdom.

An Act for authorizing traffic arrangements between the West End of London and Crystal Palace, and the London, Brighton, and South Coast Railway Companies; the regulation and increase of capital, and for other purposes.

An Act to afford facilities to the Bagenalstown and Wexford Railway Company, for raising the funds necessary to enable them to execute their

undertaking, and for other purposes.

An Act for more effectually repairing several roads leading to and from the town of Monmouth, and for making several lines of road to communicate therewith, in the counties of Monmouth, Gloucester, and Hereford.

An Act for the improvement of part of the district of St. Peter Bournemouth, in the parishes of Christchurch and Holdenhurst, in the county of Southampton, and for providing a pier there.

An Act to enable the Morayshire Railway Company to construct a railway from Orton to

Craigellachie, and for other purposes.

An Act for carrying into effect certain arrangements between the Trustees of the Renfrewshire Turnpike Roads and the Lord Provost, Magistrates and Council, and Police and Statute Labour Committee of Glasgow; and for continuing in other respects the Acts relating to the said roads.

An Act for making and maintaining a turnpike road from Conway to Llandudno, in the county of Carnaryon, and for other purposes.

An Act to repeal the Act relating to the turnpike roads from Halifax to Huddersfield, in the West Riding of the county of York, and to grant a further term in the said roads, and further powers for the management thereof, and other purposes.

An Act for better supplying with water the city of Edinburgh, and town and port of Leith, and

MADE BY THE RIGHT HONELE JOHN MELVILLE, LORD PROVOST OF THE CITY; JOHN THOMSON GORDON, ESQUIRE, SHERIFF OF THE COUNTY OF EDINBURGH; AND DAVID MURE, ESQUIRE, ADVOCATE, SHERIPF OF THE COUNTY OF PERTH (APPOINTED BY THE RIGHT HONELE SIR GEORGE GREY, BARONET, ONE OF HER MAJESTY'S PRINCIPAL SECRETARIES OF STATE), IN TERMS OF 'THE EDINBURGH MUNICIPALITY EXTENSION ACT, 1856.'

#### I. CALTON WARD.

To comprehend the whole lands and others within the following limits:—From a point on the London Road where the said road is intersected by the Parliamentary boundary; thence westward along the centre of the said road, of the Regent Road, and of Waterloo Place; thence northward along the centre of East Register Street, of the street on the west side of St James' Square, and of Elder Street, to York Place; thence eastward along the centre of the east division of York Place to Broughton Street; thence southward to the head of Leith Walk; thence along the centre of Leith Walk to the point where it is intersected by the Parliamentary boundary at Pilrig Street; and thence eastward and southward along the said boundary to the point first mentioned.

#### II. BROUGHTON WARD.

To comprehend the whole lands and others within the following limits:—From the head of Leith Walk, along the centre of said Walk, to the point where it is intersected by the Parliamentary boundary at Pilrig Street; thence along the said boundary northward and westward to a point on the said boundary opposite the centre of the high road leading from Golden Acre to Canonmills Bridge; and thence southward along the centre of the said high road by Canonmills Bridge and Broughton Street to the head of Leith Walk.

#### III. ST BERNARD'S WARD.

To comprehend the whole lands and others within the following limits:—From a point on the Parliamentary boundary at Golden Acre opposite the centre of the high road leading southward to Canon-mills Bridge; thence westward and south-westward along the said boundary to the Water of Leith; thence along the said Water to a point opposite the north side of St Bernard's Well; thence by a straight line to the north-west angle of the garden wall behind the houses of Moray Place; thence north-eastward along the said wall, and by production of the line thereof to the centre of Doune Terrace; thence eastward along the centre of the said Terrace to Church Lane; thence northward along the centre of the high road leading from Stockbridge to Howe Street; thence south-eastward along the centre of the said road to the foot of Howe Street; thence northward and eastward along the centre of St Vincent Street, of Fettes Row, and of Royal Crescent, to Scotland Street; thence southward, south-eastward, and eastward, along the centre of Scotland Street, of the street in front of the northern quadrant of Drummond Place, and of London Street, to the high road at the east end of the street last mentioned; and thence northward along the centre of the high road by Canonmills Bridge to the point first mentioned.

#### IV. ST GEORGE'S WARD.

To comprehend the whole lands and others within the following limits:—From the point on the Parliamentary boundary where it intersects the Water of Leith near John Watson's Institution along the said Water to a point opposite the north side of St Bernard's Well; thence by a straight line to the north-west angle of the garden wall behind the houses of Moray Place; thence north-eastward along the said wall, and by production of the line thereof to the centre of Doune Terrace; thence eastward along the centre of Doune Terrace and of Gloucester Place to India Street; thence southward along the centre of India Street to Heriot Row; thence westward along the centre of Wemyss Place to Queen Street; thence westward along the centre of Queen Street to North Charlotte Street; thence southward along the centre of North Charlotte Street, of the street on the east side of Charlotte Square, and of South Charlotte Street, to Princes Street; thence westward along the centre of Princes Street to the Lothian Road; thence along the centre of the said road to St Cuthbert's Lane; thence along the centre of the said lane to Morrison Street; thence along the centre of the said street to the road leading to Coltbridge; thence westward along the centre of the said road to the point where it is intersected by the Parliamentary boundary; and thence northward along the said boundary to the point first mentioned.

#### V. ST STEPHEN'S WARD.

To comprehend the whole lands and others within the following limits:—From a point opposite the foot of Church Street, in the centre of the high road leading from the Stockbridge south-eastward; thence along the centre of the said road to the foot of Howe Street; thence northward and eastward along the centre of St Vincent Street, of Fettes Row, and of Royal Crescent, to Scotland Street; thence southward along the centre of Scotland Street, of the street in front of the Quadrants of Drummond Place, and of Dublin Street, to Abercromby Place; thence westward along the centre of Abercromby Place, and of Heriot Row, to India Street; thence northward along the centre of the said street to

Gloucester Place; thence westward along the centre of Gloucester Place to Church Lane; and thence northward along the centre of Church Lane, and of Church Street, to the point first mentioned.

#### VI. ST LUKE'S WARD.

To comprehend the whole lands and others within the following limits:—From a point in the centre of the street at the west-end of Heriot Row, opposite the centre of the street of Wemyss Place; thence southward along the centre of Wemyss Place to Queen Street; thence westward along the centre of Queen Street to North Charlotte Street; thence southward along the centre of North Charlotte Street, of the street on the east side of Charlotte Square, and of South Charlotte Street to Princes Street; thence eastward along the centre of Princes Street to Hanover Street; thence northward along the centre of Hanover Street, and of the road between the Queen Street Gardens to Heriot Row; and thence westward along the centre of Heriot Row to the point first mentioned.

#### VII. ST ANDREW'S WARD.

To comprehend the whole lands and others within the following limits:—From a point in the centre of Princes Street opposite the centre of Hanover Street; thence eastward along the centre of Princes Street to East Register Street; thence northward along the centre of East Register Street, of the street on the west side of St James' Square, and of Elder Street to York Place; thence eastward along the centre of the east division of York Place to Broughton Street; thence northward along the centre of Broughton Street to London Street; thence westward, south-westward, and southward, along the centre of London Street, of the street in front of the Southern Quadrant of Drummond Place, and of Dublin Street to Abercromby Place; thence westward along the centre of Abercromby Place to the east end of Heriot Row; and thence southward along the centre of the road between the Queen Street Gardens, and of Hanover Street, to the point first mentioned.

#### VIII. CANONGATE WARD.

To comprehend the whole lands and others within the following limits:—From a point on the London Road where the said road is intersected by the Parliamentary boundary; thence westward along the centre of the said road, of the Regent Road, and of Waterloo Place, to the North Bridge; thence southward along the centre of the North Bridge, and of the South Bridge, to Drummond Street; thence eastward along the centre of Drummond Streets to the Pleasance; thence southward along the centre of the Pleasance to Salisbury Street; thence eastward along the centre of Salisbury Street to the Dumbiedykes Road; thence northward along the centre of the said road to a point opposite the entrance to the Queen's Park at the foot of Arthur Street; thence eastward to the boundary wall of the Park at the said entrance; thence south-eastward along the said wall to the point at which it is intersected by the Parliamentary boundary; and thence northward along the said boundary to the point first mentioned.

#### IX. ST GILES' WARD.

To comprehend the whole lands and others within the following limits:—From a point in the centre of Princes Street opposite the North Bridge; thence westward along the centre of Princes Street to the Lothian Road; thence southward along the centre of the said road to the road leading to King's Stables; thence south-eastward and southward along the centre of the last-mentioned road to the West Port; thence eastward by the southern wall of the Old Corn Market, and the centre of the Grassmarket, to the Cowgate-head; thence southward along the centre of Candlemaker Row, and of Forrest Road, to the road in front of Teviot Row; thence eastward along the centre of the road last-mentioned, of Lothian Street, and of South College Street to the South Bridge; and thence northward along the centre of the South Bridge, and of the North Bridge, to the point first mentioned.
