Copy of a Letter from the Right Honourable Lord BRIDPORT, K. B. Admiral of the White, &c. to EVAN NEPEAN, Esq. dated Forbay, 3d inst.

SIR,

ENCLOSED is a copy of a letter from Captain Yorke, of his Majesty's ship *Stag*, informing me with his having captured *L'Heureux* privateer letter of marque, which is transmitted for their Lordships' information.

MY LORD,

ON the 19th instant, and in the latitude of the entrance of the Garonne, longitude 4 deg. W. Cambrian in company, we fell in with two sail, to which immediate chase was given; one, *L'Heureux* privateer letter of marque, carrying ten brasses fixes, from Cayenne to Bourdeaux, laden with red dye, cotton, cocoa, coffee, and sugar, &c. was taken possession of by the *Stag*, the other a large Bourdeaux privateer, of 26 guns, outward bound, on a cruise, was left to the better failing, and I trust good fortune of the Cambrian.
