The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Consul-General at Hamburgh, reporting the following alterations in the tariff and port charges at that port.

Abolition of export duty. Abolition of ship dues.

Abolition of tonnage dues on river boats for their passage on the river, including vessels that arrive from beyond sea and Heligoland, with fish; and also on steamers carrying passengers to and from Heligoland, Föhr, Norderney; such vessels however, in case of entering inner harbours, to pay harbour dues in conformity with regulation of 8th December 1843.

Abolition of import duty on cotton, woollen and half woollen yarn, flax, and other articles inserted in paragraph 3 of the Customs Regulations, and in list of articles not liable to duty, annexed to that paragraph; on passenger's baggage if accompanied by owner, and not exceeding value of 100 marks banco, exclusive of wearing apparel; and on all articles imported in parcels not exceeding the value of 20 marks banco. Goods will be allowed to remain in transit for a period of nine months, and the transit dues are reduced to 1s. 8d. per cent. for the first three months, and to a like amount for a further similar period; the value of such goods, the prices of which are not quoted on Change, or otherwise notified, to be calculated according to cost price, with addition of freight and charges.

(No. 42.) North America—West Coast.

Light on Cape Hancock, Columbia River.

THE United States' Lighthouse Board has given notice that on and after the 15th day of October 1856, a light would be established on Cape Hancock, on the north side of the mouth of the Columbia River, Washington Territory.

The light is a fixed white light, of the first order, illuminating the entire horizon. It is placed at a height of 230 feet above the level of the sea f and should be visible, in clear weather, from the deck of a ship at a distance of 22 miles.

The light tower is whitewashed; it is 40 feet high, and stands on the pitch of the Cape, at about 190 feet above the sea. According to the United States Coast Survey it is in lat. 46° 16′ 35″ N., long. 124° 2′ west of Greenwich. Variation of the compass 20° 45' east in July 1851.

A fog bell of 1,600 lbs. weight has also been placed on the bluff, in advance of the light tower, and will be sounded during foggy or thick weather, day and night, from the same date. The distinctive mode of striking the bell will be published hereafter. The machinery is in a frame building, on a level with the ground, with the front open to receive the bell, and is also white-washed.

(No. 43.) North Sea- River Weser.

Fixed Light on the Hohe Weg Flat. The Senate of the Free Hanse-Town of Bremen has given notice that on and after the 1st day of December 1856, a light will be established in a light-house recently erected in the place of the Bremen Beacon on the flat named Hohe Weg, at

the entrance of the River Weser.

The light will be a fixed white light; the illuminating apparatus being a catadioptric lens of the second order. It is placed at a height of 112 feet above the mean level of the sea, and should be visible in clear weather from the deck of a ship at a distance of 15 miles, and may therefore be seen from the first or outer buoy of the Weser, called the Schlüssel-tonne or Key bouy. The light will be only visible from N.W. by W. round northerly and easterly to south.

The light-house is an octagonal structure of brick on a stone basement, its whole elevation being about 120 feet; at a height of about 40 feet above the mean tide level it is surrounded by a terrace with an iron railing. It stands on the site of the old wooden Bremen Beacon, in lat. 53° 42′ 51" N., long. 8° 14′ 52" east of Greenwich. From the light-house the outer light vessel bears N. by W. 4 W., and the church of Langwarden

bears south.

On the day it is first lighted the inner light

vessel will be removed from her station.

For the convenience of mariners entering the Weser, but by no means to induce them to neglect the use of the lead, a small white light will be shown from the lighthouse at a height of 44 feet above the mean tide level, visible in clear weather at the distance of 7 miles. This light will dis-

appear to those who are nearing too much the black buoy (or starboard side) on entering, near huoys H. and J. To those entering the channel named the Dwasgat, the light will assume a reddish colour, in a line with the red buoy, and will disappear when they reach the line of the black W A buoy. This low light will be only visible from N. by W. 3 W. round northerly to E. by S.

Revolving Light on Wanger-Oog.

nary weather, at a distance of 16 miles.

The light tower is octagonal in form, painted white, and is 75 feet in height to the floor of the lantern. It stands in lat. 29° 43′ 55" N., long. 93° 50′ 19" west from Greenwich.

To cross the Bar, bring the light to bear N.W. by N., and run in N.W., passing the Louisiana shore abreast of the lighthouse, at a distance of one cable's length.

The United States' Lighthouse Board has also given notice, that on or about the 1st day of January 1857, a light will be established on a light tower recently erected at Aransas Pass, upon Low Island, on the coast of Texas, in the Gulf of Mexico.

The light will be a fixed white light, and its illuminating apparatus a lens of the fourth order. The light is placed at an elevation of 60 feet above the mean level of the sea, and should be seen from the deck of a ship, in ordinary weather, at a distance of about 13 miles.

The tower is octagonal; it is painted dark brick colour, and it is 55 feet in height to the floor of the lantern. It stands in lat. 27° 54′ 0″ N., long. 97° 3′ 54" west from Greenwich, nearly.

The light when bearing N.W. & W. will show between the two points of the Pass; but the Bar shifts so often that no directions can be given for crossing without a pilot.
