THIS day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them, that the Lords authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers, to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to amend the Act for limiting the time of service in the Royal Marine Forces.

An Act to facilitate the appointment of chief constables for adjoining counties, and to confirm appointments of chief constables in certain cases.

An Act to confirm certain provisional orders of the General Board of Health applying the Public Health Act 1848, to the districts of Ipswich, Oldbury, Stroud, Llangollen, and Dukinfield; and for altering the constitution of the Local Board for the Main Sewerage District of Wisbech and

An Act to enable the subjects of the Ionian States to hold military and naval commissions under the Crown.

And Her Majesty has been further pleased to command that the said royal order and declaration be registered in the College of Arms.

NAVAL MEDALS FOR THE BALTIC.

Department of the Accountant-General of the Navy, Admiralty, Somerset-House, March 13, 1857.

HER Majesty having been graciously pleased to grant a Medal to the Officers and Men serving on board Her Majesty's ships in the Baltic campaigns, from the 28th of March 1854 to the close of the Naval Operations in that year, and from the commencement to the close of Naval Operations in the year 1855-

Notice is Hereby Given, that all claimants to such Medal, notwithstanding any previous appli-cation, should apply personally or by letter, with the words "Baltic Medal" on the outside, to the Accountant-General of the Navy, Admiralty,

Somerset House.

Every applicant must state his rank or rating, and the name of the ship or ships on board which he served; also, in the case of every Petty Officer, Seaman, or Marine, it is indispensable that his application should be accompanied by a certificate of service, except in the case of his being on board one of Her Majesty's ships, and the application be made through his Commanding Officer, in which case the certificate will not be required.

Where there are several applicants on board the same ship, it is desirable that they should make their applications in one letter through their Commanding Officer, by a list alphabetically arranged under the ships in which they were serving at the time, and affording the information as above

required.

No other claims should be mixed up with the applications for the Medal in question, and in all cases where the parties have served in more than one ship in the Baltic between the dates before stated, the name of each ship must be stated.
