The Speech of the Lords Commissioners to both Houses of Parliament, on Saturday, March<sup>\*</sup> 21, 1857.

My Lords and Gentlemen,

WE are commanded by Her Majesty to inform you that, in releasing you at this early period from your attendance in Parliament, it is Her Majesty's intention immediately to Dissolve the present Parliament in order to ascertain, in the most constitutional manner, the sense of Her People upon the present state of Public Affairs.

Gentlemen of Commons,

We are commanded by Her Majesty to thank you for the liberal provision which you have made for the exigencies of the Public Service during the period that will elapse before the New Parliament, which Her Majesty will direct immediately to be called, shall have been able to give its deliberate attention to these matters.

## My Lords and Gentlemen,

We are commanded by Her Majesty to express the satisfaction which She feels at your having been able, during the present Session, materially to reduce the burdens of Her People. Her Majesty commands us to assure you that it is Her fervent prayer that the several constituencies of the United Kingdom, upon whom will devolve the exercise of those high functions which, by the Constitution, belong to them, may be guided by an All-wise Providence to the selection of representatives whose wisdom and patriotism may aid Her Majesty in Her constant endeavours to maintain the honour and dignity of Her Crown, and to promote the welfare and happiness of Her People.

A PROCLAMATION,

For Dissolving the present Parliament and declaring the Calling of another.

VICTORIA, R.

HEREAS We have thought fit, by and with the advice of Our Privy Council, to dissolve this present Parliament, which was this day prorogued and stands prorogued to Thursday the thirtieth day of April next: We do for that end publish this Our Royal Proclamation, and do hereby dissolve the said Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgesses, and the Commissioners for shires and burghs, of the House of Commons, are discharged from their meeting and attendance on the said Thursday the thirtieth day of April next; and We, being desirous and resolved, as soon as may be, to meet Our people, and to have their advice in Parliament, do hereby make known to all Our loving subjects Our Royal will and pleasure to call a new Parliament; and do hereby further declare, that, with the advice of Our Privy Council, We have given order that Our Chancellor of that part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, do respectively, upon notice thereof, forthwith issue out writs in due form and according to law, for calling a new Parliament; and We do hereby also, by this Our Royal Proclamation under Our Great Seal of Our United Kingdom, require writs forthwith to be issued accordingly by Our said Chancellors respectively, for causing the Lords Spiritual and Temporal and Commons, who are to serve in the ARE Rliament to be duly returned to a market are to be in Our said Parliament's which write are to be returnable on Thursday the thirtieth day of April | land, ten days, at least, before the time hereby

## A PROCLAMATION,

In order to the Electing and Summoning the Sixteen Peers of Scotland.

VICTORIA, R.

WHEREAS We have in Our Council thought fit to declare Our pleasure for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Thursday the thirtieth day of April next ensuing the date hereof; in order therefore to the electing and summoning the Sixteen Peers of Scotland, who are to sit in the House of Peers in the said Parliament, We do, by the advice of Our Privy Council, issue forth this Our Royal Proclamation, strictly charging and commanding all the Peers of Scotland to assemble and meet at Holyrood House, in Edinburgh, on Tuesday, the fourteenth day of April next, between the hours of twelve and two in the afternoon, to nominate and choose the Sixteen Peers to sit and vote in the House of Peers in the said ensuing Parliament, by open election and plurality of voices of the Peers that shall be then present, and of the proxies of such as shall be absent, (such proxies being Peers, and producing a mandate in writing, duly signed before witnesses, and both the constituent and proxy being qualified according to law,) and the Lord Clerk Register, or such two of the Principal Clerks of the Session as shall be appointed by him to officiate in his name, are hereby respectively required to attend such meeting, and to administer the oaths required by law to be taken there by the said Peers, and to take their votes; and immediately after such election made and duly examined, to certify the names of the Sixteen Peers so elected, and to sign and attest the same in the presence of the said Peers the electors, and return such certificate into Our High Court of Chancery of Great Britain. And We do, by this Our Royal Proclamation, strictly command and require the Provost of Edinburgh, and all other the Magistrates of the said city, to take especial care to preserve the peace thereof during the time of the said election, and to prevent all manner of riots, tumults, disorders, and violence whatsoever. And We strictly charge and command that this Our Royal Pro-clamation be duly published at the Market Cross at Edinburgh, and in all the county towns of Scot-

(No. 13.) ATLANTIC OCEAN.—NEWFOUNDLAND.

Light on Green Isle, Catalina Harbour.

The Colonial Government at Newfoundland has given notice, that on and after the 1st day of March 1857, a light would be exhibited from a lighthouse recently erected on Green Isle, on the south side of the entrance of Catalina Harbour, Trinity Bay, on the east coast of Newfoundland.

The light is a fixed white light, and will be visible seaward from the deck of a ship, in a favourable state of the atmosphere, at a distance of 8 miles from E.N.E. round southerly to S.W.

The lighthouse consists of a keeper's dwelling, of wood, of a story and a half high, with a pitched roof, through the centre of which rises a low stone tower surmounted by a lantern, the height from

the base to the top being 32 feet.

About the 1st day of June next this light, which is temporary, will be replaced by a more powerful light of the same character, the illumination of the same character. nating apparatus being a lens of the fourth order. The light will be placed at a height of 86 feet above the level of the sea, and will be visible through the same arc of the horizon, from E.N.E. round southerly to S.W., for a distance of 15 miles.

Green Isle is in lat. 48° 30' 45" N., long. 53° 6' W., of Greenwich nearly.
