SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Twenty-second Day of June, Eighteen Hundred and Sixty Years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled 'An Act to make Provision for the better Government and Discipline of the Universities of Scotland, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of Aberdeen,' it is provided, that the Commissioners of Her Majesty's Treasury shall be empowered to pay out of such Moneys, as may be provided by Parliament for the Purpose, such Sums of Money as the Commissioners under the said Act shall recommend to be paid for, among other Purposes, that of providing retiring Allowances to aged and infirm Principals and Professors; and whereas the said Act, by Section XII. 5, empowers the University Court of each University, upon sufficient Cause shown, and after due Investigation, to require a Principal or Professor to retire from his Office on a retiring Allowance, subject to the Proviso, that no such Requisition shall have any Effect until it has been approved by Her Majesty in Council; but the said Act does not provide in what Manner a Principal or Professor, disabled from the Performance of his Duties by Age or Infirmity, should make Application to be allowed to retire on a retiring Allowance; and whereas it is expedient that Provision should be made as to the Mode of Procedure in such a Case, the Commissioners statute and ordain:—

That any Principal or Professor desiring to retire from his Office on a retiring Allowance, on the Ground of Age or Infirmity, shall apply by Petition to the University Court, stating the Grounds on which his Application is rested, and if the University Court, after due Inquiry, shall be satisfied that the Petitioner is, by Reason of Age or Infirmity, permanently incapable to discharge the Duties of his Office, they shall report the same to Her Majesty in Council, together with a Statement of their Opinion that the Petitioner ought to be permitted to retire; and, in the Event of the Opinion of the University Court receiving the Approval of

Her Majesty in Council, the Petitioner shall be entitled to retire from his Office, and to receive a retiring Allowance on the same Scale and Conditions as may for the Time be applicable to the Case of a Principal or Professor retiring under Section XII. 5 of the said Act.

SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Twenty-fifth Day of June Eighteen Hundred and Sixty Years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled 'An Act to make Provision for the better Government and Discipline of the Universities of Scotland, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of Aberdeen,' the Commissioners for the Purposes of the said Act are empowered to revise the respective Foundations, Mortifications, Bursaries, and Donations, bestowed on any of the Universities or Colleges mentioned in the said Act, or for the Benefit of any Professors, Students, or others therein; and, further, if in the Case of any such Gift or Endowment which has taken Effect for more than Fifty Years, and has been held by any of the said Universities or Colleges, or by any other Person in Trust for or on behalf of the same, or of any Persons therein, it shall appear to the Commissioners that the Interests of Religion and Learning, and the main Design of the Donor, so far as consistent with the Promotion of such Interests, may be better advanced by an Alteration of the Conditions or Directions affecting such Gift or Endowment, to alter or modify such Conditions or Directions, and to frame a new Statute or Ordinance for the Application of such Gift or Endowment in such manner as may better advance the Purposes thereof; and whereas by Deed of Mortification,

dated the Fourth day of June Sixteen Hundred and Eighty-one, Mr *John Ramsay*, Minister of *Markinch*, in the County of *Fife*, mortified his Lands of *Duniface*, in the said Parish and County, for the Education and Entertainment of Three Youths at School and College in *St Andrew's*, in the Manner and subject to the Conditions in the said Deed more particularly set forth; and whereas, since the said Date, the Value of the said Lands has greatly increased, so that it appears to the Commissioners that the Interests of Religion and Learning, and the main Design of the Donor would be better advanced by an Alteration of the Conditions and Directions affecting the said Mortification; and whereas Two of the said Three Bursaries were vacant at the Commencement of the last College Session; and whereas a Competition took Place for Appointment to such two Bursaries, subject to the Condition that their Number, Value, and Duration should be determined by the Commissioners, and Two Students were declared successful Competitors for such Bursaries, but have not received any Presentation thereto; and whereas the Third of the said Bursaries has become vacant since the Expiration of the last College Session; the Commissioners statute and ordain, with reference to the University of *St Andrew's* and the said Mortification, as follows:—

I. Hereafter there shall be Eight Bursars and One Fellow on the said Foundation, to be called respectively the *Ramsay Bursars* and *Ramsay Fellow*, who shall receive the net annual Rents and Proceeds of the said Lands or other Property included in the said Mortification in the following Proportions, that is to say, each Bursar on the Foundation shall receive annually during the Continuance of his Bursary One Twelfth Part of such net annual Rents and Proceeds, and the Fellow shall receive annually during the Continuance of his Fellowship Four Twelfth Parts of such Rents and Proceeds.

II. The sole Patronage of, and Right of Nomination to, the said Eight Bursaries, shall be vested in Sir *Alexander Ramsay* of *Balmain*, Baronet, and his Heirs, in whom is now vested the Patronage of the Three Bursaries under the said Mortification.

III. The Senatus of the *United College of St Salvador and St Leonard* shall, on or before the First Day of August in each Year, intimate to the Patron the Number of Bursaries then vacant, and the Patron shall thereupon, and not later than the Fifteenth day of October then next, intimate to the College the Name or Names of the Person or Persons whom he nominates to such vacant Bursary or Bursaries, nominating at least One Person for each vacant Bursary; and, in the Event of more than One Person being nominated for any Bursary, such Bursary shall be competed for by the Persons so nominated: Provided, that in the Event of the Patron failing at any Time to intimate his Nomination to any Bursary on or before the said Fifteenth Day of October, such Bursary shall, at the Commencement of the Session, be thrown open to general competition among the Students then entering upon the First Year of the Curriculum in Arts in the said College; Provided also, that Nominations shall not be made to more than Two Bursaries, nor shall more than Two Bursaries be filled up, in any One Session, and, in the Event of more than Two Bursaries being vacant at One Time, the vacant Bursary or Bursaries above the Number of Two shall be suspended and kept vacant until some subsequent Session, so that there shall not be more than Two Bursaries filled up in any one Session, as aforesaid; and the Portion of the Income of the mortified Estate so set free shall be added to the

Capital, or employed in the Improvement of the Lands belonging to the Mortification; and the Funds so added to the Capital may be invested by the College, in Land, or on Heritable Security, or in the Public Funds, and no otherwise.

IV. All Students, without Limitation or Preference of Names, entering upon the First Year of the Curriculum in Arts, and being between the Ages of Fifteen and Nineteen Years on the First Day of the Session in the *United College*, shall be eligible for Nomination on or before the preceding Fifteenth Day of October.

V. Every Student nominated to a Bursary under the said Mortification, shall, before being admitted thereto, be required to pass the Entrance Examination of Students, and, upon being admitted to his Bursary, he shall proceed regularly through the Curriculum in Arts, and undergo the Examinations required by the College for the Degree of Master of Arts, and shall also submit to such Examinations during his Curriculum, as may be required of the Foundation Bursars of the College: Provided that, if he shall fail to pass the Entrance Examination, or any of the above mentioned subsequent Examinations, he shall from and after such Failure forfeit his Bursary: Provided also, that in Case of any gross Misconduct on the Part of a Bursar, it shall be in the power of the Senatus Academicus of the University, with the Approval of the University Court, to deprive him of his Bursary.

VI. Each Bursar shall, subject to the above mentioned Conditions, be entitled to hold his Bursary for a Period of Eight Years, provided that he shall, during the first Four of such Years give Attendance on the Course of Study in the Faculty of Arts in the *United College*, and shall, on the Completion thereof, proceed to the Degree of Master of Arts, and during the next Four Years shall give Attendance on the Course of Study in Divinity in *St Mary's College*; but in case of a Bursar not proceeding with the Study of Divinity in *St Mary's College*, his Bursary shall lapse and become vacant at the End of his Course in the Faculty of Arts in the *United College*.

VII. Nothing herein contained shall affect the Claims of the Two successful Competitors for the Bursaries competed for at the Commencement of last Session, as above mentioned, to be presented by the Patron to Two Bursaries to be held as from the Beginning of last Session: Provided always, that, if so presented, they shall hereafter hold their Bursaries subject to the above mentioned Regulations and Conditions as to the Value, Duration, and Terms of Tenure for the Future, of Bursaries under the said Mortification: Provided also that the Presentation of the said Two Bursars, as aforesaid, shall not interfere with the Right of the Patron to nominate Two Persons for vacant Bursaries on or before the Fifteenth Day of October Eighteen hundred and Sixty.

VIII. The *Ramsay Fellowship* shall be open for general Competition to all Persons who have passed regularly and uninterruptedly through the Course of Study in the Faculty of Arts in the *United College*, and have completed such Course of Study within Four Years before the Time at which the Competition shall take Place, and the successful Competitor for the Fellowship, if he have not already been admitted to the Degree of Master of Arts, shall not be admitted to the Fellowship, unless he proceed to that Degree within One Year after the Time of the Competition.

IX. The Examination of Candidates for the *Ramsay Fellowship* shall embrace all the Branches

of Study included in the Curriculum in Arts, and the Examination shall be conducted by the Professors whose Branches are included in the said Curriculum.

X. The first Competition for the said Fellowship shall take Place at a Time to be hereafter fixed by the Senatus of the *United College*, with the Sanction of the Commissioners.

XI. The said Fellowship shall be tenable for Four Years, and on its becoming vacant at the End of such Four Years, or by the Death of the Holder, it shall be again competed for under the same Conditions, and so on thereafter as often as it shall become vacant.

XII. It shall not be competent for any Person to hold the said Fellowship along with any Bursary in the University of *St Andrew's*.

SCOTTISH UNIVERSITIES COMMISSION.

*At Edinburgh, the Second Day of July
Eighteen hundred and Sixty Years.*

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled 'An Act to make Provision for the better Government and Discipline of the Universities of *Scotland*, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of *Aberdeen*,' the Commissioners under the said Act are empowered, subject to the Provisions of the Act, to regulate by Ordinance the Powers, Jurisdictions, and Privileges of Chancellors, Rectors, Assessors, Professors, and all other Members or Office-Bearers in the several Universities of *Scotland*, as also of the Senatus Academicus, the General Council, and the University Court, and their Meetings; and, further, to make Regulations as to Time, Place, and Manner of presenting and electing all University Officers; the Commissioners statute and ordain, with reference to each of the said Universities, as follows:—

I. At the Meetings of the General Council, in the Absence of the Chancellor, Rector, and Principal, the Professor who has been longest in Office, as Professor in the University, of those present shall preside: Provided that in the University of *St Andrew's* the Junior Principal, if present, shall, in the Absence of the Chancellor, Rector, and Senior Principal, preside in Preference to the Senior Professor; and in every Case the President of the Meeting shall have a deliberative and also a casting Vote.

II. It shall not be in the Power of the General Council to adjourn its Meetings from either of the stated annual Days of Meeting to a future Day; but it shall be in the Power of any Meeting to suspend its Proceedings from One Hour to a later Hour of the same Day.

III. It shall be in the Power of the General Council to appoint a Committee or Committees at One Meeting to arrange or prepare Business for a future Meeting; but it shall not be in the Power of the General Council to delegate any of its Functions to a Committee, or to act by means of a Committee.

IV. In the Absence of the Rector at a Meeting of the University Court of any University, the Member present, who is first mentioned in the Enumeration of its Members in the said Act, shall preside, with a deliberative Vote only; and, in the Event of an Equality of Votes upon any Question at such Meeting, the Consideration of the Question before the University Court shall be adjourned to a Day, of which due Notice shall be given to the Rector; and on that Day the Consideration of the Question so adjourned shall be resumed, and, if the Rector does not then attend, the Member presiding at such subsequent Meeting shall have both a deliberative and a casting Vote on that Question.

V. On the Occurrence of a Vacancy in the Office of Chancellor, the Election of his Successor shall take Place at the first ordinary Meeting of the General Council, which shall take Place after the Lapse of Two Months from the Occurrence of the Vacancy.

VI. Whenssoever the statutory Term of Office of the Assessor in the University Court for the General Council is to expire within Ten Days next after an ordinary half-yearly Meeting of the General Council, it shall be lawful for the General Council at the said half-yearly Meeting to proceed to the Election of an Assessor, who shall enter upon his Office at the Expiration of the said statutory Term of Office; and, in the Event of a Vacancy occurring from any Cause at any other Period, the General Council shall proceed to the Election of an Assessor at the next ordinary half-yearly Meeting.

VII. Provided always, that at any Meeting of the General Council, at which an Election of Chancellor or Assessor shall fall to take Place, the General Council shall proceed to such Election before entering on any other Business.

VIII. The Appointment of every Assessor to the University Court shall be made in Writing, and the written Appointment shall be forthwith transmitted to the University Court; and no Assessor shall be entitled to act as a Member of the University Court, until his written Appointment shall have been so transmitted.

IX. In the Election of Chancellor or of Assessor by the General Council, where more than One Person is nominated for the same Office, the President of the Meeting shall, by Means of a Show of Hands, ascertain and declare which of the Persons nominated has a Majority of Votes at the Meeting, and, if no Poll be demanded by the Proposer or Seconder of any Candidate, the President shall declare such Person to be duly elected; but, in the Event of a Poll being demanded by the Proposer or Seconder of a Candidate, a Poll of all the Members of the General Council shall be taken in the Manner hereinafter provided, that is to say, the Registrar shall, on the next Day but One after the Day of Meeting, issue, through the Post, to each Member resident in the United Kingdom, to his Address as appearing in the Register, a voting Letter in the Form of Schedule (A.) hereunto annexed, with all the Blanks filled up, except the Name of the Person for whom the Member votes and the Signature of the Member; and such Letter shall be accompanied by a Letter of Intimation from the Registrar in the Form of Schedule (B.) hereunto annexed, and each Member, upon Receipt of his voting Letter, if he desires to vote in the Election, shall insert the Name of the Candidate for whom he votes, and affix his Subscription, and return the voting Letter to the Registrar in such Time, that the Registrar shall receive the same within Twenty-one Days after the said Day

of Meeting ; and, on the Expiration of the said Twenty-one Days, the Registrar shall, in the Presence of the Proposer or Seconder of each Candidate, or of some Person to be named by them for the Purpose, sum up the Votes so returned ; and the Candidate, for whom the largest Number of Votes shall be returned within the Time aforesaid, shall be declared to be duly elected as from the Day of Meeting, and an Intimation to that Effect, under the Hands of the President of the Meeting and the Registrar, shall be forthwith published in the *Edinburgh Gazette*, and a Copy thereof fixed in some patent Place in the University ; and, in Case of an Equality of Votes for Two or more Persons, the President of the Meeting shall have a casting Vote : Provided always, that it shall be lawful for the Registrar to deliver his voting Paper, with the Blanks duly filled up as aforesaid, to any Member of the General Council personally, or to send it through the Post to any Member to

a different Address from that appearing in the Register, on an Application by such Member to that Effect being lodged with the Registrar not later than the Day immediately following the Day of Meeting ; but the Registrar shall not in any Case deliver the voting Paper of any Member to another Member, or to any other Person, but shall either send it through the Post, or deliver it personally to each Member ; and no Vote shall be reckoned in the Election, which is not returned under the Signature of a Member to the Registrar in a voting Letter issued as aforesaid.

SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Second Day of July
Eighteen hundred and Sixty years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled 'An Act to make Provision for the better Government and Discipline of the Universities of Scotland, and improving and regulating the Course of Study therein; and for the Union of the two Universities and Colleges of Aberdeen,' the Commissioners under the said Act are empowered, *inter alia*, to make Rules as to the Amount and Exaction of Fees, and the granting of Degrees, whether in Arts, Divinity, Law, or Medicine, in the several Universities of Scotland, and to make such Provision by Ordinance, as they shall see fit, for the due Preservation, Administration, and Disposal of the whole Property, Funds, Rents, Revenues, and Endowments of the said Universities, and to make all such Rules and Ordinances as may be necessary for securing good Order and Government, and regulating the Course of Study in the University of Aberdeen; the Commissioners statute and ordain, with reference to the University of Aberdeen, as follows:—

I. From and after the Date, at which the said Act shall come into Operation in the University of Aberdeen, and subject to any Alterations which may hereafter be made by the Commissioners, the Course of Study for the Degree of Master of Arts in the said University shall extend over four Winter Sessions, as herein provided; and no Person, who shall commence his Course of Study after the said Date, shall be admitted to the Degree of Master of Arts, unless he shall have completed such Course of Study:—

During the First Session, the Attendance shall be on the Classes of Latin and Greek, each for Two Hours daily for Five Days a Week, and on the Class of English Language and Composition, under the Professor of Logic, for One Hour on each of Three Days a Week;

During the Second Session, the Attendance shall be on the Class of Mathematics for Two Hours daily for Five Days a Week, and on the Classes of Latin, Greek, and Natural History, each for One Hour daily for Five days a Week;

During the Third Session, the Attendance shall be on the Classes of Logic and Natural Philosophy, each for Two Hours on each of Three Days, and One Hour on each of Two Days a Week, and on the Class of Mathematics for One Hour daily for Five Days a Week;

During the Fourth Session, the Attendance shall be on the Class of Moral Philosophy for Two Hours on each of Three Days, and One Hour on each of Two Days a Week, and on the Classes of Natural Philosophy and Chemistry, each for One Hour daily for Five Days a Week.

II. The Class Fees payable by Students in the Faculty of Arts shall be the following, viz.—

During the First Session, for each of the Classes of Latin and Greek a Fee of Three Guineas, and for the Class of English Language and Composition a Fee of One Guinea;

During the Second Session, for each of the Classes of Mathematics and Natural History

a Fee of Three Guineas, and for each of the Classes of Latin and Greek a Fee of One Guinea;

During the Third Session, for the Class of Natural Philosophy a Fee of Three Guineas, for the Class of Logic a Fee of Two Guineas, and for the Class of Mathematics a Fee of One Guinea;

During the Fourth Session, for each of the Classes of Moral Philosophy and Chemistry a Fee of Three Guineas, and for the Class of Natural Philosophy a Fee of One Guinea:

Provided always, that Students, who shall not have commenced their Studies in *King's College* or *Marischal College* before the Date aforesaid, and shall attend the Second Class of Latin, Greek, Mathematics, or Natural Philosophy, without having attended the First Class, or shall attend the Class of Logic without having attended the Class of English Language and Composition, shall pay in each Case a Fee of Three Guineas, in respect of such Attendance, instead of the lower Fee above mentioned.

III. In the Faculty of Divinity, the Fee payable by Students for each of the Classes of Systematic Theology, Oriental Languages, Church History, and Biblical Criticism, shall be One Guinea and a Half for each Session.

IV. In the Faculty of Law, the Professor of Law shall deliver Two Courses of Lectures, one on Scots Law, and the other on Conveyancing, and the Fee payable by Students for each of the said Courses shall be Two Guineas.

V. In the Faculty of Medicine, the Fees payable by Students shall be, for each of the Classes of Institutes of Medicine, Practice of Medicine, Chemistry, Practical Chemistry, Anatomy, Surgery, Materia Medica, Midwifery, Botany, and Medical Jurisprudence, a Fee of Three Guineas, and for Practical Anatomy and Demonstrations a Fee of Two Guineas: Provided always that the Title of the Professor of Medical Jurisprudence shall be 'the Professor of Medical Logic and Medical Jurisprudence,' in Terms of the Deed of Mortification made by Doctor *Alexander Henderson*, on the Twenty-sixth Day of August, Eighteen hundred and Fifty-seven, for the Establishment of a Professorship of Medical Logic and Medical Jurisprudence in *Marischal College*.

VI. Each Student shall pay a Matriculation Fee of One Pound Sterling at the Commencement of each Winter Session for the whole academical Year then next ensuing; but any Student attending Classes during a Summer Session, without having attended the immediately preceding Winter Session, shall, in respect of such Summer Session, pay a Fee of Ten Shillings only; and no other Fee shall be chargeable against any Student for such Year or Session, except the Professors' Class Fees.

VII. The Fees for Graduation shall be the following, viz.—

For the Degree of Master of Arts, Four Guineas;

For the Degree of Bachelor of Medicine, Twenty Guineas;

For the Degree of Doctor of Medicine, Five Guineas, in Addition to the Fee previously paid for the Degree of Bachelor of Medicine, but exclusive of any Stamp Duty, which may for the Time be exigible.

VIII. The Fees hereinbefore specified, whether Class, Matriculation, or Graduation Fees, shall be payable by all Students whether Bursars or not,

with this exception, that Students, who shall have obtained Bursaries either in *King's College* or in *Marischal College*, and who shall have studied as Bursars therein before the Date aforesaid, shall, during the Continuance of such Bursaries, pay the same Fees in the University of *Aberdeen*, as they would have paid, had the Union not taken Effect, and had they continued their Studies in the College, in which they obtained their Bursaries as aforesaid.

IX. The Matriculation and Graduation Fees shall be placed to the Account of a General University Fund, which shall also include all the Revenues formerly belonging to *King's College* or *Marischal College*, except such as have been, or shall be, otherwise appropriated by Ordinance of the Commissioners, and such as are appropriated to special Purposes by Mortification, Gift, or Endowment, the Conditions or Directions of which have not been altered or modified by the Commissioners; and the said General Fund, after the Payment of the Expense of Diplomas, shall be applicable to defray the ordinary current Expenses of the University, including Servants' Wages, and the Cost of lighting, heating, cleaning, maintaining and repairing the Buildings; also, the necessary Expenses of providing and maintaining such Apparatus and Museums, as are not provided for by Ordinance No. 6, *Aberdeen*, No. 2, of the Ninth Day of January in the present Year or otherwise; and the Residue of the said General Fund shall be applicable to the Purposes of the Library or Libraries of the University.

X. And whereas the Professorship of Divinity in *King's College* was endowed by the Synod of *Aberdeen*, and the Patronage of the said Professorship has heretofore belonged to the Synod, and whereas the Commissioners, by their said Ordinance No. 6, *Aberdeen*, No. 2, ordained, that the Patronage of the Professorship of Systematic Theology in the University of *Aberdeen* shall be vested in the said Synod; and whereas it is expedient to define the manner in which such Patronage shall be exercised, the Commissioners statute and ordain—

That the Patronage of, or Right of presenting to the said Professorship of Systematic Theology shall be exercised as nearly as possible in the Manner pointed out by the Charter of Erection of the said Professorship of Divinity in *King's College*, dated the Twelfth day of March in the Year Sixteen hundred and Forty-two, that is to say, on a Trial and Election by the following Persons, viz., the Moderator of the Synod of *Aberdeen*, two Commissioners from each Presbytery of the Synod to be chosen for the Purpose, the Principal of the University of *Aberdeen*, a Professor of the University to be chosen by the Senatus Academicus, and the Dean of the Faculty of Divinity therein, or a Member of that Faculty to be chosen for the Purpose by the Faculty.

WHEREAS by the three hundred and thirty-second section of "The Merchant Shipping Act, 1854," it is enacted that every pilotage authority shall have power, by bye-law made with the consent of Her Majesty in Council, to exempt the masters of any ships, or of any classes of ships, from being compelled to employ qualified pilots, and to annex any terms or conditions to such exemptions, and to revise and extend any exemptions existing at the passing of the said Act, by virtue of the said Act, or any other Act of Parliament, law, or charter, or by usage, upon such terms and conditions, and in such manner as may appear desirable to such authority. And by the three hundred and thirty-third section of the said recited Act it is enacted that, subject to the provisions contained in the fifth part of the same Act, it shall be lawful for every pilotage authority, by bye-law made with the consent of Her Majesty in Council, from time to time, to do within its districts, all or any of the things specified in that behalf in the said section, which things include, amongst others, to repeal or alter any bye-law made in exercise of the said powers, and to make a new bye-law or new bye-laws in lieu thereof. And whereas the Commissioners for the Harbour and Docks of Leith are the pilotage authority for the said port and harbour, according to the meaning of the said recited Act, and have certain powers in respect of the pilotage of the said port or harbour, under certain local Acts. And whereas, pursuant to the said three hundred and thirty-third section of the said recited Act, the said Commissioners have made certain Regulations in regard to the piloting of vessels at the Port of Leith, and such Regulations were approved by Her

Majesty in Council on the twenty-eighth day of July one thousand eight hundred and fifty-six. And whereas the said Commissioners have submitted, for the consent of Her Majesty in Council, the bye-law, a copy whereof is set forth in the Schedule hereunto annexed, with respect to the piloting of vessels at the port of Leith. And whereas it has been made to appear to Her Majesty that the said bye-law is proper and reasonable; now therefore, Her Majesty, by virtue of the powers vested in Her by the said recited Act, and by and with the advice of Her Privy Council, is pleased to approve, and doth hereby approve and signify Her consent to the said bye-law, as a bye-law of the Commissioners for the Harbour and Docks of Leith, with respect to the piloting of vessels at the port of Leith. ARTHUR HELPS.

SCHEDULE to which the foregoing Order refers.

The Commissioners for the Harbour and Docks of Leith do hereby, pursuant to the three hundred and thirty-second and three hundred and thirty-third sections of the Merchant Shipping Act, 1854, enact that from and after the expiration of ten days from the publication in the London Gazette of the Order signifying the consent of Her Majesty in Council to this bye-law, the Regulations in regard to the piloting of vessels at the port of Leith, approved by Her Majesty in Council on the twenty-eighth day of July one thousand eight hundred and fifty-six, and enacted and declared to take effect on the 8th day of September one thousand eight hundred and fifty-six, shall be amended and altered in manner following, that is to say:

The Second Article of the said Regulations is repealed, and in lieu of the said Article the following is substituted:

“ II. No shipmaster or other person shall be bound to employ a pilot, either inwards or outwards.”

The rates of pilotage referred to in the Twelfth Article of the said Regulations shall be those specified in the Table hereunto annexed, which Table is substituted for the Table of Rates of Pilotage annexed to the said Regulations :—

The Right Honourable the Lords of the Committee of Privy Council for Trade and Plantations have received, through the Secretary of State for Foreign Affairs, translations of a Royal Decree respecting the importation of Foreign brandy into Portugal, and of a Government Order consequent thereon, which have been transmitted by Her Majesty's Consul at Lisbon, from which the following are extracts :—

I.—ROYAL DECREE.

Article 1.—Foreign brandy of the strength of 33 degrees, according to Cartier's hydrometer, shall pay a duty of 1,500 reis, or 6s. 9d. sterling, per almude.

Foreign brandy imported in bottles or jars, and all which may exceed 33 degrees by the above-named hydrometer, shall pay a duty of 2,000 reis, or 9s. sterling, per almude.

The Government shall designate the custom-houses at the sea-ports, as well as the fiscal stations through which this article can be admitted.

II.—GOVERNMENT ORDER.

In virtue of the authorization conceded to the Government by the last paragraph of the first Article of the above Royal Decree, His Majesty the King hereby determines that Foreign brandy is permitted to enter the Custom-house of Barca de Alva, in transit for Oporto, at which Custom-house only the same can be cleared for consumption, on being accompanied by a proper pass.

NAVAL UNIFORMS.

The following is the description of the Uniforms which, in pursuance of Her Majesty's pleasure, are in future to be worn by the Officers, Seamen, and Boys of the Royal Navy, viz. :—

ADMIRAL OF THE FLEET.

DRESS UNIFORM.

Coat.—Blue cloth, double breasted, ten buttons in each row, three inches apart across the breast; white collar sloped off in front, one and three-quarters inch gold lace of the Navy pattern along the top and front edges, and one inch lace along the bottom edge, coming partly on the coat; blue cuffs, with one and three quarters inch lace round the top; white slash pointed flaps in the sleeve with three small buttons, and one inch lace round the outside edge; four rows of five-eighths of an inch distinction lace round the sleeve above the cuff, at such distance from each other as place them within the length of the slash, *the upper row to form a circle, two inches diameter, in the centre of the top sleeve of all the coats of Officers of the Military Branch*; pointed blue flaps on the skirt, laced all round with one and three quarters inch lace, and three buttons under them; a row of one inch lace to encircle the hip buttons and form a point above them on the seam; and bottom of lappel and front and back edges of the skirt to be laced with the same; the skirts to begin at one-fifth the circumference from the front edge, and to be lined with white kerseymer; one button at the bottom of each plait.

Buttons.—Raised, gilt, and one inch in diameter, indented with a round rim, and within, an anchor and a cable, and a crown over between two wreaths of laurel; the small buttons to be half an inch in diameter.

Epaulettes.—Two gold epaulettes with embroidered straps, oak leaf and acorn pattern, with pearl crescent and edging, three stars within the crescent and one star on the strap, above it crossed batons surmounted by a crown; a double row of dead and bright loose bullions three inches long, and one inch and a quarter in circumference.

N.B.—The devices on all the Executive Officers' epaulettes to be embroidered in silver, according to patterns, except batons and swords, which are to be solid.

Trowsers.—Blue cloth, with one and three quarters inch gold lace down the outside seam, to be worn over boots, between the 1st October and the 30th April; and white duck, over boots, between the 1st May and 30th September.

Cravat or Stock.—Black silk.

Hat.—Cocked; the flaps eight and a half inches in the back, seven and a half inches in the front, five and three quarters inches at each corner, bound with gold lace two inches wide, showing one inch on each side. Black silk cockade, five inches wide, looped with six gold dead and bright bullions, three and a half eighths of an inch wide, the two centre twisted, with a button of the same size and pattern as that on the coat; and tassels with five gold and five blue bullions each.

Sword.—The hilt solid, half basket guard, with raised bars and crown and anchor badge, lion-head back piece, white fish skin gripe, bound with three gilt wires; outside length, five inches and three quarters; inside length, four inches and a half. The blade slightly curved, thirty-one inches

and a quarter long, and one inch and three-eighths wide at the shoulder, with a flat back and the blade ground hollow to within eleven inches of the end, with a double-edged spear point.

Scabbard.—The top and middle lockets to be four and three inches and a half long respectively; to have loops and rings, and to be ornamented with embossed oak leaves in bas-relief; the chape to be seven inches and a half long, and to have oak leaves, as above, round the upper part, and a honeysuckle ornament at the end.

Sword Knot.—Blue and gold rope, twenty-three inches long, with ditto ditto vellum basket-work head, and twelve gold bullions; a piece of the same sort of cord, fourteen inches and three quarters long, is to be fixed to the hilt, to which the knot is attached.

Sword Belt.—Blue morocco leather, lined, full one inch and a half wide in the girdle; single, *one inch wide*, sword slings on carriages; the whole embroidered in gold, with oak leaves and acorns down the middle, and margined with a straight line near each edge. Gilt mountings with circular clasp in front, two inches diameter laurel embossed edges, crown, anchor, and laurel on the centre; embossed carriage buckles, plain girdle buckles and rings, the latter one inch and three quarters diameter in the centre; a plain strong gilt hook attached to the ring to suspend the sword short.

UNDRESS UNIFORM.

Coat.—Blue cloth, double breasted, eight buttons in each row, with padded turn-down collar; pointed flaps with three notched holes, and buttons under; round cuffs, with three buttons, the sleeves laced the same as the full dress coat, omitting the slash.

Buttons.—The same.

Epaulettes.—The same as in dress.

Waistcoats.—White or blue cloth, or kerseymer, single breasted, with small buttons.

Trowsers.—Blue cloth, with or without gold lace on the seams; in warm climates, or on the home station in summer, Officers may wear white duck.

Cravat or stock.—Black silk.

Hat.—The same, or without lace.

Sword.—The same.

Scabbard.—The same.

Sword Knot.—The same.

Sword Belt.—Black morocco leather, of the same width as in full dress, but without embroidery, with round slings; the mountings and edges to be the same as in dress.

ADMIRAL.

DRESS UNIFORM.

The same uniform and appointments as Admiral of the Fleet, except that there are to be three rows only of distinction lace on the sleeves; and the

Epaulettes—are to have lace straps, with three stars, within the crescent, above them crossed sword and baton, surmounted by a crown.

UNDRESS UNIFORM.

The same as Admiral of the Fleet, except that the

Coat—is to have three rows only of distinction lace on the sleeves.

Epaulettes.—The same as in dress.

VICE-ADMIRAL.

DRESS UNIFORM.

The same uniform and appointments as an Admiral, except that the

Coat—is to have two rows only of distinction lace on the sleeves; and

Epauettes—two stars only within the crescent, under the crossed baton and sword.

UNDRESS UNIFORM.

The same as an Admiral, except that the

Coat—is to have two rows only of distinction lace on the sleeves.

Epauettes.—The same as in dress.

REAR-ADMIRAL.

DRESS UNIFORM.

The same uniform and appointments as an Admiral, except that the

Coat—is to have one row only of distinction lace on the sleeves; and

Epauettes—one star, of a larger size, within the crescent, under the crossed baton and sword.

UNDRESS UNIFORM.

The same as an Admiral, except that the

Coat—is to have one row of distinction lace on the sleeves.

Epauettes.—The same as in dress.

COMMODORES OF THE FIRST CLASS,
AND CAPTAINS OF THE FLEET WHEN
NOT FLAG OFFICERS.

DRESS UNIFORM.

The same as a Rear-Admiral, with the following exception:—

Epauettes.—The same pattern as the Admirals, but the bullions to be *bright*, with an anchor and chain cable within the crescent, above it a star, surmounted by a crown.

UNDRESS UNIFORM.

The same as a Rear-Admiral, except that the epauettes are to be the same as in dress.

COMMODORES OF THE SECOND CLASS.

DRESS UNIFORM.

The same as Commodores of the First Class, with the following exceptions:—

Coat.—The one and three quarters inch lace on the cuffs, the lace on the bottom edge of lappel and on front and back edges of skirt to be omitted; the lace round top edge of the collar to be one and a half inch wide, and three quarters of an inch along the bottom; one and a half inch lace round the flaps, and three quarters of an inch on slash in sleeve; and one inch to encircle the hip buttons. The sleeves to have four rows of half inch distinction lace round them.

Buttons.—The same as the Admirals, omitting the laurel wreaths.

Trowsers.—The lace on the outside seam to be one and a half inch wide.

UNDRESS UNIFORM.

The same as Commodores of the First Class, except that the sleeves are to be laced the same as the dress coat, omitting the slash, and to have notched holes to the three buttons on the cuffs.

Buttons the same as in dress.

CAPTAINS AND COMMANDERS.

DRESS UNIFORMS.

The same as Commodores of the Second Class, with the following exceptions:—

Coat.—The sleeves to have three rows of half-inch distinction lace for Captains, and two for Commanders. The lace round hip buttons for Commanders to be omitted.

Epauettes.—Captains of three years standing the same as Commodores. Those under three years standing to be distinguished by the anchor, surmounted by a crown; and

Commanders by the anchor surmounted by a star, and the bullions to be only two inches and three quarters long, and one inch and one-eighth in circumference.

Hats.—The same as the Admirals, but bound with black silk instead of gold lace, of the oak-leaf pattern, and looped with four *bright* gold bullions, the two centre twisted.

Scabbards.—The same as the Admirals, but the chape to be only six inches and a half long; both lockets and chapes to be ornamented with fluted threads and scrolls instead of oak leaves.

Sword Belts.—Black morocco leather, lined, the same dimensions as the Admirals, embroidered in gold, with three straight lines, one down the middle and one at each margin near the edge; gilt clasps, with circular fronts, with embossed laurel edges, crown and anchor in the centre; plain carriage and girdle buckles, and plain gilt ring and hook.

UNDRESS UNIFORM.

The same as Commodore of the Second Class, with the following exceptions:—

Coat.—To have three rows of distinction lace round the sleeves for Captains, and two rows for Commanders.

Epauettes.—The same as in dress.

Hats.—The same.

Scabbards.—The same.

Sword Belts.—The same as the Admirals, omitting the laurel in the centre of the clasp.

LIEUTENANTS.

DRESS UNIFORM.

The same uniform and appointments as Commanders, with the following exceptions:—

Coat.—The lace to be only one inch wide instead of one inch and a half; and half an inch instead of three quarters of an inch; and the sleeves to have one row of distinction lace round them.

Epauettes.—To be the same as Commanders, with the anchor only within the crescent.

Trowsers.—The lace on the outside seam to be one inch wide.

Hats.—To be looped with only two bullions, twisted.

Sword Belts.—To have only two straight lines, one near each edge.

UNDRESS UNIFORM.

The same as Commanders, with one row of distinction lace round the sleeves.

Epauettes.—The same as in dress.

Hats.—The same.

Sword Belts.—The same as Commanders.

MASTER OF THE FLEET.

DRESS UNIFORM.

The same uniform and appointments as a Commander, except that the

Epaulettes—are to have crossed anchors, with-out cables, within the crescent, surmounted by a gold and silver star on the strap.

UNDRESS UNIFORM.

The same as a Commander.

Epaulettes.—The same as in dress.

MASTERS.

DRESS UNIFORM.

The same uniform and appointments as Lieutenants, except that the

Epaulettes—are to have crossed anchors, with-out cables, within the crescent.

UNDRESS UNIFORM.

The same as Lieutenant.

Epaulettes.—The same as in dress.

MATES.

DRESS UNIFORM.

The same uniform and appointments as Lieutenants, with the following exceptions:—

Coats.—The lace to be only three quarters of an inch wide, and the sleeves to have one row of quarter inch braid round them instead of lace.

Trowsers.—To have no lace on the outside seams.

Epaulettes.—Instead of epaulettes, two shoulder straps of the same pattern as Lieutenant's epaulettes, without bullion, with the anchor within the crescent.

UNDRESS UNIFORM.

Coats.—The same as Lieutenants, except to have one row of quarter inch braid round the sleeves instead of lace.

Trowsers.—Same as in dress.

Shoulder Straps.—The same as in dress.

SECOND MASTERS.

DRESS UNIFORM.

The same uniform and appointments as Mates, except that the devices on the straps are to be the same as the Masters.

UNDRESS UNIFORM.

The same as the Mates, except that the devices on the straps are to be the same as the Masters.

MIDSHIPMEN.

Coat.—Blue cloth, single breasted, with nine notched holes on each breast, and three on each cuff, and pocket-flap, with buttons to correspond, lined with white serge, stand-up collar, with a white turn-back on each side of the collar, with notched hole and button.

Buttons.—The same as other Officers.

Swords.—No swords, but a dirk according to pattern.

Dirk Belts.—The same as the Lieutenant's undress belt, but with frog instead of slings.

Hat.—The uniform cap only.

MASTER'S ASSISTANT.

The same as midshipmen, but instead of the white turn-back, a button-hole of blue twist at each end of the collar, with a corresponding button.

NAVAL CADETS.

The same as midshipmen, but instead of the white turn-back, a button-hole of white twist on the collar, with a corresponding button.

GUNNERS, BOATSWAINS, AND CARPENTERS.

Coat.—Blue cloth; if lined, to be with serge, fall-down collar, blue lappels to button across, and round cuffs; nine buttons on the lappels, and three on each cuff and pocket, with corresponding blue twist button-holes, and three buttons in the folds of the skirts. Plain gilt buttons, with an anchor and cable engraved thereon.

Waistcoat.—White.

Cravat or Stock.—Black.

Hat.—Cap only.

Sword.—Of the same pattern and length as Commissioned Officers, but the back piece of the handle is to be plain, with a flute round the top and down the back, with a black fish-skin gripe, bound with three gold wires; the etchings on the blade not blued or gilt.

Sword Knot.—Of blue silk, mixed with gold fringe, but no bullion.

Sword Belt.—The same as Mate's undress belt.

PETTY OFFICERS, SEAMEN, AND BOYS.

Blue Cloth Jacket.—To be made of navy blue cloth, double breasted, with stand and fall collar, sleeves sufficiently large to go easily over a duck and serge frock, to reach to the hip, with an opening at the cuffs on the seam, with two small black buttons, one inside breast pocket on the left side, and seven black horn crown and anchor buttons, $\frac{7}{16}$ of an inch in diameter on each side, according to a pattern.

Blue Cloth Trowsers.—To be made of navy blue cloth, of the ordinary naval pattern, fitting tight at the waistband, with two pockets and a broad flap, and stained bone buttons.

Duck or White Drill Frock.—To be made with collar and wristbands of blue jean, each having a border of three rows of $\frac{3}{16}$ of an inch white tape, $\frac{1}{2}$ of an inch apart, with one white metal dead-eye button at each of the wrists.

Duck Trowsers.—To be made of white duck, in a similar manner to the blue trowsers, with white metal dead-eye buttons.

Blue Serge Frock.—To be made of the same material and pattern as that now in use.

Pea Jacket.—To be of blue flushing, the same as the present pattern and material, with seven buttons on each side, black horn, navy pattern, $1\frac{1}{2}$ inch in diameter.

Black Silk Handkerchief.

Hat.—To be black or white according to climate.

The hat to be four inches high in the crown, three inches wide in the rim, and seven inches across the crown, and made of sennet, covered with brown holland painted black, with a hat ribbon bearing the ship's name; and in warm climates the same hat uncovered.

A chin-stay to be attached to the hat.

Cap.—To be worn at *night*, and at sea when ordered.

The cap to be made round, of No. 1 cloth, and partially stiffened across the crown, similar in shape to that worn by naval officers, without the peak. Diameter across the crown, for men ten inches, for boys nine inches, with a ribbon bearing the ship's name.

A chin-stay to be attached to the cap.

Woollen Comforter.—To be of a dark blue colour.

Badges.—Petty officers and leading seamen are to wear an embroidered mark of distinction on the upper part of the left sleeve of their jacket; viz. :—

On the blue frock the badge is to be of red cloth, and blue on the white frock.

Badges and buttons of the approved pattern will be supplied to H.M.'s ships for issue.

CIVIL BRANCHES.

The coats of all ranks to be single breasted, at angles with the skirt; the distinction laces to be carried round the sleeves; the epaulettes to have silver instead of gold edging to the straps, quarter of an inch wide, to be continued round inside the crescent, and outside below it; the devices thereon to be embroidered in gold and silver; the loops of cocked hats to be of half-inch gold lace instead of bullion; the tassels to be flat; and the cap badges, and peaks of caps, of those officers entitled to wear them, to be embroidered in gold, as per patterns.

DIRECTOR-GENERAL OF NAVAL HOSPITALS AND FLEETS.

DRESS AND UNDRRESS.

The same uniform and appointments as Rear-Admiral, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Epaulettes.—The sword and baton to be omitted, and instead thereof an additional star on the epaulette strap.

INSPECTORS-GENERAL.

DRESS AND UNDRRESS.

The same uniform and appointments as Commodores of the First Class, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Epaulettes.—To have a crown on the strap, and a star placed within the crescent, omitting the anchor.

DEPUTY INSPECTORS-GENERAL.

DRESS AND UNDRRESS.

The same uniforms and appointments as Captains, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Epaulettes.—To have a crown on the strap, and a star placed within the crescent, omitting the anchor.

STAFF SURGEONS.

DRESS AND UNDRRESS.

The same uniform and appointments as Captains under three years, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Epaulettes.—To have a crown only placed within the crescent.

SURGEONS.

DRESS AND UNDRRESS.

The same uniforms and appointments as Commanders, with the following exceptions :—

Coat.—Nine buttons to be placed on the breast, worn by threes.

Epaulettes.—To have a star only placed within the crescent.

ASSISTANT-SURGEONS OF SIX YEARS' SERVICE ON FULL PAY.

DRESS AND UNDRRESS.

The same uniforms and appointments as Lieutenants, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Epaulettes.—The anchor to be omitted.

ASSISTANT-SURGEONS.

DRESS AND UNDRRESS.

The same uniform and appointments as Mates, with the following exceptions :—

Coat.—Nine buttons to be worn on the breast, placed by threes.

Shoulder Straps.—Omitting the anchor.

SECRETARIES TO COMMANDER-IN-CHIEF.

DRESS AND UNDRRESS UNIFORM.

The same uniform and appointments as Commanders, with the exceptions specified above for the Civil Branches ;—and

The Coat.—Eight buttons on the breast by pairs.

The Epaulettes.—To have an embroidered gold and silver star within the crescent.

The Hat.—To have the loop of half-inch gold lace instead of bullion, and flat tassels.

SECRETARIES TO JUNIOR FLAG OFFICERS.

DRESS UNIFORM.

The same as Secretaries to Commanders-in-Chief, with the following exceptions :—

Coat.—The lace to be only one inch wide, instead of one inch and a half, and half an inch,

instead of three quarters of an inch, with one row of distinction lace round sleeves.

Epaulettes.—The same size as Lieutenants, with silver edging to the straps and crescent as above, but without the devices thereon.

Belt.—The same as Lieutenants.

Hat.—The same as Secretaries to Commanders-in-Chief, but with a single loop of gold lace.

Or Secretaries to Flag Officers may wear the uniform of the rank they hold.

UNDRESS UNIFORM.

The same as Secretaries to Commanders-in-Chief, with one row of distinction lace round sleeves.

Epaulettes.—The same as in dress.

Hat.—The same.

Belt.—The same as Lieutenants.

Or Secretaries to Flag Officers may wear the undress uniform of the rank they hold.

PAYMASTERS.

DRESS AND UNDRESS UNIFORM.

The same as Secretaries to Junior Flag Officers.

NAVAL INSTRUCTORS.

Naval Instructors are not required to wear any uniform whatever; but if they do, it is to be the following :—

DRESS AND UNDRESS UNIFORM.

Unless in Holy Orders, the same as Secretaries to Junior Flag Officers, except that the eight buttons on the breast of the coat are to be placed at equal distances, and without epaulettes or lace to the trowsers.

ASSISTANT PAYMASTERS.

DRESS UNIFORM.

The same as Paymasters, with the following exceptions :—

Coat.—The lace to be only three-quarters of an inch wide, and one row of a quarter of an inch gold braid round the sleeves.

Trowsers.—To have no lace.

Epaulettes.—Two shoulder straps, the same as Mates, without the device, but with silver edging to the straps and crescents.

UNDRESS UNIFORM.

The same as Paymasters, except one row of quarter of an inch gold braid round sleeves of coats instead of lace.

Epaulettes.—The same as in dress.

CLERKS.

DRESS AND UNDRESS UNIFORM.

The same as the undress uniform of the Assistant Paymasters, but without the shoulder strap.

Hat.—Cap only; no sword.

ASSISTANT CLERKS.

The undress uniform of Clerks, omitting the gold braid round sleeves of coats.

INSPECTOR OF MACHINERY.

DRESS AND UNDRESS UNIFORM.

The same uniform as Secretaries to Commander-in-Chief, except that the coat is to have eight buttons on the breast, placed by fours.

Epaulettes.—To have a gold anchor within the crescent, surmounted by a gold star.

CHIEF ENGINEERS.

DRESS AND UNDRESS UNIFORM.

The same uniform as Secretaries to Junior Flag Officers, except that the coats are to have eight buttons on the breast, placed by fours.

ASSISTANT ENGINEERS—FIRST CLASS.

DRESS AND UNDRESS UNIFORM.

The same as Assistant Paymasters, except that the coats are to have eight buttons on the breast, placed by fours; and to wear the uniform cap instead of the cocked hat.

Swords.—Of the Regulation pattern.

ASSISTANT ENGINEERS—SECOND CLASS.

DRESS AND UNDRESS UNIFORM.

The undress uniform of Assistant Engineers of First Class.

Caps.—Same as First Class; no sword or dirk.

ASSISTANT ENGINEERS—THIRD CLASS.

DRESS AND UNDRESS UNIFORM.

The same as the Second Class, omitting the gold braid round the sleeves of coats.

Caps.—The same as First Class; no sword or dirk.

MEMORANDA.

Full dress is to be worn only on State occasions.

The undress coat, with epaulettes, cocked hat and sword, are to be worn at Courts-Martial.

On all special duties, such as Medical Surveys, examination of Candidates, &c., as well as upon ordinary occasions of duty, frock coat, with the cap and sword, is to be considered sufficient dress.

Trowsers.—On all occasions of full dress officers shall wear white trowsers, over boots, between the 1st May and 30th September, and blue trowsers between the 1st October and the 30th April.

Great Coats.—The great coats for Officers are to be of blue cloth, double breasted, with the number and arrangement of buttons according to the undress uniform assigned to their respective ranks, omitting the pocket flaps; with padded turn-down collar, and with the rows of lace or braid round the sleeves the same as the undress coats.

All Officers, except Midshipmen, Masters' Assistants, Clerks' Assistants, Cadets, and Warrant Officers, may wear a blue frock, made according to the directions given above for great coats, with the same distinctions of lace or braid on the sleeves.

Admirals and Commodores of the First Class may wear epaulettes with their frock and great coats, and on such occasions the cocked hat and sword must also be worn.

Jackets.—All Officers may wear *on board their ship*, a round jacket, without skirts, with their respective arrangement of buttons and distinction lace, double breasted for the Military Branch, except Midshipmen, Masters' Assistants, and Cadets, who are to wear single breasted jackets, the same as the Civil Branch.

Caps,—are to be of blue cloth, the diameter of the top to be eight inches, with a black mohair band $1\frac{1}{2}$ inch wide. Admirals and Commodores of the First Class, and Officers of the Civil Branches ranking with them, to have the peak embroidered all round in Gold; Commodores of the Second Class, Captains and Commanders, and Officers of the Civil Branches ranking with them, the peak embroidered on the front edge only; and all other Officers a plain peak.

The Military Branch to be distinguished by the embroidery on the peak, which is to be of oak leaves, and a device placed in the front of the cap, consisting of a crown embroidered in gold and silver, and a silver anchor surrounded by gold laurel wreaths.

The Civil Branches by plain embroidery, and the same device embroidered in gold. The peaks of all caps not embroidered to be of patent leather; when embroidered, to be of blue cloth bound with patent leather.

Round Hats.—Officers, during bad weather, when on board their ships, may wear a round black hat, with a narrow black band and buckle, and a black silk or leather cockade, with a loop of gold lace half the width of the broad lace on their dress coats, or, if they have no lace on their coats, of black silk ribbon. Midshipmen, Masters' Assistants, and those ranking with them and Cadets, to have a loop of gold twist.

Belt.—The sword belt to be worn over the coat.

The new Regulations may be adopted at once by Officers requiring uniforms, and they are to come into full force after 1st January 1861.

My Lords desire that the Commander-in-Chief, and the Captains of Her Majesty's ships, will prevent any Officer serving under their command from deviating in any way whatever from the foregoing Regulations.
