SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Twelfth Day of January Righteen-hundred and Sixty-one Years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of Her Majesty's Reign, Chapter Eighty-three, intituled an Act to make Provision for the better Government and Discipline of the Universities of Scot-\* Land, and improving and regulating the Course of Study therein; and for the Union of the two Universities and Colleges of Aberdeen, the Commissioners under the said Act are empowered, inter alia, subject to the Provisions thereof, to regulate by Ordinance the Powers, Jurisdictions, and Privileges of Professors, and all other Members or Office-Bearers in the several Universities of Scotland, as also of the Senatus Academicus and their Meetings: the Commissioners statute and ordain, with reference to the University of Aberdeen, as follows :-

I. The Order of Precedence among the several Professors in the University of Aberdeen shall be regulated according to Seniority of Appointment as Professor, whether such Appointment shall have originally been made in King's College, or in Marischal College, or in the University of Aberdeen; and, in the Case of Two or more Appointments being of the same Date, the Order of Precedence shall be regulated according to the Order in which the Professorships are named in the Eighteenth Section of the said Act.

II. In the Absence of the Principal at any Meeting of the Senatus Academicus, the Professor present, who is first in the Order of Precedence hereinabove provided, shall preside, with a deliberative and a casting Vote.

SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Twenty-sixth Day of January Eighteen Hundred and Sixty-one Years.

HEREAS, by an Act passed in the Twenty-Majesty's Reign, Chapter Eighty-three, intituled, General, No. 3. 'An Act to make Provision for the better Government and Discipline of the Universities of Scot-'land, and improving and regulating the Course of Study therein; and for the Union of the Two 'Universities and Colleges of Aberdeen,' the Commissioners under the said Act are empowered, inter alia, to make Rules for the Management and Ordering of the several Universities of Scotland, the Manner and Conditions in and under which Students shall be admitted thereto, the Course of Study and Manner of Teaching therein, the Manner of Examination, with the Qualifications, Appointment and Number of Examiners, and the Amount and Manner of their Remuneration, the granting of Degrees, whether in Arts, Divinity, Law, or Medi-cine, and to provide that, in so far as shall be practicable, and, in the Opinion of the Commissioners, conducive to the Well-being of the Universities, and to the Advancement of Learning, the Course of Study, the Manner of Examination, and the Conditions under which Degrees are to be conferred, shall be uniform in all the Universities of Scotland; and whereas the Commissioners of Her Majesty's Treasury are empowered by the same Act to pay out of such Moneys as may be provided by Parliament for the Purpose, such Sums of Money as the Commissioners under the Act shall recommend to be paid for, among other Purposes, that of providing Remuneration to the Examiners appointed in pursuance thereof: the Commissioners under the said Act statute and ordain, with reference to the granting of Degrees in Arts in each of the said Universities, as follows:--

 The Course of Study necessary for the Degree of Master of Arts shall extend over Four Winter Sessions, and shall include Attendance for not less than Two Sessions on the Classes of Humanity, Greek, and Mathematics respectively; and Attendance for not less than One Session on the pages of Logic, Moral Philosophy, and Natural Philosophy respectively; and also Attendance on English Literature, for which each Literature

shall make due Provision: Provided always; that, more than One Winter Session; but it shall be in any Student, who, at the Time of his Entrance to the University, shall satisfy the Professors in the Faculty of Arts, on Examination, that he is qualified to attend the higher Classes of Latin, Greek, and Mathematics, or any of them, shall be admitted to such higher Class or Classes, as the Case-may be, without baving previously attended the First or Junior Class or Classes in the same Department or Departments: Provided also, that, where a Student has been admitted to the higher Classes both of Latin and Greek, without having previously attended the First or Junior Latin and Greek Classes, his Course of Study for the Degree of Master of Arts may be completed within Three Winter Sessions, instead of Four.

II. In pursuing the Course of Study for the Degree of Master of Arts, no Student shall be permitted to pass from the Junior to a higher Class in any Department, unless the Professor shall be satisfied of his Fitness to enter the higher

III. Examinations for the Degree of Master of Arts shall take Place, in each University annually, at such convenient Time, after the Close of the Winter Session, as the Senatus Academicus shall from Time to Time appoint; with Power to each University to appoint Examinations to take Place at such other Time or Times as may be convenient.

IV. Candidates for the Degree of Master of Arts shall be examined on the Subjects of Instruction embraced in the Course of Study above prescribed; and the Examinations may be conducted partly in Writing and partly vivá Voce.

V. Any Student, who has completed his Attendance on the Latin and Greek Classes required in the prescribed Course of Study, may be examined on these Subjects at any Examination for Degrees, although he has not completed his Attendance on the other Classes of the prescribed Course; and, in like Manner, any Student, who has completed the Attendance required in the prescribed Course of Study on the Classes of Logic and Moral Philosophy and Course of English Literature, may be examined on these Subjects at any Examination for Degrees, although he has not completed his Attendance on the other Classes of the prescribed Course; and also, in like Manner, any Student, who has completed the Attendance required in the prescribed Course of Study on the Classes of Mathematics and Natural Philosophy, may be examined on these Subjects at any Examination for Degrees, although he has not completed his Attendance on the other Classes of the prescribed Course; and, if such Student shall satisfy the Examiners, when so examined in Latin and Greek, or in Logic, Moral Philosophy, and English Literature, or in Mathematics and Natural Philosophy; he shall receive from them a Certificate to that Effect, and he shall not be again examined on the same Subjects, as a Condition of his taking the Degree of Master of Arts.

VI. Students, who have passed satisfactorily an Examination or Examinations on the several Subjects embraced in the prescribed Course of Study, shall be entitled forthwith to receive the Degree of Master of Arts without Honours; but they may, before taking a Degree, offer themselves for a farther Examination with a View to Graduation with Honours: Provided always that no Person shall be admitted to Examination for Honours, after he thas ceased to be a Matriculated Student in Attendance on a Class or Classes in the University, for

the Power of the Senatus Academicus in particular Cases, on the Ground of ill Health or other mficient Cause, to dispense, so far as may be necessary, with this Regulation.

VII. There shall be Four Departments, in any One or more of which Candidates for Graduation with Honours may offer themselves for Examina-tion, viz:—(1) Classical Literature; (2) Mental Philosophy, including Logic, Metaphysics, and Moral Philosophy; (3) Mathematics, including pure Mathematics and Natural Philosophy; and (4) Natural Science, including Geology, Zoology, and Chemistry.

III. In each of the first Three of the above mentioned Departments, viz., in Classical Literature, in Mental Philosophy, and in Mathematics, there shall be Two Grades of Honour, each representing, as nearly as may be, a uniform Standard of Qualification, to be denominated respectively the First Class and the Second Class; but in the Department of Natural Science there shall be One Class of Honours only; and the Examiners shall determine, with reference to each Candidate for Honours, whether he is entitled to any honourable Distinction, and, if so, whether, in regard to each of the first Three Departments, he has attained the Standard of the First, or only of the Second Class; and the Names of the Candidates entitled to Honours in each Class, in the several Departments, shall be arranged in alphabetical Order.

IX. The Examiners for Graduation without Honours in each University shall be the Professors whose Classes are embraced in the prescribed Course of Study, and, in Addition, three Persons, not being Professors or Assistant Professors in any Scottish University, to be appointed by the University Court, and in the Appointment of whom Regard shall be had to their Eminence in Classical Literature, Mental Philosophy, and Mathematical Science.

X. Of the Three Examiners first appointed by the University Court in each University, One shall be appointed for the Term of Two Years, another for the Term of Three Years, and the Third for the Term of Four Years; and thereafter, every additional Examiner shall be appointed for a Term of Three Years: Provided that the Appointment of any Examiner, during the Currency of his Term of Office, to a Professorship or Assistant Professorship in any Scottish University, shall be held to vacate his Office of Examiner. Provided also, that, in the Event of a Vacancy in the Office of an Examiner occurring otherwise than by Expiration of his Term of Office, the Examiner, to be appointed by the University Court in his Room, shall be appointed for the Remainder of such Term

XI. No Person who has been appointed to the Office of Examiner for the Period of Three Years or Four Years, shall be eligible for Re-appointment to the Office of Examiner in the same University, until he has ceased to hold the Office of Examiner in such University for not less than One Year. 🔸

XII. The Examiners for Graduation Honours shall be the same Professors and additional Examiners, as for Graduation without Honours; and, in the Examination of Candidates for Honours in the Department of Natural Science, there shall be added the Professors of Natural History and of Chemistry, and the University Court may, if they think fit, appoint an additional Examiner, skilled in Natural Science, not being a Professor or Assistant Professor in any Scottish University.

XIV. With the Exception of the additional Examiner in Natural Science, each of the Exami-sors to be appointed by the University Court, shall, for each full Period of a Year in which he shall not as Examiner, receive, in the Case of the Universities of Glasgow, Aberdeen, and Edinburgh, a Sum of Eighty Pounds, and in the Case of the University of St Andrew's, a Sum of Fifty Pounds, to be annually voted by Parliament; and, where an additional Examiner in Natural Science is appointed, he shall receive, from the General Funds of the University, such Remuneration as the Senatus Aradomicus, with the Approval of the University Court, shall appoint.

XV. The first Aradom of Ordinance, No. 12,

Pessens who have Case be conferred, except on Persons who have complied with the Conditions hereinbefore set forth, and shall in no Case be conferred honoris caused tantum; and the Degree of Bachelor of Arts shall not hereafter be conferred.

..XVII. The Provisions of this Ordinance shall come into Operation, in each University, at the Commencement of the Winter Session next after the Approval thereof by Her Majesty in Council.

XVIII. Every Student, who, at the Time when this Ordinance shall come into Operation, shall have completed a Part of his Course, with a View to Graduation in Arts in any of the said Universities, under Regulations in Force at the Time in such University, and shall thereafter complete his Course of Study in Conformity with such Regulations, may become a Candidate for the Degree of Master of Arts, without complying with the Provisions of this Ordinance regarding the Course of Study for that Degree, provided he pass the Examination or Examinations required by this Ordinance.

#### ROYAL WABRANT GRANTING DELHI PRIZE MONEY.

VICTORIA R.

VICTORIA, by the grace of God, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, to all to whom these presents shall come; greeting.

WHEREas it has been represented aunto: IIs. by the Commissioners of Our Treasury, that on the twelfth of May one thousand eight hundred and fifty-seven, an insurrection broke out in the city of Delhi, in the East Indies; that the Indian Garrison and the inhabitants joined the mutiness Indian Troops swhich arrived there from Meernt, and made an insurrection and rebellion, and levied War against Us and Our authority, and forcibly took possession of the said city of Delhi and its dependencies; that a force for the coercion of the mid insurgents and mutineers, and for the capture partir du 20 Janvier dernier, le Soussigné En-voyé Extraordinaire et Ministre Plénipotentiaire distely organised by the then Commander-in-de Sa Majesté le Roi de Santaigne, a Phonneur Chief of Our Forces in India, composed of Our officiellement d'en Informer sea Excellence Lord, troops, and of European and Indian treops of the

on the fourteenth day of September one thousand eight hundred and fifty-seven, the said troops, then under the command of Brigadier-General Wilson, (now Major-General Sir Archdale Wilson, Baronet, Knight Commander of the Most Honourable Military Order of the Bath,) took by assault and storm the said city and the dependencies thereof, and especially the fort of Jhujjur, (then held by the Chief of Jhujjur,) which were subsequently occupied by the said troops; that booty, consisting amongst other things, of crown and other jewels, coin, shawls, arms, elephants, horses, ordnance, and other property, was then captured in the said city and its dependencies, and in the said fort of Jhujjur, which has been since duly sold; and the sale proceeds of which have been realized by the Prize Agents employed for collecting, selling, and realizing the said booty, or have been otherwise realized, or are about to be realized, amounting, or computed to amount to the sum of thirty-five lacs forty-seven thousand nine hundred and seventeen rupees, six annas, and eight pie, or thereabouts: And whereas the sum of eighty-six thousand and seven hundred and four rupees, a portion of the said sum of thirty-five lacs fortyseven thousand and nine hundred and seventeen rupees, six annas, and eight pie, has been claimed by an inhabitant of Delhi, in respect of property taken from him by the Prize Agents, which sum it is expedient at present to withhold from distribution, leaving the sum of thirty-four lacs sixtyone thousand and two hundred and thirteen rupees, six annas, and eight pie, now to be distributed: And whereas it has also been represented unto Us by the said Commissioners of Our Treasury, that four General Officers, videlicet: Major-General Sir Henry Barnard, Knight Commander of the Most Honourable Order of the Bath, (since deceased,) Major-General Reed, Companion of the Most Honourable Order of the Bath, now Lieutenant General Reed, the said Major-General Sir Archdale Wilson, Baronet, Knight Commander of the Most Honourable Military Order of the Bath, and Major-General Military Order of the Bath, and Major-General Penny, (since deceased,) held, for various periods, chief command of the Forces so operating against and besieging and taking the said city of Delhi and its dependencies, and the said fort of Jhujjur: And whereas the said Commissioners of Our Treasury have recommended unto Us to grant the said booty and the proceeds thereof for the use of the Commanders, officers, and men, belonging to the Forces engaged in the said operations against the said city, and its dependencies, and the said fort, in considera-tion of their gallant and meritorious services; which operations began with the action at Ghazeeood-deen-nuggur, on the thirtieth day of May one thousand eight hundred and fifty-seven, and ended with the capturing or taking possession of the said fort of Jhujjur, and to give such directions as to the appropriation and distribution thereof as to Us should seem fit, to which We are graciously pleased to condescend. ROYAL WARRANT GRANTING LUCK-NOW PRIZE MONEY.

VICTORIA R.

VICTORIA, by the grace of God, of the United Kingdom of Great Britain and Ireland, Queen, Defender of the Faith, to all to whom these presents shall come; greeting.

WHEREAS it has been represented unto Us, by the Commissioners of Our Treasury, that in the month of June, in the year one thousand eight hundred and fifty-seven, a rebellion took place within that part of Our East Indian dominions known as "Oude," and theretofore as the "Kingdom of Onde," and that the rebels forcibly took possession of the city of Lucknow therein, and compelled the British Authorities, and Our Troops, and the Troops of the East India Company, to entrench themselves in the Residency at Lucknow, and levied war against Us and Our authority, and besieged and attacked them therein; and that measures having been taken for the relief of the said British Authorities and Troops, a force, under the command of the late Major-General Sir Henry Havelock, Baronet, Knight Commander of the Most Honourable Military Order of the Bath, entered the Residency, and relieved and assisted the troops then there; that afterwards a force—composed of Our Naval and Military Forces, and of European and Indian Troops of the East India Company—was employed against the rebels, under the personal command of Our then Commander-in-Chief of Our Forces in India, General Sir Colin

Clyde, of Lucknew, and that, on the sixteenth of March one thousand eight hundred and fifty-eight, the mid city of Lucknew, and its dependencies, was taken by assault; and booty, consisting of gold, jewels, shawls, dresses, and other property, was captured therein, the sale proceeds of which have been realised by the Prize Agents employed for collecting, selling, and realizing the mid booty, or have been otherwise realized, amounting to, or compated to amount to the sum of fourteen lace seventy-one thousand nine hundred and six rupees, six annas, eleven pie; that, in addition to this amount, a sum of ten thousand seven hundred and thirty-nine rupees has been also realized from the sale of arms, native dresses, and other property, taken by the force under the command of the said late Major-General Sir Henry Havelock, Baronet, Knight Commander of the Most Honourable Military Order of the Bath, during actual hostilities with the said rebels in the said city of Lucknow, making together a total, or estimated total, of fourteen lacs eighty-two thousand six hundred and forty-five rupees, six annas, eleven pie: And whereas Our said Commissioners have recommended unto Us to grant all the said booty for the use of the Commanderin Chief, Officers, and Men belonging to Our Naval and Military Forces, and the European and Indian Troops of the East India Company, which took active part in the operations leading to the aforesaid capture of the said city of Lucknow and its dependencies, including all the troops at first entrenched in the said Residency; the said force under the command of the late Major-General Sir Henry Havelock, Baronet, Knight Commander of the Most Honourable Military Order of the Bath; the force which held Cawnpore during the final operations against Lucknow; and the said force under the personal command of the said Baron Clyde of Lucknow; which took part in the said capture of the said city of Lucknow and its dependencies, or in the operations which contributed thereto; which operations commenced with the first affair at Chinhutt, and the investment of the Residency by the rebels on or about the twentyninth of June one thousand eight hundred and fifty-seven, and ended with the final expulsion of the rebels, and the capture of the said city of Lucknow, on or about the twenty-first of March one thousand eight hundred and fifty-eight, in consideration of their gallant and meritorious services, and to give such directions as to the appropriation and distribution thereof as to Us should seem fit, to which We are graciously pleased to condescend. #### PRESENT.

The QUEEN's Most Excellent Majesty in Council.

Whereas Her Majesty was pleased, on the twenty-third day of January, in the year of our Lord one thousand eight hundred and sixty, by and with the advice of Her Privy Council, to issue a certain Order for the exercise of the power and jurisdiction which Her Majesty has in the dominions of the Tycono of Japan, under and by virtue of an Act of Parliament made and passed in the Session of Parliament holden in the sixth and seventh years of the reign of Her Majesty, intituled "An Act to remove doubts as to the "exercise of Power and Jurisdiction by Her Majesty within divers Countries and Places out "of Her Majesty's Dominions, and to render the "ame more effectual." And whereas it is expedient that the said Order should be amended as bereinafter mentioned. Now, therefore, in pursuance of the above recited Act of Parliament, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:—

I. The seventh and eighth Articles of the said Order of the twenty-third day of January A. D. one thousand eight hundred and sixty, shall be, and the same are hereby revoked and cancelled, save and except as to all acts, matters, and things done under the said seventh and eighth Articles of the said Order, or either of them, or which may hereafter be done under the same, or either of them, by Her Majesty's Consul-General, or by any Consul, Vice-Consul, or Consular Agent in Japan, or by any person duly authorized to act as such, previously to the day next succeeding the day on which this Order shall be received by the Consul-General in Japan.

II. And it is further ordered that any charge against a British subject for a breach of any rules and regulations, other than those relating to the observance of Treaties, be heard and determined by the Consul; and in all cases in which the penalty shall not exceed two hundred dollars or one month's imprisonment, the Consul shall hear and determine the charge summarily, without the aid of assessors; but when the penalty attached to a breach of any rules and regulations, other than those relating to the observance of Treaties, shall amount to more than two hundred dollars, or to imprisonment for more than one month, it shall be obligatory upon the Consul, before he shall proceed to hear the charge, to summon two British subjects of good repute, residing within his district, to sit with him as assessors, which assessors shall however have no authority to decide on the innocence or guilt of the party accused, or on the amount of fine or imprisonment to be awarded to him on conviction; but it shall rest with the Consul to decide on the guilt or innocence of the party accused, and on the amount of fine or imprisonment to be awarded to him : Provided always, that in no case shall the penalty be attached to a breach of rules and regulations, other than those for the observance of Treaties, exceed five hundred dollars, or three months' imprisonment; and provided further, that in the event of the said assessors, or either of them, dissenting from the conviction of the party accused, or from the penalty of fine or impresonment awarded to him by the Consul, the Consul shall take a note of such dissent, with the

grounds thereof, and shall require good and sufficient security for the appearance of the party convicted at a future time, in order to undergo his sentence, or receive his discharge; and the Consul shall, within twenty days, report his decision, with all the particulars of the case, together with the dissent of the assessors, or either of them, and the grounds thereof, to Her Majesty's Envoy Extraordinary and Minister Plenipotentiary and Consul-General in Japan, who shall have authority to confirm, or vary, or reverse the decision of the Consul as to the said Envoy Extraordinary and Minister Plenipotentiary and Consul-General may seem fit: Provided always, that if an appeal shall be entered against the decision of the Consul, no such report shall be made to Her Majesty's Envoy Extraordinary and Minister Plenipotentiary and Consul-General, on the ground of the dissent of the assessors, or either of them, but the appeal shall be prosecuted in the manner hereinafter ordered.

III. And it is further ordered, that in any question relating to the observance of Treaties, or of rules and regulations for the observance of Treaties, or of rules and regulations other than those for the observance of Treaties, a report of any and every decision made by a subordinate Consular Officer, with or without the aid of assessors, shall be sent in by such subordinate Consular Officer to the superior Consular Officer of the district, and that, on the receipt of such report, the superior Consular Officer of such district shall proceed, without assessors, to revise such decision as to him may seem fit, and such revision shall have, for the purposes of the said recited Order, and of this Order, the same effect as if the case had been originally heard and determined by such superior Consular Officer, with or without the aid of assessors: Provided always, that in any case in which the assessors, or either of them, shall dissent from a decision of a subordinate Consular Officer, such decision shall not be subject to revision by the superior Consular Officer; but, in the event of no appeal being entered as aforesaid, shall be submitted to Her Majesty's said Envoy Extraordinary and Minister Plenipotentiary and Consul-General, for revision, in the same manner as if such decision had been originally made by the superior Consular Officer.

IV. Provided always, and it is hereby further ordered, that Her Majesty's said Envoy Extraordinary and Minister Plenipotentiary and Consul-General shall once at least in every year, report to Her Majesty's Principal Secretary of State for Foreign Affairs his decisions on all cases heard and decided by him under and by virtue of this Order, together with the particulars thereof.

V. And it is further ordered, that this Order shall be read and construed with and as a part of the said recited Order of the twenty-third day of January, in the year of our Lord one thousand eight hundred and sixty, which, save as by this Order is otherwise provided, is to remain and continue in full operation and effect in all particulars.

And the Right Honourable Lord John Russell, one of Her Majesty's Principal Secretaries of State is to give the necessary directions herein accordingly.
