## EDINBURGH AND DUNFERMLINE RAILWAY.

(Incorporation of Company : Construction of Railways from Edinburgh to Dunfermline, with Branches and Piers : Crossing Firth of Forth at Queensferry : Arrangement with the North British Railway and other Companies : Purchase of Halbeath Railway : Tolls : and other Purposes.)

**NOTICE** is Hereby Given, That a Bill under the above short title has been introduced into Parliament, and is now in the House of Commons, to incorporate a Company for making and maintaining the following Railways and Works, or some of them, with all necessary conveniences connected therewith ; That is to say—

*First*, A Railway commencing by a Junction with the Edinburgh and Glasgow Railway at a point 720 yards, or thereby, westward of the Bridge which carries the said last mentioned Railway over the Water of Leith, measured along the Line of the said last mentioned Railway, in the Parish of St Cuthbert's, and County of Edinburgh, and terminating at or near to the Pier of Port Edgar, in or adjoining to the Parish of Dalmeny, and County of Linlithgow, which intended Railway and Works will be situated in, or will pass from, in, through, or into the following Parishes and Royal Burgh, or some of them (that is to say), the Parishes of St Cuthbert's, Corstorphine, Cramond, and Kirkliston in the County of Edinburgh ; and the Parishes of Kirkliston, Dalmeny, and South Queensferry, and the Royal Burgh of South Queensferry, in the County of Linlithgow.

*Second*.—A Railway commencing at a point at or near to the east end of Long Craig Island, and 320 yards, or thereby, to the west of the southern end of the Signal-house Pier, near to the town of North Queensferry, in or adjoining to the Parish of Dunfermline, and county of Fife, and terminating by a junction with the Dunfermline Branch of the Edinburgh, Perth, and Dundee Railway, at or near a point 130 yards, or thereby, south-west of the farm-buildings of Sheephousell, in the parish of Dunfermline and county of Fife, which intended Railway and Works will be situated in, or will pass from, in, through, or into, the following parishes and Royal Burghs, or some of them, (that is to say), the parishes of Dunfermline and Inverkeithing and the Royal Burghs of Dunfermline and Inverkeithing—all in the county of Fife.

*Third*.—A Branch Railway commencing from or out of the first-mentioned intended Railway in a field or enclosure lying to the south of Port Edgar aforesaid, and upon the north side of the public road leading from South Queensferry to Linlithgow, at a point 290 yards or thereby, south-east from the southern end of Port Edgar Pier, and 490 yards westward of the junction of the said public road from South Queensferry to Linlithgow with the road leading westwards from South Queensferry along the shore of the Firth of Forth, and terminating at a point at or near the Dundas Limeworks, or the site thereof, about 420 yards westwards from the said southern end of Port Edgar Pier, all in the parish of Dalmeny and county of Linlithgow.

*Fourth*.—A Branch Railway, commencing from or out of the said last-mentioned Branch Railway at or near to a point on the south side of the said public road leading westwards from South Queensferry along the shore aforesaid, at a point 220 yards or thereby to the south-west of the said

southern end of Port-Edgar Pier, and terminating by a junction with the line of railway first hereinbefore described, at or near to the Pier of Port-Edgar—all in the said parish of Dalmeny and county of Linlithgow.

*Fifth*.—A Branch Railway, proceeding out of the Railway second hereinbefore described, at a point 130 yards or thereby, north of the farm-buildings of Grange, and terminating by a junction with the Charleston Railway, at a point 85 yards or thereby south of the point of junction of the Nethertown Branch with the main line of the said Charleston Railway—all within the parish of Dunfermline and county of Fife.

AND with a view to the use and accommodation of a Ferry for the conveyance of traffic across the Firth of Forth, to and from the railways first and second hereinbefore described, power will be taken in the said Bill to make and construct a pier or jetty, over which the Railway first hereinbefore described will be carried, the said pier or jetty commencing at a point at or near to the south end of the pier of Port-Edgar aforesaid, and terminating at a point 418 yards, or thereabouts, to the northward of the south end of the said pier of Port-Edgar, the line or extent of which said pier or jetty will be delineated on the plans to be deposited as hereinafter mentioned, with all necessary Wharfs, Landing-places, and other conveniences on the south side of the said Firth of Forth, in connection with the said intended Railway and Works first hereinbefore described—such pier or jetty, and others aforesaid, to be made in the bed or soil of the said Firth of Forth, in or adjoining to the said parish of Dalmeny, and county of Linlithgow ; as also to make and construct a pier or jetty over which the railway second hereinbefore described will be carried, the said pier or jetty commencing at or near highwater mark on the north shore of the Firth of Forth, at a point about 400 yards westward of the north end of the Signal-house Pier aforesaid, and 100 yards eastward of the house called Craigdhu, near to the town of North Queensferry, and terminating at a point at or near to the east end of Long Craig Island, and 320 yards, or thereby, to the west of the southern end of the Signal-house Pier aforesaid, near to the town of North Queensferry, the line or extent of which said pier or jetty will be delineated on the plans to be deposited as hereinafter mentioned, with all necessary Wharfs, Landing-places, and other conveniences on the North side of the said Firth of Forth in connection with the said intended Railway and Works second hereinbefore described ; such pier or jetty, and others aforesaid, to be made in the bed or soil of the said Firth of Forth, in or adjoining to the Parish of Dunfermline, and County of Fife.

AND power will be taken in the said bill to enable the said Company to purchase, lease, or otherwise acquire from the Trustees of the Queensferry Passage constituted under the Act of Parliament passed in the eleventh year of the reign of his late Majesty King George IV., entitled "An Act for the further improvement and support of the passage across the Firth of Forth, called the Queensferry," and to enable the said Trustees to sell, convey, or lease to the said intended Company, for such price, rent, or consideration in money, or in shares or stock of the intended Company, or other consideration as may be arranged, all or any of the rights, property, and interests which the said Trustees possess in or to the Ferry upon or across the said Firth of Forth, the said Ferry extending and situated within the following limits, (that is to say), from the east side of the East Bat-

tery Pier to the west side of Haughend Pier, on the north side of the said passage, in the Parish of Dunfermline and County of Fife, and from the east side of the Long Craig Pier to the west side of Port Edgar pier, on the south side of the said passage, in the parishes of Dalmeny and South Queensferry, and the Royal Burgh of South Queensferry, in the County of Linlithgow, together with all or any part of the piers, harbours, works, and accesses connected therewith or belonging thereto, and the rights of working the said Ferry, and of taking tolls, rates, and charges therefor; and, if need be, to enable the intended Company to remove or relinquish the said ferry, and to establish and work in lieu thereof another ferry between the respective piers and jetties intended to be constructed at Port Edgar and Long Craig Island as aforesaid, being the respective termini of the Railways first and second hereinbefore described; with power to the intended Company to hold such ferry and works, and by themselves or others to work or use the same, or the said substituted ferry, and levy tolls, rates, and charges in respect thereof; and otherwise if need be, the Bill will contain powers to the intended Company to establish a separate and independent ferry betwixt the piers or jetties to be constructed by them as aforesaid, and to work the same, and to levy tolls, rates, and duties thereat, and will enable the Company to make the necessary rules for the control and government of the said piers or jetties and ferry to be constructed, acquired, or established by them, and for purchasing or hiring vessels for working the said ferry, and to enable the intended Company to lease the ferry and the tolls to be levied thereat.

AND power will be taken in the said Bill to the intended Company to purchase or acquire from, and to the North British Railway Company to sell and convey to the said intended Company, the Railway or Tramway called the Halbeath Railway, commencing at or near to the Halbeath Station of the Dunfermline Branch of the Edinburgh, Perth, and Dundee Railway, in the Parish of Dunfermline and County of Fife, and terminating at the harbour of Inverkeithing, in the Parish and Royal Burgh of Inverkeithing and County of Fife, together with a Branch Railway or Tramway diverging therefrom, at or near to the Village of Guttersgates, and terminating by a junction with the Townhill Railway at or near to the south march of the lands of Whitefield, all in the Parish of Dunfermline and County of Fife, together with the several sidings and lyes, stations, wharfs, loading banks, and other conveniences and works connected therewith, all situated within the said Parishes of Dunfermline and Inverkeithing and Royal Burgh of Inverkeithing, and County of Fife, for such price, or consideration in money, or shares or stock of the intended Company, or such other consideration as may be arranged betwixt these Companies, or as may be fixed by the Bill, and power to the North British Railway Company to transfer and vest in the said intended Company the said Railway, and all the rights and privileges of what kind or nature soever in reference thereto presently vested in the North British Railway Company, on such terms as may be agreed on, and to enable the said intended Company to work and maintain the said Railway, and to levy tolls, rates, and duties on and for the use of the same.

AND NOTICE IS HEREBY ALSO GIVEN, That power will be taken by the said Bill to the proposed Company, for the following among other purposes:—

To deviate in constructing the said intended Railways and piers or jetties, and works, from the

line or lines, and levels delineated on the plans and sections to be deposited as aftermentioned, to such extent as will be defined on the said plans and sections, and be provided by the said Bill.

To cross, alter, divert, and stop up, and to alter the lines, levels, and inclinations of such highways, turnpike, and other roads, railways, streets, paths, passages, rivers, canals, brooks, streams, sewers, waters, water courses, gas and water pipes, and other works, as may be necessary or expedient, for the purpose of making, maintaining, and working the said Railways, and piers or jetties, and works, or any part thereof.

To work and use the said Railways, and piers or jetties, and works, and the said Halbeath Railway, and to convey passengers, goods, and other things, on the said whole Railways, and on other communicating Railways; and also to work and use the said Ferry or Ferries, and to convey by and across the same passengers, goods, and other things, by means of steamboats, and otherwise, and for these and other purposes of the intended Act, to raise money by shares, and by borrowing upon bond or mortgage.

To acquire by compulsory purchase, or otherwise, all such lands, houses, and other heritages, as may be necessary for the purposes of the said Railways, and Piers or Jetties, and works, and all property or rights necessary for the establishment and working of the said Ferry or Ferries; and also to acquire, by compulsory purchase, or otherwise, all lands, heritages, or other property, through, or upon which the said Halbeath Railway passes or is situated, together with all wayleaves, and other rights and privileges affecting the said Halbeath Railway, and to authorise and empower all owners of land, whether persons or corporations, or others holding under entail, or other legal disability to convey, to sell or convey their lands and heritages, or any part thereof necessary for the purposes, aforesaid, to the said intended Company, or for such annual feu-duty, ground-annual, or rent charge, or for such consideration in shares, mortgages, or bonds of the said proposed Company, as may be fixed or agreed on, as the value of such lands and heritages, and to provide that such feu-duty, ground-annual, or rent charge, shall form a preferable lien and burden on the revenues and property of the said intended Company.

To vary or extinguish all existing rights and privileges connected with the lands, houses, and other heritages, so to be acquired, and all such other rights and privileges, including all leases or other terminable rights affecting the said Halbeath Railway, and also the rights of the Ferry hereinbefore described, and of levying tolls thereat, which would in any manner impede or interfere with the construction, maintenance, or use of the said Railways, and Piers or Jetties, and works, or with the use of the said Halbeath Railway, and of the said Ferry; and to confer other rights and privileges in relation to all the matters aforesaid.

To levy tolls, rates, and duties on and for the use of the said intended Railways and works, and of the said Halbeath Railway, and for the conveyance of passengers, goods, and other things thereon, and for the use of the said Piers or Jetties, and for the conveyance of traffic across the said Ferry; and to confer certain exemptions from payment of such tolls, rates, and duties, and certain other rights and privileges in relation thereto.

To empower the North British Railway Company to maintain and manage the said proposed Railways and works, and Piers, and Jetties, the said Ferry, and the said Halbeath Railway, and to work the



traffic thereon, and provide the necessary plant therefor, and to fix, collect, and apportion the tolls, rates, and charges, to be levied in respect of such traffic; as also to empower the said North British Railway Company, and the intended Company, to enter into agreements with each other in relation to the aforesaid matters, or any of them, or otherwise in relation thereto.

To enable the North British Railway Company, by themselves, or others on their behalf, to subscribe and contribute towards the construction, maintenance, and working of the undertaking under the said intended Act, and the said several works hereinbefore described, and to take and hold shares in the said intended Company, and to apply to these purposes any funds which they now have, or may have power to raise; and also, if necessary, to raise additional capital for these purposes, by the creation and issue of new shares or stock in their undertaking, with such guarantee or priority of dividend, or other privileges, if any, as may be thought expedient, or by borrowing on mortgage, or bond, or by one or other of these means, and to enable the North British Railway Company to vote at meetings of, and to appoint directors in the intended Company.

To enable the West of Fife Mineral Railway, and the Charleston Railway Companies, or either of them respectively, by themselves or others on their behalf, to subscribe and contribute towards the undertaking, under the said intended Act, and the several works aforesaid; and to take and hold shares in the said intended Company, and to vote at meetings thereof; and to apply any funds which they respectively now have, or may have power to raise to the said purpose; and also, if necessary, to raise additional capital for these purposes, by the creation and issue of new shares or stock in their respective undertakings, with such guarantee or priority of dividend, or other privileges, if any, as may be found expedient, or by borrowing on mortgage or bond, or by one or other of these means.

To enable the intended Company, and the North British Railway Company, and all persons lawfully using the said intended Railways and works, to run over and use, with their own engines, carriages, and waggons, so much of the North British Railway as is situated betwixt the western extremity of the tunnel under the Calton Hill, and the general or Waverley Bridge Station, both at Edinburgh, and to make use of the separate station of the North British Railway company situated at or near thereto; and also to run over and use so much of the Edinburgh and Glasgow Railway as is situated between the eastern terminus thereof at the said Waverley Bridge Station, and a point two hundred yards to the westward of the Junction of the intended Railway first hereinbefore described, with the said Edinburgh and Glasgow Railway, and also to run over and use the lines of Railway passing through the said Waverley Bridge Station, jointly or respectively belonging to the said North British and Edinburgh and Glasgow Railway Companies, in order that there may be secured to the intended Company and the North British Railway Company, and all persons lawfully using the said intended Railway, a free, continuous, and uninterrupted passage for the working of their traffic between the said intended Railways and the North British Railway, with power also to use the general station, works, and conveniences connected therewith, at Waverley Bridge, Edinburgh, belonging to the North British Railway and Edinburgh and Glasgow Railway Companies, and all other stations, works, and conveniences connected therewith,

situated on the portions of the said Railways to be worked and used as aforesaid, all upon such terms and conditions, and upon payment of such tolls, rates, and charges as may from time to time be agreed upon, or as may be provided by, or under the provisions of, the intended Act, or as shall be settled by arbitration under the said Act; and to alter, limit, or regulate the tolls, rates, and charges now authorised to be levied and demanded by the North British Railway and Edinburgh and Glasgow Railway Companies, for the use of the said Railways, and portions of Railways, Stations, Works, and other conveniences as aforesaid, and to authorise the intended Company, or the North British Railway Company, or all persons using the portions of the said Railways and Works and conveniences as aforesaid, to levy and recover tolls, rates, and duties, and other charges in respect of the use of, and carriage of traffic over and upon the Railways and portions of Railways aforesaid, and to provide for, and require the North British Railway and the Edinburgh and Glasgow Railway Companies, or either of them, to grant facilities for the interchange, transmission, and conveyance of traffic to, from, or over the intended Railways and works, to, from, or over their Railways respectively, or any part thereof.

To enable the intended Company, and the North British Railway, the Edinburgh, Perth, and Dundee Railway, the Edinburgh and Glasgow Railway, the West of Fife Mineral Railway, and the Charleston Railway and Harbour Companies, or any one or more of the five last-named Companies, or the Directors thereof, to enter into agreements with each other in relation to the interchange of the traffic on their respective undertakings, the passage and conveyance of such traffic over the Railways and other works belonging to or worked by them respectively, the use for such traffic of the Stations and other works of such respective Railways, and the tolls, rates, and charges to be levied in respect of such passage, conveyance, and use, and in relation to the reciprocal use, management, maintenance, and working of their undertakings, or any part thereof, and the fixing, collection, and apportionment of such tolls, rates, and charges on the undertakings of the Companies parties to such agreements.

To ratify and confirm all such agreements as may have been already made, or may hereafter be made, by and between the said intended Company or parties acting on their behalf, and the Trustees of the said Ferry, and any of the said Companies, or other persons or corporations, in relation to the objects and purposes set forth in this Notice, or any of them.

AND IT IS INTENDED by the said Bill to empower the Magistrates and Town Council of the Royal Burghs of South Queensferry, Inverkeithing, and Dunfermline, or other party interested, to make and carry into effect such arrangement with the Company to be incorporated by the said Bill, as may be agreed upon in relation to the dues and customs leviable by the said Magistrates and Town Council, or other party, upon goods, cattle, matters, and things passing on the said intended Railways from or into the said Royal Burghs, and to lease such dues and customs to the said Company, or to compound the same for a fixed or annual sum, and to empower the said Company to make and carry into effect such arrangements; and if it shall be so arranged, to empower the said Company to levy and recover the said dues and customs.
