INVESTITURE OF HIS MAJESTY WILLIAM, KING OF PRUSSIA, WITH THE ENSIGNS AND HABIT OF THE MOST NOBLE ORDER OF THE GARTER.

BERLIN, March 7, 1861.

THE QUEEN, Sovereign of the Most Noble Order of the Garter, having been pleased, by a Commission under Her Majesty's Royal Sign Manual and the Great Seal of the Order, to constitute and appoint the Most Honourable John, Marquess of Breadalbane, Knight of the Most Ancient and Most Noble Order of the Thistle, Her Majesty's Envoy Extraordinary on a Special Mission to this Court, and Sir Charles George Young, Knight, Garter King of Arms, to be Her Majesty's Plenipotentiaries for Investing His Majesty William, King of Prussia, with the Ensigns and Habit of that Most Noble Order, They proceeded to this City with their respective Suites, and arrived on the 28th February ultimo.

On the 2d instant the Marquess of Breadalbane was honoured with an audience of His Majesty at the Palace, after which Garter, and the respective Suites, were presented.

The requisite arrangements for the Investiture having been made, His Majesty was pleased to appoint Wednesday the 6th instant for that purpose, on which day, at four o'clock, the several persons appointed to take part in the Ceremony assembled at the residence of the Marquess of Breadalbane, and from thence proceeded to the Royal Palace or Schloss, in the following Order:—

Upon arriving at the Schloss the Mission was received by the Seneschal de Roeder, and conducted to the Grand Apartments, lined by the Garde du Corps, and thence, by the Marshal Comte Puckler, to the Chamber of the Black Eagle (Schwarze Adler Kammer), where it waited until the Grand Master of the Ceremonies, Stillfried, Comte d'Alcantara, and the Grand Marshal of the Court, Comte de Keller, announced the King's readiness for his reception in the Salle Blanche.

The Procession being formed, advanced into the Royal Presence in the following Order:-

Robert Burnet D. Morier, Esq. First Attaché to the Britannic Legation, carrying the Book of Statutes on a Velvet Cushion.

Major-General Lord Frederic Paulet, C.B., carrying the Hat and Star of the Order in like manner. William Lowther, Esq. Secretary to the Britannic Legation, carrying the Sword of the Order in like manner.

Viscount Hinchingbrook, carrying the Collar of the Order in like manner.

Edward Stephen Dendy, Esq. Chester Herald, in his Tabard and Collar of S.S., and bearing the Garter and Riband and George, in like manner.

William Courthope, Esq. Somerset Herald, Secretary to the Commission, in his Tabard and Collar of S.S., and carrying in his hand the Sovereign's Commission.

Sir Charles George Young, Knight, Garter King of Arms, in his Mantle, Chain, and Badge, bearing his Sceptre, and the Sovereign's Letters of Credence. The Honourable Hussey Crespigny Vivian, Secretary to the Special Mission, bearing the Mantle and Cordon of the Order on a Velvet Cushion.

The Most Honourable John, Marquess of Breadalbane, K.T., Her Majesty's Envoy Extraordinary on a Special Mission.

Advancing into the Royal Presence with due reverences, the Mission was received by His Majesty upon His Throne.

On the right of the Throne stood His Royal Highness the Crown Prince, Knight of the Most Noble Order of the Garter, in his Mantle and Collar, and on either side thereof stood the Great Officers of the Court, and Aides-de-Camp of the King.

The Gentlemen bearing the Insignia divided to the right and left, the Plenipotentiaries advancing between them, the Secretary to the Commission, Somerset Herald, remaining near to the Plenipotentiaries to deliver to them the Insignia.

After a short pause, the Marquess of Breadalbane addressed His Majesty, declaring the object of the Mission, to which His Majesty most graciously replied; Garter then delivered to his Lordship the Letters of Credence, which his Lordship presented to the King, who gave the same to Baron de Schleinitz, Minister for Foreign Affairs: The Statutes were in like manner presented, and delivered by His Majesty to Comte de Redern, Grand Seneschal of the Court. The Commission was next presented, and read by the Baron de Schleinitz, when it was returned to Garter. The Garter was next delivered to the Marquess of Breadalbane, who buckled the same round His Majesty's left leg, Garter reading the Admonition. His Majesty was then invested with the Riband and George, Garter reading the Admonition.

The King then delivered his Sword to His Aide-de-Camp, General Alvensleben, which Garter received and retained as an ancient fee appertaining to his office: His Majesty was then invested with the Sword of the Order. His Majesty being then divested of the Riband and George, which was received by the Grand Master of the Wardrobe, Garter presented to the Marquess of Breadalbane the Mantle, with which the Plenipotentiaries invested His Majesty, and immediately afterwards with the Collar of the Order. The Marquess of Breadalbane next presented the Hat, and lastly the Star of the Order.

The Ceremony of Investiture being concluded, the Plenipotentiaries, with their respective Suites, making their reverences, withdrew from the Royal Presence, and were re-conducted to the Schwarze Adler Kammer.

The Ceremony was witnessed by Her Majesty the Queen; their Royal Highnesses the Prince Royal of Prussia; the Prince Charles of Prussia; the Prince Frederic Charles of Prussia; the Prince Albert (son) of Prussia; the Prince George of Prussia; the Prince Adalbert of Prussia; His Highness Prince (Charles Antoine) of Hohenzollern Sigmaringen; their Serene Highnesses the Hereditary Prince of Hohenzollern Sigmaringen and the Prince Charles of Hohenzollern Sigmaringen; their Royal Highnesses the Princess Royal of Prussia; the Princess Charles of Prussia; the Princess Charles of Prussia; the Princess Frederic Charles of Prussia; the Princess Louise of Prussia; the Princess Alexandrine of Prussia; Her Highness the Princes (Charles Antoine) of Hohenzollern Sigmaringen; His Royal Highness the Prince Augustus of Würtemburg; His Highness Prince Louis of Hesse (Grand Ducal); their Serene Highnesses Prince Chrétien of Schleswig Holstein Sonderbourg Augustenbourg; the Prince George of Schwarzbourg Rudolstadt; the Prince Henry XIII de Reuss Schleiz Koestritz; the Prince Henry LXXIV de Reuss Schleiz Koestritz; the Prince Henry LXXIV de Reuss Schleiz Koestritz; the Prince Henry IX de Reuss Schleiz Koestritz; with many other persons of distinction; the Ministers of State; General Officers and Aides-de-Camp of the King; Lord Augustus Loftus, Her Britannic Majesty's Resident Minister at the Court of Berlin, with the Members of the British Legation.

A splendid Banquet was afterwards given, at which The King appeared, wearing the Ensigns of the Order. During the dinner His Majesty drank to the health of the Sovereign, Queen Victoria, and the Marquess of Breadalbane afterwards drank to the health of His Majesty the King of Prussia, Knight of the Most Noble Order of the Garter.

After the Banquet their Majesties held a circle. The Mission, during its residence at Berlin, was honoured with the most marked attention and condescension by their Majesties and the whole of the Royal Family.

Board of Trade, Whitehall, March 15, 1861.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Secretary of State for Foreign Affairs, a copy of a Despatch from Her Majesty's Minister at Berlin, enclosing copies of two Royal Prussian Ordinances; the first decreeing, on behalf of the Rhine-bordering States of Germany, considerable reductions in the dues hitherto levied upon goods ascending or descending the Rhine, known as the "Rhine Dues," such reductions to take effect from the 1st instant; and the second decreeing, on behalf of the States of the Zollverein, the abolition of transit dues in those States.

Hasgow, No. 2 At Edinburgh, the Sixteenth Day of March Eighteen Hundred and Sixty-one Years. HEREAS, by an Act passed in the Twenty-

HEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled, 'An Act to make Provision for 'the better Government and Discipline of the 'Universities of Scotland, and improving and regulating the Course of Study therein; and for the 'Union of the two Universities and Colleges of 'Aberdeen,' the Commissioners under the said Act are empowered, inter alia, to make Rules for the Management and Ordering of the several Universities of Scotland, the Course of Study and Manner of Teaching therein, the Manner of Examination, with the Qualifications, Appointment, and Number of Examiners, and the Amount and Manner of their Remuneration, and the granting of Degrees, whether in Arts, Divinity, Law, or Medicine, in the several Universities of Scotland: the Commissioners statute and ordain with reference to the granting of Degrees in Medicine in the University of Glasgow, as follows:—

- I. The Degrees in Medicine to be hereafter granted by the University of Glasgow shall be divided into Three Classes, and be designated respectively Bachelor of Medicine (M.B.), Master in Surgery (C.M.), and Doctor of Medicine (M.D.).
- II. The preliminary Branches of Extra-Professional Education shall be English, Latin, Arithmetic, the Elements of Mathematics, and the Elements of Mechanics; and the Proficiency of Students in these Branches shall, as far as possible, be ascertained by Examination prior to the Commencement of their Medical Study.
- III. No Candidate shall be admitted to a Professional Examination, who has not passed a satisfactory Examination on at least Two of the following Subjects, in addition to the Subjects mentioned above:—Greek, French, German, Higher Mathematics, Natural Philosophy, Natural History, Logic, Moral Philosophy; and the Examination on these Subjects also shall, as far as possible, take Place before the Candidate has entered on his Medical Curriculum.
- IV. The Examinations in Extra-Professional Education shall be conducted by some of the Examiners in Arts (who may be Professors) together with some of the Medical Examiners.
- V. A Degree in Arts (not being an honorary Degree) of any of the Universities of England, Scotland, and Ireland, and also a Degree in Arts of any Colonial or Foreign University, which may for this Purpose have been specially recognised by the University Court, shall exempt Candidates from all preliminary Examination.
- VI. No one shall be admitted to the Degree of Bachelor of Medicine or Master in Surgery, who has not been engaged in Medical and Surgical Study for Four Years—the Medical Session of each Year, or Annus Medicus, being constituted by at least Two Courses of not less than One hundred Lectures each, or by One such Course, and Two Courses of not less than Fifty Lectures each; but in the case of the Clinical Courses, it shall be sufficient that the Lectures be given at least Twice a Week during the prescribed Periods.
- VII. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery shall give sufficient Evidence by Certificates:—

(1) That he has studied each of the following Departments of Medical Science, viz.:—

ANATOMY,.....CHEMISTRY,MATERIA MEDICA and PHARMACY, INSTITUTES of MEDI-CINE, or PHYSIOLOGY, PRACTICE of MEDICINE, SURGERY, MIDWIFERY, and the DISEASES peculiar to WOMEN and CHILD-REN; Two Courses of Midwifery, of .Three Months each, being reckoned equivalent to a Six Months Course, provided different Departments of Obstetric Medicine be taught in each of the Courses, PATHOLOGICAL ANA-

During Courses including not less than One Hundred Lec-

TOMY, during a Three Months' Course of Lectures, together with a Supplemental Course of Practice of Medicine, or Clinical Medicine; or a Course of not less than One hundred Lectures on General Pathology.

Six Months:

Three Months.

PRACTICAL MID-WIFERY,.... Three Months at a Midwifery Hospital, or a Certificate of Attendance on Six Cases from a Registered Medical Practitioner.

During Courses

During Courses of Six Months, or Two Courses of Three Months; Lectures being given at least Twice a Week.

During Courses including not less than Fifty Lectures.

- (2) That he has attended for at least Two Years the Medical and Surgical Practice of a General Hospital, either at Glasgow or elsewhere, which accommodates not fewer than Eighty Patients, and possesses a distinct Staff of Physicians and Surgeons.
- (3) That he has been engaged for at least Three Months, by Apprenticeship or otherwise, in compounding and dispensing Drugs at the Laboratory of an Hospital, Dispensary, Member of a Surgical College or Faculty, of a Licentiate of the London or Dublin Society of Apothecaries, or of a Member of the Pharmaceutical Society of Great Britain.

(4) That he has attended for at least Six Months, by Apprenticeship or otherwise, the Out-practice of an Hospital, or the Practice of a Dispensary, or of a Physician, Surgeon, or Member of the London or Dublin Society of Apothecaries.

VIII. The Studies of Candidates for the Degrees of Bacholor of Medicine and Master in Surgery shall be subject to the following Regulations:-

(1) One at least of the Four Years of Medical and Surgical Study above required must be in

the University of Glasgow.

(2) Another of such Four Years must be either in the University of Glasgow, or in some other University entitled to give the Degree of Doctor of Medicine.

(3) Attendance during at least Six Winter Months on the Medical or Surgical Practice of a General Hospital, which accommodates at least Eighty Patients, and during the same Period on a Course of Practical Anatomy, may be reckoned as One of such Four Years; and to that extent shall be held equivalent to One Year's Attendance on Courses of Lectures, as hereinbefore prescribed.

(4) One Year's Attendance on the Lectures of Teachers of Medicine in the Hospital Schools of London, or in the School of the College of Surgeons in Dublin, may be reckoned as one of such Four Years; and to that Extent shall be held as Attendance on Courses of Lectures,

as hereinbefore prescribed.

(5) If the University Court shall, at any Time, by Regulation to that Effect, which it is hereby empowered to make, recognise, for the Purpose of Graduation in the University, the Lectures of any private Teacher or Teachers of Medicine, then, and in that Case, Attendance on such Lectures may be reckoned in Place of the Year's Attendance under Subsection (4), or as Part thereof, as the Case may be: Provided always, that no Course of Lectures of a private Teacher on any Subject taught by a Professor of the University shall be recognised, without the Consent of the Chancellor of the University.

(6) Candidates may, to the Extent of Four of the Departments of Medical Study above required, attend in such Year or Years of their Medical and Surgical Studies, as may be most convenient to them, the Lectures of the Teachers of Medicine specified in Sub-sections

(4) and (5).

(7) In the Event of the Lectures of any private Teachers of Medicine being recognised in Terms of Sub-section (5), all Candidates availing themselves of the Permission to attend the Lectures of such Teachers, and not being, at the Time, Matriculated Students of the University, must, at the Commencement of the Year of such Attendance, enrol their Names in a Book to be kept by the University for that Purpose, paying a Fee of one-half the Amount of the Matriculation Fee paid by Students of the University; but they shall not be thereby entitled to any of the Privileges of a Matriculated Student of the University.

(8) The Fee for Attendance on the Lectures of any private Teacher, with a View to Graduation, shall not be of less Amount, than that exigible by Medical Professors of the University for the same Course of Instruction.

(9) No Attendance on Lectures shall be reckoned, if the Teacher gives Instruction in more than One of the prescribed Branches of Study, except in those Cases where Professors of the University are at Liberty to teach more than One Branch.

(10) It shall not be necessary for any private

recognised for the Purpose of Graduation in the University, to obtain a new Recognition from the University Court.

(11) It shall be in the Power of the University Court, if they shall see Cause, at any Time to withdraw or suspend the Recognition of any private Teacher or Teachers,

IX. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery shall lodge with the Clerk of Senate, at such Period of the Year in which he proposes to graduate, as may be fixed for that Purpose by the Senatus Academicus,—

(1) A Declaration, in his own Handwriting, that, on the Day of Graduation, he will have completed his Twenty-first Year, and will not be under Articles of Apprenticeship:

(2) A Statement of his Studies, as well in Literature and Philosophy as in Medicine, accompanied with proper Certificates:

(3) An inaugural Dissertation, composed by himself, to be approved by the Senatus Acade-

X. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery shall be examined, both in Writing and wird Voce,—First, on Chemistry, Botany, and Elementary Anatomy; Secondly, on Advanced Anatomy, Zoology with Comparative Anatomy, Physiology, and Surgery; and, Thirdly, on Materia Medica, General Pathology, Practice of Medicine, Clinical Medicine, Clinical Surgery, Midwifery, and Medical Jurisprudence: the Examinations on Anatomy, Chemistry, Physiology, Botany, and Zoology, to be conducted, as far as possible, by Demonstrations of Objects exhibited to the Candidates; and those on Medicine and Surgery in Part by Clinical Demonstrations.

XI. Students, who profess themselves ready to submit to an Examination on the First Division of these Subjects at the End of the Second Year of their Course, may be admitted to Examination at that Time.

XII. Students, who have passed their Examina-tion on the First Division of these Subjects, may be admitted to Examination on the Second Division at the End of the Third Year of their Course.

XIII. The Examination on the Third Division shall not take Place, until the Candidate has completed the Fourth Year of his Course.

XIV. Candidates may be admitted to Examination on the First Two of these Divisions at the End of their Third Year; or to the Three Examinations at the End of their Fourth Year.

XV. If any Candidate, on Examination, be found unqualified, he shall not be again admitted to Examination, unless he shall have completed another Year of Medical Study, or such Portion of another Year, as may be prescribed by the Examiners when he is found unqualified.

XVI. The Medical Examiners for Graduation in Medicine in the said University shall be the Professors in the Faculty of Medicine therein (including the Professor of Natural History), and, in addition, Three Persons to be appointed annually by the University Court, who shall be selected from among the Fellows of the Three following Bodies, namely, the Royal College of Physicians of Edinburgh, the Royal College of Surgeons of Edinburgh, and the Faculty of Physicians and Surgeons of Glasgow, or shall be Persons otherwise fully qualified in the Judgment of the University Court; such Three Persons to be eligible for Re-election, and each of them to receive, out of Moneys to be provided by Teacher, Attendance on whose Lectures is now Parliament for the Purpose, a Sum of Eighty

Pounds for each full Period of a Year, in which he granting of Degrees in Medicine in the University shall act as Examiner.

XVII. The Degree of Master in Surgery shall not be conferred on any Person, who does not at the same Time obtain the Degree of Bachelor of Medicine.

XVIII. The Degree of Doctor of Medicine may be conferred on any Candidate who has obtained the Degree of Bachelor of Medicine, and is of the Age of Twenty-four Years, and has been engaged, subsequently to his having obtained the Degree of Bachelor of Medicine, for at least Two Years in Attendance on an Hospital, or in the Military or Naval Medical Service, or in Medical and Surgical Practice: Provided always, that the Degree of Doctor of Medicine shall not be conferred on any Person, unless he be a Graduate in Arts within the Fifth Section of this Ordinance, or unless he shall, before or at the Time of his obtaining the Degree of Bachelor of Medicine, or within Three Years thereafter, have passed a satisfactory Examination in Greek, and in Logic or Moral Philosophy, and in One, at least, of the following Subjects, namely, French, German, Higher Mathematics, Natural Philosophy, and Natural History.

IX. The Senatus Academicus shall, from Time to Time, as they think expedient, appoint the Period or Periods of the Year at which Degrees in Medicine shall be conferred.

XX. The Provisions of this Ordinance shall come into Operation at the Commencement of the Winter Session in the University next after the Approval thereof by Her Majesty in Council.

XXI. Candidates, who shall have begun their Medical Studies before the Date at which this Ordinance shall come into Operation, shall be entitled to graduate under the System in force before or after that Date, according as they shall comply with the Regulations in force in the University before or after that Date.

I. The Degrees in Medicine to be hereafter granted by the University of Aberdeen shall be divided into Three Classes, and be designated respectively Bachelor of Medicine (M.B.), Master in Surgery (C.M.), and Doctor of Medicine (M.D.).

II. The preliminary Branches of Extra-Professional Education shall be English, Latin, Arithmetic, the Elements of Mathematics, and the Elements of Mechanics; and the Proficiency of Students in these Branches shall, as far as possible, be ascertained by Examination prior to the Commencement of their Medical Study.

III. No Candidate shall be admitted to a Professional Examination, who has not passed a satisfactory Examination on at least Two of the following Subjects, in addition to the Subjects mentioned above:—Greek, French, German, Higher Mathematics, Natural Philosophy, Natural History, Logic, Moral Philosophy; and the Examination on these Subjects also shall, as far as possible, take Place before the Candidate has entered on his Medical Curriculum.

IV. The Examinations in Extra-Professional Education shall be conducted by some of the Examiners in Arts (who may be Professors), together with some of the Medical Examiners.

V. A Degree in Arts (not being an honorary Degree) of any of the Universities of *England*, Scotland and Ireland, and also a Degree in Arts of any Colonial or Foreign University, which may for this Purpose have been specially recognised by the University Court, shall exempt Candidates from all preliminary Examination.

VI. No one shall be admitted to the Degree of Bachelor of Medicine or Master in Surgery, who has not been engaged in Medical and Surgical Study for Four Years—the Medical Session of each Year, or Annus Medicus, being constituted by at least Two Courses of not less than One hundred Lectures each, or by One such Course and Two Courses of not less than Fifty Lectures each; but in the Case of the Clinical Courses, it shall be sufficient that the Lectures be given at least Twice a Week during the prescribed Periods.

VII. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery shall give sufficient Evidence by Certificates:

(1) That he has studied each of the following Departments of Medical Science, viz. :-

PRACTICE of MEDICINE, SURGERY, MIDWIFERY, and the DISEASES peculiar to WOMEN and CHILD-REN; Two Courses of Midwifery, Three οf each, being Months reckoned equivalent to a Six Months' Course, provided different Departments of Obstetric Medicine be taught in each of the Courses,

During Courses including not less than One Hundred Lectures.

PRACTICAL ANATOMY...Six Months.

PRACTICAL CHEMISTRY, Three Months.

PRACTICAL MID-WIFERY,.....

Three Months at a Midwifery Hospital, or a Certificate of Attendance on Six Cases from a Registered Medical Practitioner.

CLINICAL MEDICINE, CLINICAL SURGERY,... During Courses of Six Months, or Two Courses Three Months; Lec-tures being given at least Twice a Week.

JURISPRU-MEDICAL DENCE, BOTANY,.. ZOOLOGY with COM-1 PARATIVE ANA-TOMY,

During Courses including not less than Fifty Lectures.

(2) That he has attended for at least Two Years the Medical and Surgical Practice of a General Hospital, either at Aberdeen or elsewhere, which accommodates not fewer than Eighty Patients, and possesses a distinct Staff of Physicians and Surgeons.

(3) That he has been engaged for at least Three Months, by Apprenticeship or otherwise, in compounding and dispensing Drugs at the Laboratory of an Hospital, Dispensary, Member of a Surgical College or Faculty, of a Licentiate of the London or Dublin Society of Apothecaries, or of a Member of the Pharmaceutical Society of Great Britain.

(4) That he has attended for at least Six Months, by Apprenticeship or otherwise, the Out-practice of an Hospital, or the Practice of a Dispensary, or of a Physician, Surgeon, or Member of the London or Dublin Society of Apothecaries.

VIII. The Studies of Candidates for the Degrees of Bachelor of Medicine and Master in Surgery shall be subject to the following Regulations:

- (1) One at least of the Four Years of Medical and Surgical Study above required must be in the University of Aberdeen.
- (2) Another of such Four Years must be either in the University of Aberdeen, or in some other University entitled to give the Degree of Doctor of Medicine.
- (3) Attendance during at least Six Winter Months on the Medical or Surgical Practice of a General Hospital, which accommodates at least Eighty Patients, and during the same Period on a course of Practical Anatomy, may be reckoned as One of such Four Years; and to that Extent shall be held equivalent to One Year's Attendance on Courses of Lectures, as hereinbefore prescribed.
- (4) One Year's Attendance on the Lectures of Teachers of Medicine in the Hospital Schools of London, or in the School of the College of Surgeons in Dublin, may be reckoned as one of such Four Years; and to that Extent shall be held as Attendance on Courses of Lectures, as hereinbefore prescribed.
- (5) If the University Court shall, at any Time, by Regulation to that effect, which it is hereby

of Graduation in the University, the Lectures of any private Teacher or Teachers of Medicine, then, and in that Case, Attendance on such Lectures may be reckoned in Place of the Year's Attendance under Sub-section (4), or as Part thereof, as the Case may be: Provided always, that no Course of Lectures of a private Teacher on any Subject taught by a Professor of the University, shall be recognised, without the Consent of the Chancellor of the University.

(6) Candidates may, to the Extent of Four of the Departments of Medical Study above required, attend in such Year or Years of their Medical and Surgical Studies, as may be most convenient to them, the Lectures of the Teachers of Medicine specified in Sub-sections

(4) and (5).

(7) In the Event of the Lectures of any private
Teachers of Medicine being recognised in
terms of Sub-section (5), all Candidates availing themselves of the Permission to attend the Lectures of such Teachers, and not being, at the Time, Matriculated Students of the University, must, at the Commencement of the Year of such Attendance, enrol their Names in a Book to be kept by the University for that Purpose, paying a Fee of one-half the Amount of the Matriculation Fee paid by Students of the University; but they shall not be thereby entitled to any of the Privileges of a Matriculated Student of the University.

(8) The Fee for Attendance on the Lectures of any private Teacher, with a View to Gradua-tion, shall not be of less Amount, than that exigible by Medical Professors of the University for the same Course of Instruction.

(9) No Attendance on Lectures shall be reckoned, if the Teacher gives Instruction in more than One of the prescribed Branches of Study, except in those Cases where Professors of the University are at Liberty to teach more than One Branch.

(10) It shall not be necessary for any private Teacher, Attendance on whose Lectures is now recognised for the Purpose of Graduation in the University, to obtain a new Recognition from the University Court.
(11) It shall be in the Power of the University

Court, if they shall see Cause, at any Time to withdraw or suspend the Recognition of any

private Teacher or Teachers.

IX. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery shall, at such Period of the Year in which he proposes to graduate, as may be fixed for the Purpose by the Senatus Academicus, lodge with the Dean of the Faculty of Medicine, or some other Professor appointed by the Senatus,-

(1) A Declaration, in his own Handwriting, that, on the Day of Graduation, he will have com-pleted his Twenty-first Year, and will not be under Articles of Apprenticeship:
(2) A Statement of his Studies, as well in

Literature and Philosophy as in Medicine,

accompanied with proper Certificates:
(3) An inaugural Dissertation, composed by himself, to be approved by the Senatus Academicus.

X. Every Candidate for the Degrees of Bachelor of Medicine and Master in Surgery, shall be examined, both in Writing and viva Voce,—First, on Chemistry, Botany, Elementary Anatomy, and Materia Medica; Secondly, on Advanced Anatomy, empowered to make, recognise, for the Purpose | Zoology with Comparative Anatomy, Physiology, and Surgery; and, Thirdly, on Practice of Medicine, Clinical Medicine, Clinical Surgery, Midwifery, General Pathology, and Medical Jurisprudence: the Examinations on Anatomy, Chemistry, Physiology, Botany, Zoology, and Materia Medica, to be conducted, as far as possible, by Demonstrations of Objects exhibited to the Candidates; and those on Medicine and Surgery in Part by Clinical Demonstrations.

XI. Students, who profess themselves ready to submit to an Examination on the First Division of these Subjects at the End of the Second Year of their Course, may be admitted to Examination at that Time.

XII. Students, who have passed their Examination on the First Division of these Subjects, may be admitted to Examination on the Second Division at the End of the Third Year of their Course.

XIII. The Examination on the Third Division shall not take Place, until the Candidate has completed the Fourth Year of his Course.

XIV. Candidates may be admitted to Examination on the first Two of these Divisions at the End of their Third Year; or to the Three Examinations at the End of their Fourth Year.

XV. If any Candidate, on Examination, be found unqualified, he shall not be again admitted to Examination, unless he shall have completed another Year of Medical Study, or such Portion of another Year, as may be prescribed by the Examiners when he is found unqualified.

XVI. The Medical Examiners for Graduation in Medicine in the said University shall be the Professors in the Faculty of Medicine therein, and, in addition, Three Persons to be appointed annually by the University Court, who shall be selected from among the Fellows of the Three following Bodies, namely, the Royal College of Physicians of Edinburgh, the Royal College of Surgeons of Edinburgh, and the Faculty of Physicians and Surgeons of Glasgow, or shall be Persons otherwise fully qualified in the Judgment of the University Court; such Three Persons to be eligible for Reflection, and each of them to receive out of Moneys to be provided by Parliament for the purpose, a Sum of Sixty Pounds for each full Period of a Year, in which he shall act as Examiner.

XVII. The Degree of Master in Surgery shall not be conferred on any Person, who does not at the same Time obtain the Degree of Bachelor of Medicine.

XVIII. The Degree of Doctor of Medicine may be conferred on any Candidate who has obtained the Degree of Bachelor of Medicine, and is of the Age of Twenty-Four Years, and has been engaged, subsequently to his having obtained the Degree of Bachelor of Medicine, for at least Two Years in Attendance on an Hospital, or in the Military or Naval Medical Service, or in Medical and Surgical Practice: Provided always, that the Degree of Doctor of Medicine shall not be conferred on any Person, unless he be a Graduate in Arts within the Fifth Section of this Ordinance, or unless he shall, before or at the Time of his obtaining the Degree of Bachelor of Medicine, or within Three Years vthereafter, have passed a satisfactory Examination in Greeks and in Logic or Moral Philosophy, and in One, at least, of the following Subjects, namely, French, German, Higher Mathematics, Natural Philosophy, and Natural History.

. XIX. The Senatus Academicus shall, from Time to. Time, as they think expedient, appoint the Period or Periods of the Year at which Degrees in Medicing shall be conferred. XX. The Provisions hereinbefore contained shall come into Operation at the Commencement of the Winter Session in the University next after the Approval of this Ordinance by Her Majesty in Council.

XXI. Candidates, who shall have begun their Medical Studies before the Date at which the aforesaid Provisions shall come into Operation, shall be entitled to graduate under the System in force before or after that Date, according as they shall comply with the Regulations in force in the University before or after that Date.

XXII. So much of the Seventh Section of Ordinance, No. 12, Aberdeen, No. 4, of the Second Day of July Eighteen hundred and Sixty, as relates to the Fees payable for the Degrees of Bachelor of Medicine and Doctor of Medicine, is hereby repealed; and in place of the Fees therein specified, there shall be paid, by each Candidate for the Degree of Bachelor of Medicine, a Fee of Five Guineas in respect of each of the Three Divisions of the Examination on Professional Subjects specified in the Tenth Section of this Ordinance; each such Fee of Five Guineas being payable at the Time at which the Candidate comes forward to be examined in that Division, in respect of which it is payable; and, if the Candidate desires to be admitted to the Degree of Bachelor of Medicine only, he shall not, on Admission thereto, be required to pay any farther Fee in addition to the Fifteen Guineas so paid by him; but, if he desires to be admitted to the Degree of Master in Surgery also, he shall, on being admitted to such Degree, pay a farther Fee of Five Guineas; and every Candidate for the Degree of Doctor of Medicine shall pay, in addition to the Fees paid by him as a Candidate for the Degree of Bachelor of Medicine, a Fee of Five Guineas, exclusive of any Stamp Duty which may for the Time be exigible.

XXIII. The Professor of Natural History in the said University shall be a Professor in the Faculty of Medicine therein, as well as a Professor in the Faculty of Arts.
