The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Scoretary of State for Foreign Affairs, a copy of a Despatch from Major Stokes, the British Commissioner of the European Commission of the Danube, enclosing the subjoined notice, modifying the Provisional Tariff of the 25th July 1860, in favour of vessels which do not profit by the works in the upper part of the Danube.

With reference to the notice (1250) inserted in the London Gazette of the 14th August 1860, the following modification of the "Provisional Tariff of Navigation Dues applicable to the Sulina mouth of the Danube, in execution of Article XVI of the Treaty of Paris of the 30th March 1856," has been adopted by the European Commission of the Danube, to be annexed to Article I of the said Tariff.

Every sailing vessel of more than 30 tons, which shall enter the port of Sulina, and shall there take an board her cargo without ascending the river beyond the said port, shall receive the benefit of a reduction from the dues mentioned in the foregoing table, in consideration of a certain portion of those dues being levied, to cover the expences of works in the river above the port. The tolls thus reduced shall be levied according to the following table :--
