The Speech of the Lords Commissioners to both Houses of Parliament, on Tuesday, August 6,

My Lords and Gentlemen,

WE are commanded by Her Majesty to release V you from further attendance in Parliament, and at the same time to convey to you Her Majesty's acknowledgments for the zeal and assiduity with which you have applied yourselves to the performance of your duties during the Session of Parliament now brought to a close.

Her Majesty commands us to inform you that her relations with Foreign Powers are friendly and satisfactory, and Her Majesty trusts that there is no danger of any disturbance of the peace of

The progress of events in Italy has led to the union of the greater part of that Peninsula in one Monarchy under King Victor Emmanuel. Her Majesty has throughout abstained from any active interference in the transactions which led to this result, and her earnest wish as to these affairs is, that they may be settled in the manner best suited to the welfare and happiness of the Italian

The dissensions which arose some months ago in the United States of North America, have unfortunately assumed the character of open war. Her Majesty, deeply lamenting this calamitous result, has determined, in common with the other Powers of Europe, to preserve a strict Neutrality

between the contending parties.

Her Majesty commands us to inform you that the measures adopted for the restoration of order and tranquillity in Syria, in virtue of Conventions between Her Majesty, the Emperor of Austria, the Emperor of the French, the King of Prussia, the Emperor of Russia, and the Sultan, having accomplished their purpose; the European troops which, in pursuance of those Conventions, were for a time stationed in Syria to co-operate with the troops and authorities of the Sultan, have been withdrawn; and Her Majesty trusts that the arrangements which have been made for the administration of the Districts which had been disturbed will henceforth secure their internal tranquillity.

Her Majesty has seen with satisfaction the rapid improvement in the internal condition of her East Indian territories, and the progress which has been made towards equalizing the Revenue and

Expenditure of that part of her Empire.

Gentlemen of the House of Commons,

Her Majesty commands us to convey to you Her warm acknowledgments for the liberal Supplies which you have granted for the Service of the present year; and Her Majesty has seen with satisfaction that after amply providing for the wants of the Public Service, you have been able to make a sensible diminution in the Taxes levied upon her people.

My Lords and Gentlemen,

Her Majesty commands us to express to you the deep gratification with which she has witnessed the spirit of devoted patriotism which continues to animate her Volunteer Forces; and the admiration with which she has observed their rapid progress

in discipline and military efficiency.

Her Majesty has given her cordial assent to the Act for completing the number of Members of the House of Commons, by allotting the forfeited Seats

of Sudbury and St Albans.

Her Majesty trusts that the Act for improving the Laws relating to Bankruptcy and Insolvency will be productive of important advantages to the Trade and Commerce of her subjects.

Her Majesty has given her ready assent to Acts for consolidating and assimilating the Criminal Law of England and Ireland, and for promoting the

Revision of the Statute Law.

Her Majesty has given her assent to important Acts which she trusts will have the effect of opening more largely employment in the Public Service to the European and Native Inhabitants of India, of improving the means of legislation, of furthering the ends of Justice, and of promoting the content-ment and well-being of all classes of Her Majesty's Indian Subjects.

Her Majesty has assented with pleasure to the Act for the improvement of harbours on the coast of the United Kingdom, and for relieving merchant shipping from passing tolls; and also to the Act for improving the administration of the Law relating

to the relief and the removal of the poor.

Her Majesty trusts that the Act for rendering more easy arrangements connected with the drain BURGI age of land will assist agricultural improvements in ETTE many parts of the United Kingdom.

Her Majesty has gladly given her assent to ship other measures of public usefulness, the result of your labours during the Session now brought to its close.

Her Majesty has observed, with heartfelt matis-ction, the spirit of loyalty, of order, and of a copy of a Despatch from Her Majesty's Minister faction, the spirit of loyalty, of order, and of ebedience to the law, which prevails throughout all her dominions; and she trusts that by wise legis-lation, and a just administration of the law, the continuance of this happy state of things will be

On returning to your respective Counties you will still have important public duties to perform; and Her Majesty fervently prays that the blessing of Almighty God may attend your exertions, and may guide them to the attainment of the objects of Her Majesty's constant solicitude—the welfare and happiness of her people.

Then a Commission for proroguing the Parliament was read.

1. On every letter not exceeding half an ounce in weight, transmitted by the post between the United Kingdom and Penang, Singapore, Hong- the postage thereof shall be paid at the time of the Kong or China, there shall be charged and taken a miferm British rate of one shilling.

- 2. On every letter not exceeding half an ounce a weight, transmitted by the post between Penang, Singapore, Hong-Kong, or China, and any of Her Majesty's Colonies or any Foreign country, through the United Kingdom, there shall be charged and taken a uniform British rate of one shilling for the conveyance of every such letter between Penang, Singapore, Hong-Kong, or China, and any part of the United Kingdom; and for the conveyance of every such letter between the port in the United Kingdom of the departure or arrival of the packet er ship conveying the same and the Colony or Pereign country to or from which the same shall be forwarded, such a further or additional rate of postage as shall from time to time be charged and payable for British postage on letters not exceed-ing half an ounce in weight, posted or delivered at the port in the United Kingdom of the departure or arrival of the packet or ship conveying the ame, and transmitted direct between such port and any such Colony or Foreign country, provided that in all cases where such additional rate includes both inland and sea services, there shall be deducted from the said rate of one shilling the sum of one penny, in respect of the inland conveyance, under this clause, of every such letter sent through the United Kingdom.
- 8. On every letter not exceeding half an ounce in weight, posted in or addressed to Penang, Singapore, Hong-Kong, or China, transmitted by the post between Penang, Singapore, Hong-Kong, or China, and any of Her Majesty's Australian Colonies or New Zealand, without passing through the United Kingdom, there shall be charged and taken a uniform British rate of one shilling.
- 4. On every letter transmitted as is mentioned in this Warrant, exceeding half an ounce in weight, there shall be charged, taken, and paid, progressive and additional rates of postage as follows; that is
 - On every such letter exceeding half an ounce in weight, and not exceeding one ounce in weight, two rates of postage.
 - On every such letter exceeding one ounce, and not exceeding two ounces in weight, four rates of postage.
 - On every such letter exceeding two ounces, and not exceeding three ounces in weight, six rates of postage.
 - On every such letter exceeding three ounces, and not exceeding four ounces in weight, eight rates of postage.
 - And for every ounce in weight above the weight of four ounces, there shall be charged and taken two additional rates of postage; and every fraction of an ounce above the weight of four ounces shall be charged as an additional ounce; and each progressive and additional rate chargeable under this clause, shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding half an cance in weight.
- 6. On any letters posted under this Warrant addressed to China, the postage thereof shall be paid at the time of the same being posted; and if not, every such letter shall be detained and opened, and shall be either returned or given up to the sender thereof.

same being posted; and if any such letter shall be posted without any postage having been paid thereon, every such letter shall be forwarded charged with the amount of the postage to which it would have been liable if the postage had been paid when posted, together with a further and additional rate of postage of one shilling; and if any such letter shall be posted, having thereon or affixed thereto a postage stamp or stamps, the value of which shall be less in amount than the rate of postage to which such letter would be liable under the regulations in force relating thereto, every such letter shall be forwarded charged with the amount of the difference between the value of such stamp or stamps so being thereon or affixed thereto, and the postage to which it would have been liable if the postage had been paid when posted, together with a further and additional rate

of postage of one shilling.
7. Any letter which, under the regulations of this Warrant, shall be forwarded through France, shall be chargeable, in addition to the British postage, to any French transit rate which may be

chargeable thereon.

8. The rates of postage chargeable on letters and packets under the provisions of this Warrant, shall be in lieu of any rates of British postage now

chargeable by law thereon.

9. All letters transmitted by the post under the provisions of this Warrant, shall be subject to the several orders, directions, regulations, and rates of postage respectively contained in a certain Warrant of the Commissioners of Her Majesty's Treasury, under the hands of two of the said Commissioners, bearing date the 19th day of February 1855, relating to redirected rates of postage upon letters and packets which shall be redirected and again forwarded by the post.

10. Nothing in this Warrant contained shall in anywise alter, prejudice, or affect the exemptions and privileges granted by the said recited Act passed in the fourth year of the reign of Her present Majesty, nor in anywise prejudice or affect the privilege which officers, seamen, and soldiers, employed in Her Majesty's Service now by law enjoy, of sending and receiving letters by the post, subject to the regulations and restrictions in respect of the same.

11. The British postage payable under or by virtue of this Warrant shall include any British

colonial postage that may be payable.

12. The term "weight," used in this Warrant, shall mean British weight, and the term "by the post," shall include the conveyance through Egypt; and the several other terms and expressions used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said Act passed in the fourth year of the reign of Her present Majesty.

13. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands, or the hands of any two of them, at any time hereafter alter, repeal, or revoke any of the rates of postage hereby fixed or altered, or any of the orders, directions, regulations, and conditions hereby made, and may make and establish any new or other rates, orders, directions, regulations, and conditions in lieu thereof, and from time to time appoint at what time the rates which may be payable are to be paid.
