THE following Address of Condolence, on the occasion of the death of His Royal Highness The Prince Consort, which has been transmitted to the Right Honourable Sir George Grey, Baronet, Her Majesty's Principal Secretary of State for the Home Department, has been laid before the Queen by Sir George Grey, and has been received very graciously by Her Majesty :-

> Soldiers' Daughters' Home, Hampstead, February 5, 1862.

May it please your Majesty,

We, the President, Vice-Presidents, Lady Patronesses, and General Committee of the Soldiers Daughters Home, beg leave in this dark day of your Majesty's affliction to offer to your Majesty the expression of our heartfelt sympathy and sorrow, and to assure your Majesty that our prayers are continually addressed to the Throne of Grace that your Majesty may be sustained by a strength which is not your own under the sore trial with which it has been God's will to visit you.

We hesitated long before venturing on this step. fearful lest our doing so might be accounted an act of presumption, but observing how graciously your Majesty has been pleased to receive the Addresses of others, and remembering that he, whose loss the whole Empire deplores, was not only the generous patron of our Home, but most graciously opened the new buildings at Hampstead on the 18th June 1858, we take courage to approach your Majesty and to express for ourselves and the children committed to our charge, the sentiments of loyalty to your throne and devotion to your person, with which we are animated.

It cannot but touch your Majesty's generous heart to know that there is not one among all your Majesty's subjects who does not share your Majesty's

great sorrow as if it were his own. And we hambly trust that, in answer to a Nation's prayer, your Majesty may receive from on high that peace of God which passeth all understanding, and which alone can bring comfort to the widow and the orphan.

WHITEHALL, February 17, 1862.

WHITEHALL, January 28, 1862.

The Queen has been pleased to grant unto Charles Spencer Bateman-Hanbury, of Great Cumberland Place, in the county of Middlesex, Esquire, (commonly called the Honourable Charles Spencer Bateman Hanbury,) one of the Representatives in Parliament for the borough of Leominster, and to Margaret Cuninghame, his wife, eldest daughter and co-heir of John Lennox Kincaid-Lennox, late of Woodhead and Kincaid, in the county of Stirling, Esquire, deceased, and widow of George Augustus Frederick Percy Sydney Smythe, Viscount Strangford, also deceased, Her royal licence and authority that they may, in compliance with directions contained in certain deeds of disposition, entail, and settlement, bearing date respectively the 1st day of August 1828, and the 2d day of March 1849, take and henceforth use the surnames of Kincaid-Lennox in addition to and after those of Bateman-Hanbury, and the designations of Woodhead and Kincaid; and that he, the said Charles Spencer Bateman-Hanbury, may bear the arms of Kincaid and Lennox, quarterly with those of his own family; and that the said surnames and arms may in like manner be borne, taken, and used by the issue of their marriage; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said royal licence and permission to be void and of none effect:

And to command that the said royal concession and declaration be registered in Her Majesty's

College of Arms.

SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Eighth Day of February Eighteen hundred and Sixty-two Years.

WHEREAS, by an Act passed in the Twenty-first and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled, 'An Act to make Provision for the better 'Government and Discipline of the Universities of 'Scotland, and improving and regulating the Course of Study therein; and for the Union of the Two 'Universities and Colleges of Aberdeen,' the Commissioners of Her Majesty's Treasury are empowered to pay, out of such Moneys as may be provided by Parliament for the Purpose, such Sums of Money as the Commissioners under the said Act shall recommend to be paid, inter alia, for providing retiring Allowances to aged and infirm Principals and Professors: The Commissioners under the said Act statute and ordain as follows:—

I. The retiring Allowance to be granted to a Principal or Professor in any of the Universities of Scotland, retiring from his Office on the Ground of Age or Infirmity, shall be as follows; that is to say,

To any Principal or Professor who shall have served for Ten Years and upwards, and under Eleven Years, an annual Allowance equal to Twenty Sixtieths of the annual Salary and Emoluments of his Office:

For Eleven Years, and under Twelve Years, an annual Allowance equal to Twenty-one Sixtieths of such Salary and Emoluments:

And in like Manner a farther Addition to the annual Allowance equal to One-Sixtieth in respect of each additional Year of such Service, until the Completion of a Period of Service of Thirty Years, when an annual Allowance equal to Forty Sixtieths may be granted; and no Addition shall be made in respect of any Service beyond Thirty Years.

- II. In reckoning the Years of Service of a Principal or Professor under this Ordinance, the Years during which he shall have held the Office from which he retires, and also the Years, if any, during which he may have held any other Office of Principal or Professor in the same, or in any other Scottish University, shall be taken into Account.
- III. The annual Salary and Emoluments of a Principal or Professor shall be taken to be the annual Average of the Salary and Emoluments of the Office from which he retires, estimated on a Period of Five Years immediately preceding the Date of Retirement.
- IV. In Cases in which special Circumstances may appear to justify an increased Rate of retiring Allowance, and in Cases in which a Principal or Professor may be disabled by Infirmity or bad Health from performing the Duties of his Office before the Completion of Ten Years' Service, the increased Rate, or retiring Allowance, if any, shall be such as the Commissioners of Her Majesty's Treasury may determine.
- V. The retiring Allowances to aged and infirm Principals and Professors under this Ordinance shall be paid out of such Moneys as may be provided by Parliament for the Purpose.

And that all powers and authorities with respect to county gaols or houses of correction which now are or which may hereafter be vested in any of Her Majesty's Principal Secretaries of State, shall, with respect to all such naval prisons, belong to the Admiralty; and that it shall be lawful for the Admiralty from time to time to make, alter, and repeal regulations for the government of any such naval prison, and of the officers and servants thereof, and of offenders confined therein; and from time to time to appoint inspectors, and all other necessary officers and servants for any such naval prison, and, as occasion may arise, to remove the inspectors, officers, or servants of any such naval prison; and the senior officer at any port or place, or on any station where there may be any such naval prison, or such senior officer and such other person and persons as the Admiralty may from time to time appoint, shall be a visitor or visitors of such prison; and every inspector, visitor, or officer having the charge or command of any such naval prison respectively, shall, subject to such rules and regulations as may from time to time be made as aforesaid, have and exercise, in respect of such prison, and of the officers and servants thereof, and of the prisoners confined therein, all the powers and authorities, as well in respect of ad-
