WHITEHALL, February 8, 1862.

The Queen has been graciously pleased to grant unto William Surtees Cook, Esquire, late Major in Her Majesty's 83d Regiment of Foot, and to Arabella Addams, eldest and only surviving daughter of Jesse Addams, of Marylebone Road, in the county of Middlesex, Doctor of the Civil Law, and one of Her Majesty's Counsel, Her royal licence and authority that they may, from and immediately after the solemnization of their intended marriage, assume and take the surname of Altham, in lieu of that of Cook; that he, the said William Surtees Cook, may bear the arms of Altham quarterly with his own family arms; and that the said surname and arms of Altham may in like manner be taken by his issue; such arms being first duly exemplified according to the laws of arms, and recorded in the Heralds' Office, otherwise the said royal licence and permission to be void and of none effect:

And to command that the said royal concession and declaration be recorded in the College of Arms.
