THE following Address of Condolence, on the occasion of the death of His Royal Highness The Prince Consort, which has been transmitted to the Right Honourable Sir George Grey, Baronet, Her Majesty's Principal Secretary of State for the Home Department, has been laid before the Queen by Sir George Grey, and has been received very graciously by Her Majesty :--

To The QUEEN'S Most Excellent Majesty.

We, the Deputies of the several congregations of Protestant Dissenters of the three denominations, Presbyterian, Independent, and Baptist, in and within twelve miles of London, appointed to protect their civil rights, your Majesty's most loyal subjects, firmly attached to your Majesty's Royal House, desire respectfully to express our deep sympathy with your Majesty, as our beloved Queen, under the severe bereavement with which it has pleased the Almighty Ruler to afflict yourself, and your Royal Family, and all your subjects, in calling away by death from your presence and your councils your most Illustrious Consort.

Although the early departure of his Royal Highness has prevented him from fully enjoying that measure of continually increasing public respect and approbation, which all your Majesty's subjects recognize as due to his pre-eminent virtues and merits; yet, we doubt not, that time will but add to their lustre, and that we, and our children, shall look back on his life as having ennobled all family and social relationships—that he will be regarded as one of the highest of the great men who have left their stamp in the improvement of their age—and that future generations of your Majesty's subjects, in seeing the results of his pious example and his benevolent labours, will perpetuate on him public benediotion.

We earnestly pray that your Majesty may be comforted by faith in Him who is the Resurrection and the Life, and by the blessed hope of the reunion of the faithful in Christ; and that you may long be spared to rejoice, amidst the admiring congratulations of your subjects, in the growth and glory of the seed sown by the hands of your departed Consort.

#### WAR-OFFICE, February 25, 1862.

The Queen has been graciously pleased to signify Her intention to confer the decoration of the Victoria Cross on the undermentioned Officers and Non-Commissioned Officer, whose Claims to the same have been submitted for Her Majesty's approval, on account of Acts of Bravery performed by them in India, as recorded against their several names; viz. :--

Regiment or Corps.	Rank and Name.	Act of Bravery for which recommended.				
Bombay Artillery (now of the Staff Corps)	Major Richard Harte Keatinge Date of Act of Bravery, March 17th, 1858	For having rendered most efficient aid at the assault of Chundairee, in voluntarily leading the Column through the breach, which was protected by a heavy cross fire. He was one of the foremost to enter, and was severely wounded in the breach. The Column was saved from a serious loss that would probably have resulted, but for Major Keatinge's know- ledge of the small path leading across the ditch, which had been examined during the night by himself and a servant, who declined, when re- quired, to lead the Column without his master. Having cleared the breach, he led into the Fort, where he was struck down by another dangerous wound. The Commander-in-Chief in India states that the success at Chundairee was mainly owing to this Officer, whose gallantry, really brilliant, he considers was equalled by his ability and devotion. Major Keatinge was at the time a Political Officer with the 2d Brigade of the Central India Field Force.				
2d Bombay Light Cavalry	Captain James Blair Date of Acts of Bravery, August 12th, and October 23d, 1857	<ul> <li>For having on two occasions distinguished himself by his gallant and daring conduct:</li> <li>1. On the night of the 12th of August 1857, at Neemuch, in volunteering to apprehend 7 or 8 armed mutineers who had shut themselves up for defence in a house, the door of which he burst open. He then rushed in among them, and forced them to escape through the roof; in this encounter he was severely wounded. In spite of his wounds he pursued the fugitives, but was unable to come up with them in consequence of the darkness of the night.</li> <li>2. On the 23d of October 1857, at Jeerum, in fighting his way most gallantly through a body of rebels who had literally surrounded him. After breaking the end of his sword on one of their heads, and receiving a severe sword cut on his right arm, he rejoined his troop. In this wounded condition, and with no other weapon than the hilt of his broken sword, he put himself at the head of his men, charged the rebels most effectually, and dispersed them.</li> </ul>				
Bengal Police Bat- talion	Lientenant Charles George Baker Date of Act of Bravery, September 27th, 1858	For gallant conduct on the occasion of an attack on the rebels at Suhejnee, near Perco, on the 27th September 1858, which is thus described in this Officer's own words. "The enemy" (at the time supposed to have mustered from 900 to 1000 strong in infantry, with 50 cavalry), "advanced. Without exchanging a shot I at "once retired slowly, followed up steadily by "the rebel line for 100 yards clear of village or "jungle, when, suddenly wheeling about my "divisions into line, with a hearty cheer we "charged into and through the centre of the "enemy's line, Lieutenant Broughton, with his "detachment, immediately following up the

From " this moment the pursuit was limited to the " strongest and best horses of the force, num- " bering some 60 of all ranks, who, dashing " into and swimming a deep and wide nullah, " followed the flying enemy through the village " of Russowlee and its sugar-cane khêts, over " two miles of swamp, and 500 yards into the " thick jungles near Peroo, when, both men " and horses being completely exhausted, I " sounded the halt and assembly, and, collecting " my wounded, returned to camp at Munjhaea " about 6 F.M." The charge ended in the ntter defeat of the enemy, and is referred to by Lord Clyde " as deserving of the highest " encomium, on account both of conception and " execution." It is also described as having been as gallant as any during the war.

25th Bombay Light Infantry	Lieutenant William Francis Frederick Waller Date of Act of Bravery, June 20th, 1858.	For great gallantry at the capture by storm of the fortrees of Gwalior, on the 20th June 1858. He and Lieutenant Rose, who was killed, were the only Europeans present, and, with a mere handful of men, they attacked the fortress, climbed on the roof of a house, shot the gunners opposed to them, carried all before them, and took the fort, killing every man in it.				
11th (late 70th) Ben- gal Native Infantry 53d Regiment	Lieutenant John Charles Campbell Daunt Date of Acts of Bravery, October 2d and November 2d, 1857. No. 2165. Serjeant	Lieutenant Daunt and Serjeant Dynon are recommended for conspicuous gallantry in action on the 2d of October 1857, with the mutineers of the Ramgurh Battalion at Chota Behar, in capturing two guns, particularly the last, when they rushed at and captured it by pistolling the gunners, who were mowing the detachment down with grape, one-third of which was hors-de-combat at the time. He was himself subsequently wounded and sent to Agra.</li> <li>Conductor Miller was at the time employed with heavy howitzers and ordnance stores attached to a detachment of troops commanded by the late Colonal Cotton, C.B., in the attack on the above-mentioned date on the rebels who had taken up their positions in the Serai at Futtehpere Sikra, near Agra.</li> </ul>

Indian Navy		Midshipman Arthur Mayo Date of Act of Bravery, November 22, 1857	For having headed the charge on the 22d of November 1857, in the engagement between the Indian Naval Brigade and the mutineers of the 73d Native Infantry and Bengal Artillery, when the former was ordered to charge 2 six-pounders which were keeping up a heavy fire. Mr Mayo was nearly 20 yards in front of any one else during the advance.

#### SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Eighth Day of February Eighteen hundred and Sixty-two Years.

WHEREAS, by an Act passed in the Twentyfirst and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled, 'An Act to make Provision for the better 'Government and Discipline of the Universities of 'Scotland, and improving and regulating the Course 'of Study therein; and for the Union of the Two 'Universities and Colleges of Aberdeen,' the Commissioners of Her Majesty's Treasury are empowered to pay, out of such Moneys as may be provided by Parliament for the Purpose, such Sums of Money as the Commissioners under the said Act shall recommend to be paid, *inter alia*, for providing retiring Allowances to aged and infirm Principals and Professors: The Commissioners under the said Act statute and ordain as follows:--

I. The retiring Allowance to be granted to a Principal or Professor in any of the Universities of Scotland, retiring from his Office on the Ground of Age or Infirmity, shall be as follows; that is to say,

To any Principal or Professor who shall have served for Ten Years and upwards, and under Eleven Years, an annual Allowance equal to Twenty Sixtieths of the annual Salary and Emoluments of his Office :

For Eleven Years, and under Twelve Years, an annual Allowance equal to Twenty-one Sixtieths of such Salary and Emoluments :

And in like Manner a faither Addition to the annual Allowance equal to One-Sixtieth in respect of each additional Year of such Service, until the Completion of a Period of

Service of Thirty Years, when an annual Allowance equal to Forty Sixtieths may be granted; and no Addition shall be made in respect of any Service beyond Thirty Years.

II. In reckoning the Years of Service of a Principal or Professor under this Ordinance, the Years during which he shall have held the Office from which he retires, and also the Years, if any, during which he may have held any other Office of Principal or Professor in the same, or in any other *Scottish* University, shall be taken into Account.


III. The annual Salary and Emoluments of a Principal or Professor shall be taken to be the annual Average of the Salary and Emoluments of the Office from which he retires, estimated on a Period of Five Years immediately preceding the Date of Retirement.

IV. In Cases in which special Circumstances may appear to justify an increased Rate of retiring Allowance, and in Cases in which a Principal or Professor may be disabled by Infirmity or bad Health from performing the Duties of his Office before the Completion of Ten Years' Service, the increased Rate, or retiring Allowance, if any, shall be such as the Commissioners of Her Majesty's Treasury may determine.

V. The retiring Allowances to aged and infirm Principals and Professors under this Ordinance shall be paid out of such Moneys as may be provided by Parliament for the Purpose.

#### TREASURY WARRANT.

WHEREAS by an Act of Parliament passed in the fourth year of the reign of Her present Majesty, for the regulation of the duties of postage, power is given to the Commissioners of Her Majesty's Treasury, from time to time, by Warrant under their hands, to alter and fix any of the rates of British postage, or inland postage, payable by law on the transmission by the post of Foreign or Colonial letters or newspapers, or of any other printed papers, and to subject the same to rates of postage according to the weight thereof, and a scale of weight to be contained in such Warrant, and from time to time, by Warrant as aforesaid, to alter or repeal any such altered rates, and make and establish any new or other rates in lieu thereof, and from time to time, by Warrant as aforesaid, to appoint at what time the rates which may be payable are to be made, and it is provided that the powers thereby given should extend to any in-crease, or reduction, or remission of postage.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury, by an Act passed in the eleventh year of the reign of Her present Majesty, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the post office.

And whereas the Commissioners of Her Majesty's Treasury, by a certain Warrant in writing under their hands, duly made, and bearing date at Whitehall, Treasury-Chambers, the 19th day of July 1852, did direct that certain rates of British postage therein mentioned, should be charged and taken upon the transmission of letters between the United Kingdom and any place in the German Postal Union, and between any Foreign Country through any part of the German Postal Union and any place in the United Kingdom, the said respective letters being conveyed between the United Kingdom and Belgium by packet boat.

And whereas by a certain other Warrant, in writing duly made, and bearing date at Whitehall, Treasury-Chambers, the 27th day of June 1859, after reciting the said hereinbefore revited Warrant of the 19th day of July 1852, and that a Postal Convention had been then recently made and entered into between Her Majesty's Government and the Government of His Majesty the King of Prussia, and that it was expedient that further regulations should be made for the transmission by the post of certain letters in manner therein mentioned, the Commissioners of Her Majesty's Treasury did direct that certain other rates of British postage therein mentioned should be charged and taken upon the transmission of letters between the United Kingdom and certain Foreign Countries therein also mentioned, if such respective letters should be prepaid, the said respective letters being conveyed between the United Kingdom and Belgium by packet boat.

And whereas a further Postal Convention has been lately made and entered into between Her Majesty's Government and the Government of His Majesty the King of Prussia, and it has become expedient by reason thereof to extend the provisions contained in the said recited Warrant of the 29th day of June 1859 to letters transmitted by post between the United Kingdom and Hanover, now chargeable with rates of postage under the said recited Warrant of the 19th day of July 1852, in the manner hereinafter meutioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said two hereinbefore recited Acts, or either of them, and of all other powers enabling us in this behalf, do, by this Warrant, (under the hands of two of us, the said Commissioners, by the authority of the Statute in that case made and provided,) order and direct as follows :--

1. On every letter not exceeding one half of an ounce in weight, posted in the United Kingdom, addressed to any place in the Kingdom of Hanover, and on every letter not exceeding one half of an ounce in weight, posted in the Kingdom of Hanover, addressed to any place in the United Kingdom (the said respective letters being conveyed between the United Kingdom and Belgium by packet boat), there shall be charged and taken, in lieu of any rates of British postage now payable by law on such letters, an uniform rate of British postage of two pence half-penny, if such respective letters be prepaid; and if such respective letters be not prepaid, an uniform rate of British postage of three pence half-penny.

2. And on every letter transmitted as is hereinbefore mentioned, exceeding one half of an ounce in weight, there shall be charged and taken progressive and additional rates of postage, according to the scale of weight and number of rates following; that is to say:---

- On every letter so transmitted, exceeding one half of an ounce in weight, and not exceeding one ounce in weight, two rates of postage :
- On every letter so transmitted, exceeding one ounce, and not exceeding two sunces in weight, four rates of postage :

- On every letter so transmitted, exceeding two ounces, and not exceeding three ounces in weight, six rates of postage :
- And on every letter so transmitted, exceeding three ounces, and not exceeding four oances in weight, eight rates of postage :
- And for every ounce in weight above the weight of four ounces, there shall be charged and taken upon every letter so transmitted two additional rates of postage, and every fraction of an ounce above the weight of four ounces shall be charged as an additional ounce ; and each progressive and additional rate chargeable under this clause shall be estimated and charged at the sum which any such letter would be charged with under this Warrant, if not exceeding one half of an ounce in weight.

3. If any letter shall be posted in the United Kingdom, addressed to the Kingdom of Hanover, or if any letter shall be posted in the Kingdom of Hanover, addressed to the United Kingdom, and the postage paid thereon shall be less in amount than the rate of postage to which such letter would be liable under or by virtue of this Warrant, every such letter shall be forwarded, charged with the amount of the difference between the sum paid for postage thereon, and the rate of postage payable thereon, under or by virtue of this Warrant, as an unpaid letter, after deducting the amount of postage so paid thereon as aforesaid.

4. Nothing herein contained shall be deemed or construed to extend to any letters passing by the post between the United Kingdom and the Kingdom of Hanover, viå France, nor to any letters passing by the post between the United Kingdom and the Kingdom of Hanover, viå Belgium, sent otherwise than in Prussian closed mails, nor to any letters posted in, or addressed to any part of the Kingdom of Hanover, and transmitted by the post between any part of the Kingdom of Hanover and any of Her Majesty's Colonies, or any Foreign Country, through the United Kingdom, nor to any letters transmitted between any Foreign Country, through any part of the Kingdom of Hanover and the United Kingdom, nor to any letters trans-mitted between any Foreign Country, through any part of the Kingdom of Hanover and any of Her Majesty's Colonies or any Foreign Country, through the United Kingdom, and conveyed between the United Kingdom and Belgium by packet boat, all which said respective letters shall be charged and chargeable with the same rates of postage as are now chargeable and payable thereon, and as if this present Warrant had not been made.

5. The terms and expressions used in this Warrant shall be construed to have the like meaning, in all respects, as they would have had if inserted in the said recited Warrant of the 19th day of July 1852.

6. This Warrant shall come into operation on the 1st day of March 1862.

7. The Commissioners for the time being of Her Majesty's Treasury may, by Warrant under their hands, duly made, at any time hereafter alter, repeal, or revoke any of the rates of postage hereby altered, or the regulations hereby made, and may make and establish any new or other rates or regulations in lieu thereof, and from time to time appoint at what time the rates which may be payable are to be paid.
