THE following Address of Condolence, on the occasion of the death of His Royal Highness The Prince Consort, which has been transmitted to the Right Honourable Sir George Grey, Baronet, Her Majesty's Principal Secretary of State for the Home Department, has been laid before the Queen by Sir George Grey, and has been received very graciously by Her Majesty:—

To The QUEEN's Most Excellent Majesty.

Most Gracious Sovereign,

WE, your Majesty's most loyal and dutiful subjects, the President, Vice-Presidents, and Governors of the Royal Berkshire Hospital, in Special Court assembled, desire humbly to lay before your Majesty the expression of our heartfelt sorrow and sympathy in the irreparable loss which your Majesty and the whole Nation have sustained by the deeply lamented death of His Royal Highness the Prince Consort. We feel, in common with all our fellow-subjects, how inadequate any words of ours must be to express the full extent of the loss which the Nation, as well as your Majesty, has to deplore in the removal of so bright an example of domestic virtue, and of wisdom and faithfulness in counsel in every season of public difficulty.

As Governors of the Royal Berkshire Hospital, which from its opening has flourished under your Majesty's most gracious protection and patronage, we have especially to mourn over the loss of His Royal Highness, who condescended for many years to be the Patron of the Institution, and a kind and regular contributor to its funds.

We pray that it may please Almighty God to support and comfort your Majesty in this dark hour of deepest affliction, and to grant to your Majesty for many years the consolation of seeing your Royal children adorning their high station by following the steps of their beloved and lamented Father in the midst of your Majesty's attached and devoted people.

Board of Trade, Whitehall, April 1, 1862.

The Right Honourable the Lords of the Committee of Privy Council for Trade have received, from the Russian Cunsul-General in London, the following copy of a Notice to Mariners, issued by the Department of Foreign Trade at St Petersburg.

From the 13th of May of the present year 1862, it is enjoined to Owners and Captains of vessels arriving at Russian Ports, to have at the stern-post and at the stem of their vessels metal or other marks shewing their draught of water in English or other feet, or in French metres. These marks must be painted in oil, and of a clear colour, so as to be better visible, and in default of the indication of this measure, or in case of a false indication, if the mistake exceed a quarter of this inch to each foot of the real draught of water at the stern-post, Captains and Owners of research will be liable each time to pay a penalty of tex routies silver, per vessel.

SCOTTISH UNIVERSITIES COMMISSION.

Eighteen hundred and Sixty-two Years.

Ordinance, No. 27. A berdeen,

No. 7.

THEREAS, by an Act passed in the Twentyof Her present Majesty, Chapter Eighty-three, intituled, An Act to make Provision for the better 'Government and Discipline of the Universities of Scotland, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of Aberdeen, the Commissioners under the said Act are empowered, inter alia, to make Rules as to the Amount and Exaction of Fees in the several Universities of Scotland; and to make such Provision by Ordinance, as they shall see fit, for the due Preservation, Administration, and Disposal of the whole Property, Funds, Rents, Revenues, and Endowments of or connected with the Universities: And whereas, by their Ordinance, No. 12, Aberdeen, No. 4, of the Second Day of July Eighteen hundred and Sixty, the Commissioners made certain Regulations regarding the Class Fees and Graduation Fees in the University of Aberdeen, which it is expedient to alter and amend, as hereinafter provided; The Commissioners statute and ordain as follows:-

I. So much of the said recited Ordinance of the Second Day of July Eighteen hundred and Sixty, as relates to the Class Fees payable by Students in the Faculty of Arts in the University of Aberdeen, is hereby repealed; and the Class Fees, to be paid for the Future by Students in the said Faculty, shall be the following, viz. :-

1. For the Course of English Literature, a Fee

of One Guinea:

2. For each of the other Classes included in the Course of Study in the Faculty of Arts, a Fee of Three Guineas: Provided always, that it shall be in the Power of the University Court, if it shall think expedient, by general Regulation, at any Time, to fix a lower Fee than Three Guineas, but not being less than Two Guineas, for a Student's Second Session of Attendance and Study under any of the Professors of Humanity, Greek, and Mathematics: Provided also, that, in Case of a Student attending and studying under any of the Professors of Humanity, Greek, and Mathematics, during a Third Session, or attending any of the other Classes included in the Course of Study in the Faculty of Arts during a Second Session, his Attendance during such additional Session shall be on such Terms as to the Amount of Class Fee, or Exemption therefrom, as may be fixed by any general Regulation of the University Court.

II. So much of the said recited Ordinance, as regards the Fee payable for the Degree of Master of Arts, is hereby repealed as to all Persons becoming Candidates for that Degree under Ordinance, No. 14, General, No. 3, of the Twenty-sixth Day of January Eighteen hundred and Sixty-one; and, in Place of the Graduation Fee specified in the said recited Ordinance, there shall be paid by each such Candidate a Fee of One Guinea, in respect of each of the Three Divisions of the Examination for Graduation without Honours, specified in the Fifth Section of Ordinance, No. 14, General, No. 3; each such Fee of One Guinea being payable at the Time at which the Candidate comes forward to be examined in that Division, in respect of which it is College of Arms.

payable; and no farther Fee than the Sum of Three Guineas, as aforesaid, shall be payable by any Candidate in Respect of Examination for, or At Edinburgh, the Thirty-first Day of March Admission to, the said Degree, whether with or without Honours.

> III. No Bursar shall be exempted from Payment of any Fees payable by other Students in the University.

> IV. Each Member of the General Council of the University shall, on being first registered, pay a Fee of Five Shillings, and, on each Fifteenth Day of September thereafter, shall pay an annual Fee of Two Shillings and Sixpence for the Year then next ensuing: Provided always, that, after Payment of the First Registration Fee of Five Shillings, and of all Fees of Two Shillings and Sixpence, which may have become payable by any Member, it shall be lawful for him to compound for all future Pay-ments of the Fee of Two Shillings and Sixpence by a single Payment of One Pound: Provided also, that no Person shall be entitled to act as a Member of the General Council, until he has paid all Fees which may have become due by him.

> V. The Fees paid in Respect of Examination with a View to Graduation in any Faculty, and the Registration Fees of Members of the General Council shall be paid into, and form Part of, the General University Fund, mentioned in the Ninth Section of the said recited Ordinance of the Second Day of July Eighteen hundred and Sixty; and the said General University Fund shall be applicable to defray, among other ordinary current Expenses of the University, the Expenses connected with the Meetings of the Senatus Academicus, of the University Court, and of the General Council.

And to command that the said royal concession and declaration be registered in Her Majesty's CEREMONIAL TO BE OBSERVED AT THE STATE OPENING OF THE INTERNATIONAL EXHIBITION.

THE QUEEN, being anxious to mark Her interest in the success of an undertaking, in promoting which the Prince Consort had taken a most active part, has notified Her wish that the opening of the Exhibition should bear as much as possible the character of a National Ceremony. Her Majesty has therefore been pleased, under the present impossibility of Herself performing that Ceremony, to appoint His Royal Highness the Duke of Cambridge, K.G., His Grace the Archbishop of Canterbury, The Lord High Chancellor, The Earl of Derby, K.G., The Lord Chamberlain, and Viscount Palmerston, K.G., G.C.B., to be Her Representatives to conduct it in Her name.

I. Her Majesty's Ministers and the Royal Commissioners for the Exhibition of 1851 will attend in the procession, and Her Majesty's Commissioners for the Exhibition will invite the Royal and distinguished persons at the head of the respective Foreign Commissions, and the Foreign Ambassadors and Ministers accredited to this Country, to take part in the Ceremony.

II. Her Majesty's Commissioners will seek the co-operation of the Guarantors of the Exhibition, Jurors, Members of both Houses of Parliament, Heads of the Church, Universities, Law, Army, Navy, and Volunteers, and Municipalities, Scientific and Artistic Institutions, the Local and other Committees aiding the Exhibition, etc., in g ving to the State Opening a National character. For such persons there will be a number of reserved seats, but the number is necessarily limited. Whilst desiring to meet the wishes of all, Her Majesty's Commissioners must reserve to themselves full power of dealing with the arrangements according to their discretion. Her Majesty's Commissioners request that gentlemen occupying official reserved seats will appear in Uniform, Official, or Court dress.

III. The Principal Ceremonies will take place under the two Domes and along the whole length of the Nave. The Official reception of Her Majesty's Representatives, and of distinguished visitors taking part in the Ceremonial, will be held in the Central South Court. The Procession will start from this point and proceed to the West Dome. Here will be a Chair of State; and, after a verse of the National Anthem has been sung, an Address will be received. The Procession will then move down the Nave to the East Dome, where the Musical Performance will take place, after which the Procession will return to the Throne at the West Dome, a Prayer will be offered by the Bishop of London, and the Hallelujah Chorus and the National Anthem will be sung. The Opening of the Exhibition will be declared by His Royal Highness The Duke of Cambridge. Military bands will be stationed in the South Central Court.

Whereas by an Act of Parliament passed in the fourth year of the reign of Her Majesty, for the regulation of the duties of postage, certain scales of weight and rates of postage were fixed, and made chargeable and payable upon, for, and in respect of letters, newspapers, parliamentary proceedings, and printed papers, transmitted and forwarded by the post, and various regulations were made for facilitating the transmission of such letters and papers by the post; and by the same Act powers were given to the Commissioners of Her Majesty's Treasury, from time to time, by Warraut under their hands, to alter and fix any of the rates of postage therein mentioned.

And whereas further powers were given to the Commissioners of Her Majesty's Treasury by another Act of Parliament passed in the eleventh year of the reign of Her Majesty, for giving further facilities for the transmission of letters by post, and for the regulating the duties of postage thereon, and for other purposes relating to the Post-office.

And whereas the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in them in and by the said before-mentioned Acts, and of all other powers enabling them in that behalf, did, by a certain Warrant under the hands of them, the said Commissioners, bearing date at Whitehall, Treasury-Chambers, the 16th day of October 1857, (amongst other things) order and direct that all packets consisting of books, publications, or works of literature or art, posted in the United Kingdom, might be transmitted by the post within the United Kingdom, subject to the several rates of postage, and to the several regulations thereinafter contained. And the said Commissioners did further order and direct that, for the purposes of that Warrant, the terms "books, publications, or works of literature or art," should mean and comprise all such articles as in their general character were either literary, or consisted of printed, written, engraved, or lithographed matter (although not strictly literary), including

books (whether printed, written, or plain), publica- [ tions or compilations (whether in print or in manuscript), almanacks, printed or lithographed letters, and such artistic productions as prints, maps (whether on paper, or canvas, or cloth, and whether printed or written), and photographs when not on glass, or in frames containing glass, and any description of paper, parchment, or vellum (whether printed, lithographed, written upon, or plain, or any mixture of the four), together with any binding, mounting, or covering of, upon, or belonging to any such article or production, or any portion thereof, or of or belonging to any paper, parchment, or vellum, and including also any cases or rollers of prints or maps, book markers (whether of paper or otherwise), pencils, pens, or other things usually appertaining to any such articles or productions, paper, parchment, or vellum, or necessary for its safe transmission, which should be sent in the same packet with any such article or production to which they or it should belong. And the said Commissioners did, in and by the said now reciting Warrant, further order and direct that it should be lawful for the Commissioners for the time being of Her Majesty's Treasury, by Warrant duly made, at any time thereafter to alter or repeal any of the rates of postage thereby fixed or altered, or any of the regulations thereby made, and to make and establish any new or other rates of postage, or regulations in lieu thereof, and from time to time to appoint at what time the rates of postage that might be payable were to be paid.

And whereas the Commissioners of Her Majesty's Treasury, in further exercise of the powers vested in them in and by the said before-mentioned Acts, have from time to time, by divers Warrants under their hands, authorized and directed that packets consisting of books, publications, or works of literature or art, and packets consisting of printed papers, might be transmitted by the post to and from the United Kingdom and certain of Her Majesty's Colonies and various Foreign Countries, at certain reduced rates of postage, and under and subject to certain conditions, regulations, and restrictions, in and by the said several Warrants respectively specified and mentioned.

And whereas in and by each of the said lastmentioned Warrants it was ordered and declared that it should be lawful for the Commissioners for the time being of Her Majesty's Treasury, by Warrant duly made, at any time thereafter to alter or repeal any of the rates of postage thereby fixed or altered, or any of the regulations thereby made, and to make and establish any new or other rates of postage or regulations in lieu thereof, and from time to time to appoint at what time the rates of postage that might be payable were to be paid.

And whereas, since the making of the said several Warrauts by the said Commissioners of Her Majesty's Treasury hereinbefore respectively recited and mentioned, divers photographs and prints of an obscene character have been transmitted by the post, under or by virtue of the privilege by such Warrants granted for facilitating the transmission by the post of books, publications, or works of literature or art, and printed papers respectively, and it is expedient to prohibit the sending by the post of any such photographs or prints, and to make regulations for that purpose, in the manner hereinafter mentioned.

Now we, the Commissioners of Her Majesty's Treasury, in exercise of the powers vested in us in and by the said before recited Acts, or either of them, and of all other powers enabling us in this behalf, Do, by this Warrant, under the hands of two of us, the said Commissioners, by the authority

of the Statute in that case made and provided, order and direct as follows:—

1. No packet, consisting of or containing any photographs, drawings, prints, or other contents, which may be obviously of an obscene character, shall be sent by the post either within the United Kingdom, or to or from the United Kingdom or any of Her Majesty's Colonies or any Foreign Country, under, or by virtue, or authority of the said hereinbefore recited Warrant of the 16th day of October 1857, or under, or by virtue, or authority of any or either of the said other Warrants hereinbefore recited, mentioned, or referred to, or under, or by virtue, or authority of any other Warrant heretofore made by the Commissioners of Her Majesty's Treasury, at a reduced rate of postage or otherwise, under, or by virtue, or authority of the regulations made and in force for the transmission by the post of any packets consisting of books, publications, or works of literature or art, or any packets consisting of printed papers, or any or either of them, anything in the said recited Warrant of the 16th day of October 1857, or in any or either of the said other Warrants hereinbefore recited or referred to, or heretofore made by the Commissioners of Her Majesty's Treasury, to the

contrary in anywise notwithstanding.

2. If any question shall arise whether any photograph, drawing, print, or other contents of a packet, which shall have been sent by the post, is obviously of an obscene character, and prohibited from being sent by the post under, or by virtue, or authority of this present Warrant or not, such question shall be referred to the determination of the Postmaster-General, whose decision thereupon

shall be final and conclusive.

3. It shall be lawful for the Commissioners for the time being of Her Majesty's Treasury, by Warrant duly made, at any time hereafter to alter or repeal any of the regulations hereby made, and to make and establish any new or other regulations in lieu thereof.

4. This Warrant shall come into operation on
