THE following Address of Condolence, on the occasion of the death of His Royal Highness The Prince Consort, which has been transmitted to the Right Honourable Sir George Grey, Baronet, Her Majesty's Principal Secretary of State for the Home Department, has been laid before the Queen by Sir George Grey, and has been received very graciously by Her Majesty:—

To The QUEEN's Most Excellent Majesty.

We, your Majesty's faithful subjects, the Archbishop, Bishops, and Clergy of the Province of Canterbury, in Convocation assembled, approach your Majesty with the expressions of our dutiful reverence for your Throne, and our loyal affection for your Royal Person.

We beg to be allowed to assure your Majesty that in the heavy and well-nigh overwhelming sorrow with which God in His inscrutable wisdom has recently visited your Majesty, we have most deeply sympathised with your afflicted heart; and, as it is our special duty to do, have without ceasing offered up for your Majesty and your bereaved family our prayers and intercessions.

By none of all your Majesty's loyal subjects could the pure and virtuous life, and the high and noble character of your Royal Consort, be more valued than it has been by the Spirituality of your realm. Year by year we have thanked God that the Royal Family of our beloved Queen shone before the Nation with so bright a lustre of family virtue; and that he who stood closest to your Majesty showed so conspicuous an example of subjecting the greatest gifts of intellect and of station to the unvarying law of duty. With the whole of a grateful and loyal people we mourn for the Nation's loss and your Majesty's irreparable bereavement.

We pray Him, who only can, to be your support and comforter in these dark hours. We beseech Him to cheer your sadness, through the love of your Royal Family; through the loyal affection of your people; through the remembrance of the past, and the blessed hope of a future reunion, through Christ Jesus our Lord, with these

who have gone before; and, above all, we pray Him, by His own presence, to pour into your wounded heart His peace, which passeth all understanding.

SCOTTISH UNIVERSITIES COMMISSION.

At Edinburgh, the Thirty-first Day of March Eighteen hundred and Sixty-two Years.

ORDINANCE, No. 27. A berdeen,

No. 7.

HEREAS, by an Act passed in the Twentyfirst and Twenty-second Years of the Reign of Her present Majesty, Chapter Eighty-three, intituled, 'An Act to make Provision for the better Government and Discipline of the Universities of Scotland, and improving and regulating the Course of Study therein; and for the Union of the Two Universities and Colleges of Aberdeen, the Commissioners under the said Act are empowered, inter alia, to make Rules as to the Amount and Exaction of Fees in the several Universities of Scotland; and to make such Provision by Ordinance, as they shall see fit, for the due Preservation, Administration, and Disposal of the whole Property, Funds, Rents, Revenues, and Endowments of or connected with the Universities: And whereas, by their Ordinance, No. 12, Aberdeen, No. 4, of the Second Day of July Eighteen hundred and Sixty, the Commissioners made certain Regulations regarding the Class Fees and Graduation Fees in the University of Aberdeen, which it is expedient to alter and amend, as hereinafter provided: The Commissioners statute and ordain as follows :-

I. So much of the said recited Ordinance of the Second Day of July Eighteen hundred and Sixty, as relates to the Class Fees payable by Students in the Faculty of Arts in the University of Aberdeen, is hereby repealed; and the Class Fees, to be paid for the Future by Students in the said Faculty, shall be the following, viz. :-

1. For the Course of English Literature, a Fee

of One Guinea:

2. For each of the other Classes included in the Course of Study in the Faculty of Arts, a Fee of Three Guineas: Provided always, that it shall be in the Power of the University Court, if it shall think expedient, by general Regula-tion, at any Time, to fix a lower Fee than Three Guineas, but not being less than Two Guineas, for a Student's Second Session of Attendance and Study under any of the Professors of Humanity, Greek, and Mathematics: Provided also, that, in Case of a Student attending and studying under any of the Professors of Humanity, Greek, and Mathematics, during a Third Session, or attending any of the other Classes included in the Course of Study in the Faculty of Arts during a Second Session, his Attendance during such additional Session shall be on such Terms as to the Amount of Class Fee, or Exemption therefrom, as may be fixed by any general Regulation of the University Court.

II. So much of the said recited Ordinance, as regards the Fee payable for the Degree of Master of Arts, is hereby repealed as to all Persons becoming Candidates for that Degree under Ordinance, No. 14, General, No. 3, of the Twenty-sixth Day of January Eighteen hundred and Sixty-one; and, in Place of the Graduation Fee specified in the said recited Ordinance, there shall be paid by each such Candidate a Fee of One Guinea, in respect of each of the Three Divisions of the Examination for Graduation without Honours, specified in the Fifth Section of Ordinance, No. 14, General, No. 3; each such Fee of One Guines being payable at the Time at which the Candidate comes forward to be examined in that Division, in respect of which it is Tientsin, on the 26th June 1858.

payable; and no farther Fee than the Sum of Three Guineas, as aforesaid, shall be payable by any Candidate in Respect of Examination for, or Admission to, the said Degree, whether with or without Honours.

III. No Bursar shall be exempted from Payment of any Fees payable by other Students in the University.

IV. Each Member of the General Council of the University shall, on being first registered, pay a Fee of Five Shillings, and, on each Fifteenth Day of September thereafter, shall pay an annual Fee of Two Shillings and Sixpence for the Year then next ensuing: Provided always, that, after Payment of the First Registration Fee of Five Shillings, and of all Fees of Two Shillings and Sixpence, which may have become payable by any Member, it shall be lawful for him to compound for all future Payments of the Fee of Two Shillings and Sixpence by a single Payment of One Pound: Provided also, that no Person shall be entitled to act as a Member of the General Council, until he has paid all Fees which may have become due by him.

V. The Fees paid in Respect of Examination with a View to Graduation in any Faculty, and the Registration Fees of Members of the General Council shall be paid into, and form Part of, the General University Fund, mentioned in the Ninth Section of the said recited Ordinance of the Second Day of July Eighteen hundred and Sixty; and the said General University Fund shall be applicable to defray, among other ordinary current Expenses of the University, the Expenses con-nected with the Meetings of the Senatus Academicus, of the University Court, and of the General

NOTICE.—NAVAL MEDALS FOR CHINA.

Department of the Accountant-General of the Navy, Admiralty, Somerset House, April 4, 1862.

HER Majesty having been graciously pleased to grant a Medal to the Officers, Seamen, and Marines, engaged in the late wars with China, as well as distinctive Clasps for the various successful operations against the enemy, on the dates hereinafter stated.

Notice is hereby given, that the medals and clasps are now ready for issue in this Department, and for which application may be made, either personally or by letter, producing the requisite certificates in support of the claim both for the medal and the clasps.

The periods of service for which the medal is granted are as follows :-

For the first period of the China War.

To the Naval and Marine Forces who took part in the operations in China, from 1st October 1856.

To the date of the signing of the Treaty of

For the second period of the China War.

To the Naval and Marine Forces who took part in the re-commencement of operations against the enemy, from the 1st August 1860.

To the day on which the Treaty of Peace was signed at Pekin, on the 24th October 1860.

CLASPS are awarded for the following distinctive services:-

China, 1842.

To those already in possession of a medal for the China Wars of 1841 and 1842, who have also been engaged in the late wars of 1856 and 1860.

Fatshan, 1857.

To those actually present during the successful operations against the Chinese war junks, which commenced in the Escape Creek on the 25th May, and were finally closed at Fatshan on the 1st June 1857.

Canton, 1857.

To those actually present at Canton on the 28th and 29th December 1857, when that city was bombarded and finally captured.

Taku Forts, 1858.

To those actually engaged in the operations which ceased with the first capture of the Taku Forts on the 20th May 1858, and led to the Treaty of Tientsin.

Taku Forts, 1860.

To those actually present at the capture of the Taku Forts on the 21st August 1860.

Pekin, 1860.

To those actually present before Pekin, the day the gate of that city was given up to the Allied Army; viz.—13th October 1860.
