WHEREAS, in the Act of Uniformity, which established the Liturgy of the Church of England, provision is made for such alterations in the Prayers for the Royal Family as from time to time shall become necessary, and be directed by lawful authority; it is, thereupon, this day ordered in Council, that in the Morning and Evening Prayers, in the Litany, and in all other parts of the Public Service, as well in the occasional offices as in the Book of Common Prayer, where the Royal Family is appointed to be particularly prayed for, the following form and order shall be observed :-

"Albert Edward, Prince of Wales, the Princess " of Wales, and all the Royal Family."

And it is further ordered that no edition of the Common Prayer be from henceforth printed but with this amendment; and that, in the meantime, and until copies of such edition may be had, all Parsons, Vicars, and Curates within this realm do (for the preventing of mistakes), with the pen, correct and amend all such prayers in their Church Books, according to the foregoing direction: And for the better notice hereof, that this Order be forthwith printed and published, and sent to the several parishes; and that the Right Reverend the Bishops do take care that obedience be paid to the same accordingly.

Revolving Light on Cabo de Gata.

THE Minister of Marine at Madrid has given notice, that on and after the 30th day of April 1863, a light will be exhibited from a lighthouse recently erected at Cabo de Gata, on the South Coast of Spain.

The light will be a revolving white light, attaining its greatest brilliancy every half minute. is placed at an elevation of 194 feet above the mean level of the sea, and should be seen in clear weather from a distance of 19 miles.

The illuminating apparatus is dioptric, or by lenses of the second order.

The tower is 60 feet high, white, and rises from the centre of the circular battery of the Castle of Corraletes, which stands on the extremity of the Cape, distant 50 yards from the sea. It is in lat. 36° 43′ 36″ N., long. 2° 14′ 10″ West of Greenwich. At rather more than half a mile S. 5 E. from the lighthouse is a sunken rock with 9 feet water over

Fixed Light at Villaricos.

Also, that on and after the 30th day of April 1863, a light will be exhibited from a lighthouse recently erected at Villaricos, in the province of Almeria

The light will be a fixed white light, placed at an elevation of 63 feet above the mean level of the sea, and should be seen in clear weather at a distance of 9 miles.

The illuminating apparatus is dioptric, or by lenses of the fifth order.

The tower is round, 30 feet high, white, attached to the keeper's dwelling, and stands  $1\frac{1}{2}$  cables from the beach, northward of the Rio Almanzora. It is said to be in lat. 37° 11′ 20″ N., long. 1° 52′ 46″ West of Greenwich, or about 2\frac{3}{4} miles South, 4′ West of that of the Admiralty Charts.

#### Fixed Light at Altea.

The light will be a fixed white light, placed at an elevation of 367 feet above the mean level of the sea, and should be seen in clear weather from a distance of 9 miles.

The tower is round, 28 feet high, white, and attached to the keeper's dwelling. It stands on Albir Point 24 yards S.E. of the tower of Bombarda, at about eleven yards from the sea, in lat. 38° 33′ 30″ N., long. 0° 3′ 58″ West of Greenwich, or about 1′ West of that of the Admiralty Charts

#### ISLAND OF MINORCA.

Fixed Light at Puerto de Ciudadela.

Also, that on and after the 30th day of April 1863, a light will be exhibited from a lighthouse recently erected at Puerto de Ciudadela, at the west end of the island of Minorca.

The light will be a fixed white light, placed at an elevation of 66 feet above the mean level of the sea, and should be seen in clear weather from a distance of 7 miles.

The illuminating apparatus is dioptric, or by lenses of the sixth order.

The tower is slightly conical, 36 feet high, coloured dark grey, surmounted by a white lantern, and rises from the centre of the keeper's dwelling. It stands on Punta Enderrocat, at the west side of entrance to the port, about 6 yards from the sea, in lat. 39° 59′ 45″ N., long. 3° 51′ 45″ East of Greenwich.
