PRESENT.

The QUEEN's Most Excellent Majesty in Council.

THEREAS, by the " Burial Grounds Scotland Act, 1855," it is enacted that it shall be lawful for Her Majesty, from time to time, by Order in Council, upon the Representation of one of Her Principal Secretaries of State that a copy of an Interlocutor of a Sheriff of a County in Scotland, under certain provisions of the said Act, has been received by him, in pursuance thereof to order that no New Burial Ground shall be opened within certain limits specified in such Order, save with the previous approval of one of such Secretaries of State, or (as the case may require) that, after a time mentioned in such Order, Burials within certain limits, or in certain Burial Grounds or Places of Burial, shall be Discontinued wholly, or subject to any qualifications or exceptions mentioned in such Order ; and that such Order in Council shall thereupon have like force and effect as if the same were embodied in the said Act: Provided always, that Notice of such Representation, and of the time when it shall please Her Majesty to order the same to be taken into consideration by the Privy Council, shall be transmitted to the Crown Agent in Edinburgh, and the Sheriff-Clerk of the County in which such Burial Ground is situate, and that the same shall be by them respectively published in the Edinburgh Gazette, and fixed on the doors of the Church of, or in some other conspicuous places within the Parishes affected by such Representation, one month before such Representation is so considered.

And whereas the Right Honourable Sir George Grey, Bart., one of Her Majesty's Principal Secretaries of State, has, under the provisions of the said Act, made a Representation, stating that he has feceived a copy of an Interlocator pronounced by the Sheriff of Dumbarton and Bute, finding that the

Gartshore and James Dalrymple, two Members of the Parochial Board for the Management of the Poor of the Parish of Kirkintilloch, are true, in so far as regards the Burial Ground of that Parish, that the said Burial Ground is dangerous to health, and contrary to decency. And whereas, in the said Representation, it is recommended that an Order of Her Majesty in Council should be issued, directing that Burials should be forthwith Discontinued in the said Burial Ground. And whereas, Notice of the said Representation, and of the time when it pleased Her Majesty to order the same to be taken into consideration by a Committee of the Lords of the Privy Council, has been duly published in the Edinburgh Gazette, and has been fixed as required by the said Act :

Now therefore, Her Majesty, by and with theadvice of Her Privy Council, is pleased to order, and it is hereby ordered, that from and after the 7th day of May next, BURIALS be DISCONTINUED GROUND of The PARISH of in the BURIAL KIRKINTILLOCH.

To The QUEEN's Most Excellent Majesty.

May it please your Majesty,

WE, your Majesty's most dutiful and loyal subjects, the Lieutenant-Governor, Council, Deemsters, and Keys of the Isle of Man, in Tynwald assembled, beg leave to approach your Majesty with the most profound sentiments of duty and respect, to present our heartfelt congratulations ou the auspicious occasion of the marriage of His Royal Highness the Prince of Wales, an event which, in this island, as elsewhere throughout the Empire, has excited the loyalty and sincere affection of your Majesty's subjects.

Whilst the cherished memory of that great and virtuous Prince, your Majesty's Royal Consort, whom it has pleased Almighty God to take unto Himself, will ever be revered, we feel also assured that the influence upon his descendants of his great example, and of his wise counsels, will be shown for generations to come, in the continued increasing prosperity and good government of this great and favoured Nation.
