This day, the Lords being met, a message was sent to the Honourable House of Commons by the Gentleman Usher of the Black Rod, acquainting them that *The Lords, authorized by virtue of a Commission under the Great Seal, signed by Her Majesty, for declaring Her Royal Assent to several Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read;* and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, to declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to

An Act to amend the law relating to Post-Office Savings Banks.

An Act for the protection of certain garden or ornamental grounds in cities and boroughs.

An Act to abolish the office of Secretary of War, and to transfer the duties of that office to one of Her Majesty's Principal Secretaries of State.

An Act for stopping up certain streets, and widening other streets, in the borough of Cambridge.

An Act to enable the Mid-Wales Railway Company to raise a further sum of money.

An Act to grant further powers to the Berks and Hants Extension Railway Company.

An Act for repairing the road from Market Harborough to Loughborough, in the county of Leicester; and for other purposes.

An Act for enabling the London and North-Western and Lancashire and Yorkshire Railway Companies to raise further moneys for the purposes connected with the North Union Railway, and the Preston and Wyre Railway Harbour and Dock, and for other purposes.

An Act for conferring further powers on the South Staffordshire Railway Company with respect to their undertaking; and for other purposes.

An Act to regulate the mode of valuation of certain underground gas-pipes or works in the city of Glasgow, for the purpose of assessments under "The Glasgow Police Act, 1862," in conformity with the provisions of "The General Police and Improvement (Scotland) Act, 1862."

An Act for lighting with gas Leyland and Farington, and other places in the neighbourhood thereof, in Lancashire.

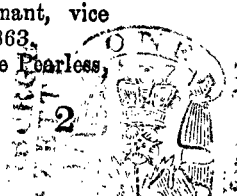
