OTICE is Hereby Given that the Right Honorable Sir George Grey, Baronet, one of Her Majesty's Principal Secretaries of State, has, under the provisions of the 'Burial Grounds '(Scotland) Act, 1855,' made a representation to Her Majesty in Council, stating that he has received a copy of an Interlocutor pronounced by the Sheriff-Substitute of the County of Fife finding that the allegations contained in a Petition of Robert Proctor, Inspector of the Poor of the Parish of Inverkeithing, and of Thomas Law, Chairman of Parochial Board of said Parish, and John Grant, a member of the said Board, are true, to the effect that the Churchyard of the Parish is badly situated as a place of Cemetery; that it, having been used for several centuries, has become overcrowded with corpses, and is dangerous to health, offensive, and contrary to decency; and that a new Cemetery having been provided for the Parish there is no occasion for the old Churchyard being kept open as a Place of Sepulture, excepting under the reservation specified in the Petition, viz., in the cases of husbands or wives of those already buried therein; which representation recommends that Burials be forthwith Discontinued in the said Burial-ground, in the manner referred to in the Interlocutor: And that it has pleased Her Majesty in Council to give notice of such representation, and to order the same to be taken into consideration by a Committee of the Lords of Her Majesty's Most Honorable Privy Council on the 8th day of June next.

"AN ACT TO REGULATE AND AMEND THE LAW RESPECTING

THE SALMON FISHERIES OF SCOTLAND." District of the River Fleet, (Kirkcudbrightshire.)

WE, the Commissioners appointed under the said Act, and empowered thereby "To make General Regulations with respect to the due observance of the Weekly Close Time," do hereby make the following Regulations with respect to the due observance of the Weekly Close Time in said District, namely:-

1. That in each and every Stake Weir, or Stake Net, a clear opening of at least four feet in width shall be made and kept free from obstruction in each and every Pouch, Trap, or Chamber of same.

2. That the Pouches, Traps, or Chambers of each and every Fly Net shall be either raised and tied up to the upper ropes of same, or lowered and tied to the lower ropes, so as effectually to prevent the capture or obstruction of Salmon.

3. That the netting of the leader of each and every Bag Net shall be entirely removed, and taken out of the water.

VACCINATION ACT.

PARISH OF STORNOWAY, ROSS.

NOTICE is Hereby Given, That in terms of the 12th Clause of the Vaccination (Scotland) Act, 1863,—26 and 27 Vict., cap. 108,—and upon application by the Parochial Board of Stornoway, in the County of Ross, the Board of Supervision have framed a Modification of the 9th Clause of the said Act, as hereinafter expressed, to supersede the provisions in that Clause so far as regards the said Parish of Stornoway, and that the said Modification has been approved of by the Lord Advocate, in conformity with the Act:—

"In the 9th Clause of the said Act, wherever the word 'Two' occurs, the word 'Three' to be substituted for it."

Accordingly, the 9th Clause of the Vaccination (Scotland) Act, 1863, will stand as follows, so far as regards the Parish of Stornoway:—

"9. If any Medical Practitioner shall be of opinion that any Child is not in a fit and proper State to be successfully vaccinated, he shall thereupon and immediately deliver to the Father or Mother of such Child, or the Person having the Care, Nurture, or Custody of such Child, a Certificate under his Hand, according to the Form of the Schedule (B) hereto annexed, that the Child is in an unfit State for successful Vaccination, and such Certificate shall

remain in Force for Three Months from its Delivery as aforesaid; and the Father, Mother, or Person aforesaid shall, unless they shall within each succeeding Period of Three Months have obtained from a Medical Practitioner a Renewal of such Certificate, within Three Months next after the Delivery of the said Certificate as aforesaid, and if the said Child be not vaccinated at the Termination of such Period of Three Months, then during each succeeding Period of Three Months, then during each succeeding Period of Three Months until such Child has been successfully vaccinated, cause such Child to be examined by a Medical Practitioner, and if he deem such Child to be then in a fit and proper State for Vaccination, he shall forthwith vaccinate him accordingly, and if the Operation be successful shall deliver to the Father or Mother of such Child, or Person aforesaid, a Certificate under his Hand, according to the Form of the said Schedule (A), that such Child has been successfully vaccinated; but if the Medical Practitioner be of opinion that the Child is still in an unfit State for successful Vaccination, then he shall again deliver to the Father or Mother of such Child, or Person aforesaid, a Certificate under his Hand, according to the Form of the said Schedule (B), that the Child is still in an unfit State for successful Vaccination; and the Medical Practitioner, so long as such Child remains in an unfit State for Vaccination and unvaccinated, shall at the Expiration of every succeeding Period of Three Months deliver, if required, to the Father or Mother of such Child, or Person aforesaid, a fresh Certificate under his Hand, according to the said Form; and the Production of such Certificate shall be a sufficient Defence against any Complaint which shall be brought against the Father or Mother, or Person aforesaid, for Non-compliance with the Provisions of this Act."
