Admiral of the White, &c. to EVAN NEPEAN, Esq.
dated on board his Majesty's ship Royal George, at fea, the 8th instant.

I inclose, for the information of the Lords Commissioners of the Admiralty, a letter which I have received from Captain Towry, of his Majelly's ship Uranie, transmitting the copy of one which he had sent to Captain Keats, of the Boadicea, giving an account of the capture of La Revanche French schooner privateer.

ST VINCENT. I am, Sir, &c. My LORD, Uranie, at fea, July 28. 1800. I have the honour to inclose you a copy of my letter of this date to Captain Keats, and am, my Lord, &c. G. H. Towry. am, my Lord, &c. G.

Sir, Uranie, at fea, July 23. 1800. Cruifing according to your instructions in his Majesty's ship under my command, I beg leave to acquaint you of my having captured this day La Revanche French schooner privateer, mounting 14 fix pounders, with 80 men, belonging to Bayonne, had been out from thence about four months, but last from Vigo (19 days), into which port she had carried three prizes, an English brig called the Marcus, a Portuguese ship,

and a Spanish brig, prize to the Minerve.
