The following Notices have been received by the Clerk of the Council from the Local Authorities appointed under the Orders of the Lords of the Council, relating to the "Cattle Plague," and are published in the London Gazette in conformity with the requirements of the 18th section of their Lordships' Order of the 23d November 1865:—

#### CATTLE PLAGUE.

I, ALEXANDER MAXWELL ADAMS, Provost of the Royal Burgh of Lanark, in virtue of the powers conferred upon me by the Orders of Her Majesty's Most Honourable Privy Council, dated respectively 23d November and 16th December 1865, hereby declare, in terms of the 18th section of the first mentioned Order, that, with a view to prevent the spreading of the cattle plague, it shall be unlawful for any person to bring any cow, heifer, bull, bullock, ox, or calf, from any part of Great Britain to any place within the Royal Burgh of Lanark from the date of this notice to the 1st day of March next, under this condition, that any animal of the description above specified, after being slaughtered, may be admitted into the said Burgh, if accompanied by a certificate from the Inspector of the District from which it has been sent, that such animal was free from the cattle plague immediately previous to being slaughtered, and that it had not, to the best of his knowledge and belief, been in contact with other animals suffering from said disease, for a period of at least

fourteen days prior to the date of his certificate; which certificate must be presented at the office of the Town-Clerk of this Burgh within two days from its date.

Any person contravening this Order is liable, for every breach thereof, to forfeit a sum not exceeding £20.

#### CATTLE PLAGUE.

I, HUGH MACFARLANE, Junior, Provost of the Burgh of Paisley, in virtue of the powers vested in me as local authority, under the Orders issued by Her Majesty's Most Honourable Privy Council, do hereby give notice, that from and after the date hereof, and up to the 1st of March next, it is expedient, and I do hereby declare, that no cow, heifer, bull, bullock, ox, calf, sheep, lamb, goat, or swine, shall be permitted to enter the burgh or town of Paisley from any other part of Great Britain except by railway and for the purpose of being sent to the Paisley slaughter-house, and to no other place within the said burgh.

Further, I, as local authority foresaid, do hereby

Further, I, as local authority foresaid, do hereby give notice that from and after the date hereof, and up to the 1st of March next, it is expedient, and I do hereby declare, that no such animal shall be allowed to pass from one part of the said burgh to another part thereof, except to the said slaughter-house for the purpose of being slaughtered, and that subject to the following conditions and

regulations, viz.:-

First. That on arrival of any such animal at the railway station within the Burgh, notice thereof shall be immediately given to the Superintendent of Police, whose duty shall be to see that such animal is taken direct from the said railway station to the said slaughter-house.

Second. That before removal of any such animal from any part of the burgh, other than from the railway station, three hours' notice of the time fixed for removal shall be given to the Superintendent of Police.

Third. That all such animals on entering the slaughter-house shall be branded, and shall not be removed therefrom until slaughtered.

Fourth. Every cow, heifer, bull, bullock, ox, or calf, shall be inspected by the Government Inspector after being slaughtered, and shall not be allowed to be taken out of the slaughter-house for consumption until such examination has taken place.

Fifth. That no carcase of any such animal shall be brought into the slaughter-house without a certificate by the Government Inspector being previously delivered to the keeper thereof that the same is free from disease.

Corton Light Vessel.

THE Corporation of the Trinity House, London, has given notice, that the Corton Light vessel has been moved  $1_{\overline{10}}^{6}$  miles N.N.E.  $\frac{1}{2}$  E. of her former position, and *Corton* alone is painted on her sides, instead of Corton Fairway, as heretofore.

The vessel now lies in 15 fathoms at low-water springs, with the tidal flagstaff on Gorleston south pier head, in line with the chancel end of Gorlespier head, in line with the chancel end of Gorleston Church, bearing N.N.W. ½ W.; Lowestoft low lighthouse—now building on the Ness—its length southward of Kirkley north mill, W. by S. ¾ S.; St Nicholas light vessel N. by W., distant 4¾ miles; South Scroby buoy N. ½ W., distant 2¾ miles; N.E. Corton buoy N.N.W. ¼ W., 1¾ miles; S.E. Corton buoy W.N.W., 6 cables; South Corton buoy S.W., 1¾ miles; East Barnard buoy S.W. 4 S., 8¼ miles; and South Cross sand buoy N.F. 1 S., 810 miles; and South Cross sand buoy N.E. by N., 4 miles.

INFORMATION has been received from Vice-Admiral Sir Robert Smart, K.C.B., Commanderin-Chief in the Mediterranean, that Mr George

Yeoman, Master of the English barque Vigilia, reports having, on the afternoon of the 19th July 1855, touched on a shoal with 12 feet water on it, in about lat. 36° 3′ 30″ N., long. 22° 33′ East, with Cape Matapan bearing N.  $\frac{1}{2}$  E., and Ovo islet, south

of Cerigo, E. ½ S.

The reported indications of this being a shoal are not conclusive; they would equally point to the vessel having grazed against a submerged body, or having felt the shock of an earthquake, an occurrence not unlikely in this neighbourhood. No soundings were obtained; signs of discoloured water were said to be observed, but indistinct and

The navigator is warned to keep a good look out, and freely use the lead when in this locality.
