By the Lords of Her Majesty's Most Honourable Privy Council.

PRESENT.

Mr Secretary Walpole. Mr Corry. Mr Cave.

WHEREAS by an Order bearing date the 31st day of August last, duly issued under the authority of the Act passed in the session of the eleventh and twelfth years of Her present Majesty's reign, chapter one hundred and seven, the Lords of Her Majesty's Privy Council did amongst other things order that from and after the 3d day of September 1866 it should not be lawful for any person to remove cattle or other animals from any port or place in England and Wales to any port or place in Scotland:

And whereas, by an Order bearing date the

10th day of September 1866, the said Lords did order that, notwithstanding anything in the above mentioned Order provided, it should be lawful for any person to move rams from the county of Northumberland into Scotland, provided that a heence for moving such rams were obtained in the form and oth rwise in accordance with the provisions contained in the Order made by the Lords of Her Majesty's Privy Council bearing date the 8th day of August, which apply to the store stock licence, and provided also that the Local Authority of the county in Scotland into which such rams are proposed to be moved, should give authority or issue any regulations for the movement of rams from the county of Northumberland into it; and by a further Order bearing date the 2d day of October 1866, they did extend the provisions of the last-mentioned Order of the 10th day of September to sheep and lambs proposed to be moved from the county of Northumberland into Scotland:

And whereas it is expedient that the provisions of the said Orders of the 10th day of September and 2d day of October 1866, should be further extended ·

Now, therefore, the Lords of Her Majesty's Privy Council do hereby order, that from and after the first day of November one thousand Majesty the Emperor of Austria.

eight hundred and sixty-six, notwithstanding anything in the first-mentioned Order of the 31st day of August 1866 provided, it shall be lawful for any person to move cattle and other animals from the counties of Northumberland and Cumberland into Scotland; provided that a licence for moving such animals be obtained in the form and otherwise in accordance with the provisions contained in the Order made by the Lords of Her Majesty's Privy Council bearing date the 8th day of August, which apply to the store stock licence; and provided also, that the Local Authority of the county in Scotland into which such animals are proposed to be moved shall give authority or issue any regulation for the movement of animals from the county of Northumberland or Cumberland into it.

And the said Lords do further order, that every such regulation so to be made by the said Local Authority shall be published in the same manner as other regulations of the said Local Authority have been hitherto published under the direction of the Lords of the Council.
