THE Secretary of State for Foreign Affairs has received from Her Majesty's Minister in Brazil a Despatch, of which the following is an extract:\*

"Steamers have for some years plied between Pará, near the mouth of the Amazon, and Yurimagnas, on the Xuallaga, in Peru; they carry passengers and cargo. Brazilian steamers go once a fortnight from Pará to Manaos, and once a month from Manaos to Tabatinga. From this point, which is on the frontier between Brazil and Peru, Peruvian steamers, in connection with the Brazilian line, start once a month for Yurimagnas.

"According to official r during the year from July 1, 1864 to June 30, 1865, produce arrived from the province of the Upper Amazon at the port of Pará to the value of £85,778, and goods were despatched from that port to the same province to the value of £40,841, which were forwarded to Peru. The import from Great Britain to Paraá has been more than double that of any other nation, whilst the export to Great Britain, though proportionally smaller, is still larger than

to any other nation.

"The general entrance to the Amazon and its confluents is now by the Pará channel, and at Pará is the custom-house, at which vessels from beyond seas enter when bound to that part of Brazil. When, however, the navigation of the Amazon shall be opened in September next to the flags of all nations, the north-western entrance would be much more direct, accessible, easy and short, than the other passage. It is therefore much to be desired that a Port of entry should be established somewhere near that mouth of the Amazon, and I have reason to believe that the Brazilian Government meditate doing so at Macapá. "The Trombetas, which, with the Rio Branco, unites the Province of Pará with the Guianas.

"The Rio Negro, which flows from Venezuela, and the Iça from New Granada.

"The Morona, Pastaza, and Napo, which afford a communication between the northern parts of Peru and New Granada and the Equator.

"And on the right bank the following rivers:—
"The Tocantins, Xingu, and Tapajoz, in Brazilian territory.

"The Madeira, in Brazilian and Bolivian terri-

"The Purus, Yurna, and Yavary, in Bolivian and Peruvian territory.

"And the Ucayali and Huallaga, in Peruvian

"With regard to the navigation of the Trombetas, I have been unable to obtain any information.

"At about eight miles from the mouth of the Rio Negro is situated the town of Manaos, the capital of the province of Upper Amazon; thence to Santa Isabel, about 377 miles up the Rio Negro, the navigation is easy for steamers of light draught, and it is only in the dry season that there are one or two passes where the river is not more than three feet deep. There was at one time a line of steamers belonging to the Brazilian Company from Manaos to Santa Isabel, which was given up as not being sufficiently remunerative. Above Santa Isabel there are rapids, though of neither a dangerous nor difficult nature; and it is said that a very little engineering would render the river in that part also navigable for light draught steamers. As it is, large barges, loaded with produce, come done from San Carlos, in Venezuela, to Santa Isabel.

"At about 170 miles above Manaos, the Rio Branco flows into the Rio Negro. It is said that the former offers, during the greater part of the year, an easy navigation for light-draught steamers for 200 miles, as far as the Fort of St Joaquim, not far from the frontier of British Guiana.

"It is asserted that a much more rapid and easy communication may be established between Europe and Guiana and the interior of Venezuela by means of the Amazon, Rio Negro, and Rio Branco, than by the Orinoco, and that steamers could go from Pará to the frontier of Venezuela on the Rio Negro in twenty-seven days, and come down again in fifteen days.

"Of the Iça, Morona, and Pastaza little is known.

"The Napo is said to be an important river, and is said to possess an easy navigation by steam for 340 miles to a place called Puerto del Napo, whence Quito may be reached in six or seven days. The River Napo runs through the Province of Canclos, which is in dispute between Peru and the Equator, and where lands were ceded by the latter in payment of a debt to an English Company.

"The River Tocantins is entirely in Brazilian

"The River Tocantins is entirely in Brazilian territory, but was opened by the Decree of last December to Cameta, about thirty-five miles distant from the confluence of that river with the Amazon. The remainder of the navigation is little known.

"The Xingu is also in Brazilian territory, and is little known.

"The Tapajoz is likewise in Brazilian territory along its whole course, and affords a communica-

"The Tapajoz is navigable for steamers for above 170 miles above Santarem, when impassable rapids are met with; above these, boats can go to within a short distance of Diamantino, which is about 100 miles north of Cuyaba, the capital of

Matto Grosso.

"The Madeira is a most important tributary of the Amazon; by the Decree of the 7th of December last this river is to be opened in September next to the flags of all nations as far as Borba, situated on the right bank of the Maideira, at about 120 miles from its mouth. For about 570 miles from its mouth the navigation of this river is clear and easy for vessels drawing 6 feet of water; generally speaking the river is very deep, and the current is not more than a mile and a half an hour. This brings one to St Antonio, where commences a series of impassable rapids and waterfalls for about 270 miles; to avoid these it would be necessary to construct a road for 170 miles from St Antonio to Guajará. A little above this point the Madeira separates into two, to the south-eastward and south-westward, the former taking the name of Guaporé, and the latter of Mamoré, of these the latter is by far the most important. From Guajará up the Mamoré the navigation is perfectly easy and clear; the current is from a mile to a mile and a half an hour; the water is in most places very deep, but always enough for vessels of twelve feet draught. Vinchuta, on the Mamoré, in Bolivia, is at about 500 miles from Guajará. It is at about 140 miles from Cochabamba and from Santa Cruz de la Sierra, and at 120 miles from Trinidad, the capital of the Bolivian province of Mojos. From Cochabamba to Chupuisaca, the capital of Bolivia, the distance may be 140 miles.

"The principal desideratum then on this route would be the road of 170 miles from St Antonio to Guajara, a work which ought to be undertaken

jointly by Brazil and Bolivia.

"Supposing this road to exist, merchandize could easily be carried from the mouth of the Amazon to Cochabamba, in the heart of Bolivia, in thirty-one days; whereas, if it went from the latitude of Pará round Cape Horn, landed at Africa, the nearest port to Cochabamba on the West Coast, and proceeded thither across the Andes, it would take at least 100 days to get there.

"This road would be further useful to Brazil, because steamers of very little draught could ascend the Guaporé as far as Villa Bella de Matto Grosso, and thus afford a completed internal water communication with the extreme west of the province of Matto Grosso.

"Little is known of the Purus, which is supposed to rise in about 12° south latitude, flowing nearly parallel to the Madeira, forming a small part

of the boundary between Bolivia and Peru, and proceeding through Brazilian territory till it empties itself into the Amazon. It is ascertained, however, that for 850 miles from its mouth, the Purus has from eight to thirteen feet water, and for 500 miles more from six to eight feet.

"No exact information can be obtained with regard to the Yarna and Yavary; but the former is said to be navigable for 1000 miles from its

junction with the Amazon.

"The Ucayali and Huellaga are exclusively Peruvian rivers. They are no doubt of great importance in connection with the navigation of the Amazon, because they flow through very populous districts to the east of the Andes, which could be much more easily supplied with European merchandize by this route than by that of the Pacific, followed up by the difficult and expensive journey across the Andes. But I am unable to furnish any precise details as to the facilities which may be offered by these two rivers for navigation by steam. According to the best authorities it would seem that the Ucayali is navigable for steamers for about 880 miles from its mouth. Above that there are rapids which would interfere with the ascent of the river, but would not at all prevent vessels from coming down it from a much greater distance. The Huallaga, the course of which is nearer to the Andes than that of the Ucayali, is navigable for large vessels only as far as Laguna, about seventeen miles from its mouth, in all seasons, and during the rainy season as far as Yurimagnas, 125 miles higher.

To the Mouths of these two rivers the Amazon always has sufficient water for good-sized vessels, and there can be no doubt that once these are properly explored and opened to navigation all the inhabitants of Peru to the east of the Andes would be supplied by this route. I understand that the Peruvian Government are meditating the establishment of a line of steamers on the Ucayali.

"This population will probably some years hence have all its communication with Europe by way of the Amazon. If we take as an instance the Peruvian town of Magro, situated in 10° south latitude, to the east of the Andes, on the river Pachitea, which falls into the Ucayali, and at about seven days journey from Lima, we find that in going down the rivers Pachitea and Ucayali the distance from Magro to Iquitos on the Amazon can be done in two days, from Iquitos to Pará in five days, and from Pará to England in fourteen days, making in all twenty-one days, and putting the time between Lima and England at twenty-seven days by this route.

"I am unable to inform your Lordship precisely what measures have been taken for the security of vessels navigating the Amazon. There are authorities at many points on the river who are

supported by a small force; indeed the Brazilian and Peruvian Governments feel themselves obliged to maintain a certain force on that river for their protection against their neighbours; but it would evidently be impossible fully to guard the whole course of the enormous distances which sometimes intervene between the different towns on the banks. Vessels navigating the river must, to a certain extent, depend on their own resources for safety. At the same time I understand that the inhabitants of the banks of the Amazon are generally well disposed towards foreigners, and most desirous of trading with them."

The Secretary of State for Foreign Affairs has received, from Her Majesty's Consul at Malaga, a Despatch, of which the following is a copy:—

British Consulate, Malaga, April 30, 1867.

I HAVE the honour to inform your Lordship that, by virtue of a Royal Order issued by the Spanish Government, under date of the 24th instant, the ports of Malaga and Almeria, within this Consular district, have been pronounced qualified for the performance of Quarantines of Observation; consequently, the term of three days' observation imposed on ships coming to Malaga or Almeria, from places treated by the Spanish Sanitary Ordinances as "compromised or suspected," may henceforth be performed at either of the above-named ports of destination, without the necessity of entering the Lazerets of Cadiz or Carthagena for that purpose, as previously required.

(Quarantine, No. 23.)

The Secretary of State for Foreign Affairs has received from the Acting British Consul at Bilbao a Despatch, of which the following is a copy:—

I HAVE the honour to report to your Lordship that, by a Royal Order dated the 24th ultimo, Bilbao is added to the ports in Spain at which the three days' quarantine of observation required of vessels proceeding from suspected ports can be performed.

By this regulation British vessels proceeding to this port from the United Kingdom are relieved from the great expense and inconvenience they have for a long time sustained by being compelled to perform quarantine of observation at Santander.

I HAVE the honour to inform your Lordship that "Finland's Official Gazette" of the 27th April contains the following Decree, issued by the Imperial Senate at Helsingfors, on the 17th instant:—

"In consequence of a petition lately presented to the Imperial Government, His Majesty the Emperor has granted permission to foundry proprietors, as well as to iron merchants in general thoughout the Grand Duchy of Finland, to import pig iron at the same reduced rate of duty as was imposed on that article in the year 1866, that is to say:—1 Finnish mark (or  $9\frac{3}{4}d$ .) per Skeppund— $7\frac{1}{2}$  skeppunds being equal to one British ton."
